DIGEST OF SB 566 (Updated February 23, 2015 6:34 pm - DI 73)

Synopsis: Education. Replaces ISTEP program testing with BEST testing program for school years beginning after June 30, 2016. Establishes certain procedures related to implementing the BEST program, including budget committee review. Provides that the education roundtable may not recommend and the state board of education (state board) may not adopt Common Core Standards or an assessment or test that is produced solely by the United States government or a consortium of states. Specifies that the state board shall ensure that applications for the necessary flexibility waivers under the federal No Child Left Behind Act are filed in a timely fashion and that the applications comply with the educational policies of the state board. Provides for innovation network school programs in school corporations other than the Indianapolis Public Schools. Extends the

school performance grant program through the 2016-2017 school year, and makes changes in the calculation and use of the grant for stipends to teachers. Permits teachers to receive a supplemental amount for completion of certain master's degrees. Requires the department of education (department) to establish a program to permit an individual with a major in science, technology, engineering, or mathematics and a minor in education to obtain a teaching license. Provides that a school corporation must consider certain factors in developing a performance evaluation model. Provides that a school corporation shall report its staff performance evaluation plan (plan) to the department (which may review the plan for efficacy) and the Indiana education employment relations board (which may review the plan for legality). Requires school employers to bring collective bargaining agreements into conformity with law, provides for oversight by the education employment relations board to bring these agreements into compliance, permits certificated employees to be paid based on adopted salary ranges rather than salary schedules, and makes other changes in collective bargaining. Provides that a school with a low student population (when compared to the average size of the student population at all schools in Indiana) may appeal a performance designation to the state board based on the insufficient size of the test group needed to determine an accurate result. Permits the governing body of a school corporation to specify that less than 50% of a stipend to a teacher from a performance grant becomes, in school years after the school year in which the stipend is awarded, a permanent part of the teacher's annual salary. Indicates that a school corporation may provide supplemental compensation to a teacher who earns a master's degree in a content area directly related to a dual placement course taught by the teacher.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-18-2-2.3 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE
3 UPON PASSAGE]: **Sec. 2.3. "BEST program" refers to the**
4 **benchmarking excellence student testing program developed and**
5 **administered under IC 20-32-5.1.**

6 SECTION 2. IC 20-18-2-6, AS ADDED BY P.L.1-2005, SECTION
7 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE UPON
8 PASSAGE]: Sec. 6. "Graduation examination" means:

9 (1) **for school years ending before July 1, 2016**, the test
10 designated by the board under the ISTEP program; **and**

11 (2) **for school years beginning after June 30, 2016**, the test
12 **designed by the board under the BEST program.**

13 SECTION 3. IC 20-18-2-10, AS ADDED BY P.L.1-2005,

2 SECTION 4. IC 20-18-2-22, AS AMENDED BY P.L.43-2014,
3 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
4 UPON PASSAGE]: Sec. 22. (a) "Teacher" means a professional person
5 whose position in a school corporation requires certain educational
6 preparation and licensing and whose primary responsibility is the
7 instruction of students.

25 duties prescribed by law, the state board shall adopt rules under
26 IC 4-22-2 concerning, but not limited to, the following matters:

28 consultants necessary for the department. The state board shall fix
29 the compensation of employees of the department, subject to the
30 approval of the budget committee and the governor under
31 IC 4-12-2.

35 full range of information sources, associated equipment, and

13 is a prerequisite to the accreditation of a school. Local public

 18 guidelines adopted by the state board is not a prerequisite of
 19 accreditation.

 27 subdivision constitutes the system of regulatory standards that
 28 apply to nonpublic schools that seek to qualify for the system of
 29 recognition.

30 (8) The establishment and enforcement of standards and
 31 guidelines concerning the safety of students participating in
 32 cheerleading activities.

33 (9) Subject to IC 20-28-2, the preparation and licensing of
 34 teachers.

35 (b) Before final adoption of any rule, the state board shall make a
 36 finding on the estimated fiscal impact that the rule will have on school
 37 corporations.

38 SECTION 6. IC 20-19-2-14, AS AMENDED BY P.L.286-2013,
 39 SECTION 12, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 40 UPON PASSAGE]: Sec. 14. The state board shall do the following:

41 (1) Establish the educational goals of the state, developing
 42 standards and objectives for local school corporations.

 21 obtain the requisite knowledge and skill to transition without
 22 remediation to postsecondary education or training, and
 23 ultimately into a sustainable career; and
 24 (2) "cut scores" means the scores that define a student's
 25 performance on an assessment, including passing, failing, or
 26 falling into a performance category.

 9 under subsection (c); the state board shall submit the proposed
 10 assessment program to the budget committee for review.

11 (e) (c) This subsection does not apply to an agreement with the

 18 4R's technology program described in section 6(a)(1) of this chapter.
 19 (b) In addition to any other funds available under this chapter, if
 20 state funds are transferred under IC 20-32-5-19 (**repealed July 1,**
 21 **2016**) to the 4R's technology program:

 7 school's initiative, is able to provide a part of the costs
 8 attributable to purchasing the necessary technology equipment.
 9 (3) The school corporation must include in the application the

 37 for the operations of an innovation network school within a school
 38 corporation.**

39 **Chapter 3. Establishment of Innovation Network Schools**

40 **Sec. 1. An innovation network school is subject to all federal and
 41 state laws and constitutional provisions that prohibit
 42 discrimination on the basis of the following:**

 3 **(3) Color.**

 8 **Sec. 2. (a) The board may enter into an agreement with a school**

 10 **(1) to establish an innovation network school, as determined**
 11 **by the board; or**
 12 **(2) to reconstitute an eligible school as an innovation network**
 13 **school.**
 14 **The school management team for an eligible school that is**
 15 **reconstituted as an innovation network school may consist of or**
 16 **include the principal and other individuals who were employed at**
 17 **the eligible school before the agreement is entered.**
 18 **(b) The terms of the agreement must specify the following:**
 19 **(1) A statement that the innovation network school is**
 20 **considered to be part of the school corporation and not**
 21 **considered a separate local educational agency.**
 22 **(2) A statement that the school management team authorizes**

 33 **(5) Grounds for termination of the agreement, including the**
 34 **right of termination if the school management team fails to:**

 37 **(B) meet generally accepted fiscal management and**
 38 **government accounting principles;**
 39 **(C) comply with applicable laws; or**

40 **(2) IC 20-30 (curriculum).**

41 **(3) IC 20-24-6 (employment of teachers and other personnel**
 42 **in charter schools).**



1 **(4) IC 20-28-11.5 (staff performance evaluations).**

2 **Sec. 6. (a) Any student who lives in the attendance area served**
 3 **by a school that is operated as an innovation network school under**
 4 **this chapter may attend the innovation network school. The**
 5 **innovation network school may not refuse enrollment to a student**
 6 **who lives in the attendance area.**

7 **(b) This subsection applies if the number of applications for a**
 8 **program, class, grade level, or building exceeds the capacity of the**
 9 **program, class, grade level, or building. If an innovation network**
 10 **school receives a greater number of applications than there are**
 11 **spaces for students, each timely applicant must be given an equal**
 12 **chance of admission.**

13 **Sec. 7. The school management team and the board shall hold**
 14 **a joint public meeting at least two (2) times each year to discuss**
 15 **issues and progress concerning the innovation network school.**

16 **Sec. 8. The board shall develop a program to provide support to**

19 **Chapter 4. Participation of Charter School as an Innovation**
 20 **Network School**

21 **Sec. 1. Except as expressly provided in this article, a**
 22 **participating innovation network charter school remains subject**
 23 **to all state laws that govern charter schools.**

24 **Sec. 2. (a) Notwithstanding IC 20-26-7-1, the board may enter**
 25 **into an agreement with an organizer to establish a participating**
 26 **innovation network charter school within a vacant, underutilized,**
 27 **or underenrolled school building, as determined by the board.**

28 **(b) The terms of the agreement entered into between the board**
 29 **and an organizer must specify the following:**

30 **(1) A statement that the organizer authorizes the department**
 31 **to include the charter school's performance assessment results**
 32 **under IC 20-31-8 when calculating the school corporation's**
 33 **performance assessment under rules adopted by the state**
 34 **board.**

35 **(2) The amount of state funding, including tuition support,**
 36 **and money levied as property taxes that will be distributed by**
 37 **the school corporation to the organizer.**

38 **(3) The performance goals and accountability metrics agreed**
 39 **upon for the charter school in the charter agreement between**
 40 **the organizer and the authorizer.**

41 **(c) If an organizer and the board enter into an agreement under**
 42 **subsection (a), the organizer and the board shall notify the**



1 department that the agreement has been made under this section
2 within thirty (30) days after the agreement is entered into.

3 (d) Upon receipt of the notification under subsection (c), the
4 department shall, for school years starting after the date of the
5 agreement:

6 (1) include the participating innovation network charter
7 school's performance assessment results under IC 20-31-8
8 when calculating the school corporation's performance
9 assessment under rules adopted by the state board; and

10 (2) treat the participating innovation network charter school
11 in the same manner as a school operated by the school
12 corporation when calculating the total amount of state
13 funding to be distributed to the school corporation.

14 Sec. 3. (a) For as long as the charter school remains a
15 participating innovation network charter school, the school
16 corporation may:

17 (1) provide transportation for students attending the
18 participating innovation network charter school; and

19 (2) maintain and repair the buildings and grounds used by the
20 participating innovation network charter school consistent
21 with the maintenance and repair to the school corporation's
22 other buildings and grounds.

23 (b) If an organizer contracts with a school corporation for goods
24 or services, the school corporation may not charge the organizer
25 more for the goods or services than the school corporation pays for
26 the goods or services.

27 (c) For as long as the charter school remains a participating
28 innovation network charter school, the school corporation may
29 distribute money levied as property taxes to the charter school.
30 Property taxes distributed to a charter school must be used only
31 for a purpose for which the property taxes could have been used by
32 the school corporation. Property taxes distributed under this
33 subsection may supplement services and property provided under
34 subsection (a) or (b). A school corporation may modify an
35 agreement described in section 2 of this chapter to implement this
36 subsection.

37 Sec. 4. An employee of a school corporation who provides
38 services to a participating innovation network charter school under
39 this article remains an employee of the school corporation.

40 SECTION 22. IC 20-26-5-4, AS AMENDED BY P.L.2-2014,
41 SECTION 83, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
42 UPON PASSAGE]: Sec. 4. (a) In carrying out the school purposes of



1 a school corporation, the governing body acting on the school
2 corporation's behalf has the following specific powers:

3 (1) In the name of the school corporation, to sue and be sued and
4 to enter into contracts in matters permitted by applicable law.
5 However, a governing body may not use funds received from the

32 additions to buildings, rooms, gymnasiums, auditoriums,
33 playgrounds, playing and athletic fields, facilities for physical
34 training, buildings for administrative, office, warehouse, repair
35 activities, or housing school owned buses, landscaping, walks,
36 drives, parking areas, roadways, easements and facilities for
37 power, sewer, water, roadway, access, storm and surface
38 water, drinking water, gas, electricity, other utilities and
39 similar purposes, by purchase, either outright for cash (or
40 under conditional sales or purchase money contracts providing
41 for a retention of a security interest by the seller until payment
42 is made or by notes where the contract, security retention, or



- 1 note is permitted by applicable law), by exchange, by gift, by
 2 devise, by eminent domain, by lease with or without option to
 3 purchase, or by lease under IC 20-47-2, IC 20-47-3, or
 4 IC 20-47-5.
- 5 (B) Repair, remodel, remove, or demolish, or to contract for
 6 the repair, remodeling, removal, or demolition of the real
 7 estate, real estate improvements, or interest in the real estate
 8 or real estate improvements, as the governing body considers
 9 necessary for school purposes.
- 10 (C) Provide for conservation measures through utility
 11 efficiency programs or under a guaranteed savings contract as
 12 described in IC 36-1-12.5.
- 13 (5) To acquire personal property or an interest in personal
 14 property as the governing body considers necessary for school
 15 purposes, including buses, motor vehicles, equipment, apparatus,
 16 appliances, books, furniture, and supplies, either by cash purchase
 17 or under conditional sales or purchase money contracts providing
 18 for a security interest by the seller until payment is made or by
 19 notes where the contract, security, retention, or note is permitted
 20 by applicable law, by gift, by devise, by loan, or by lease with or
 21 without option to purchase and to repair, remodel, remove,
 22 relocate, and demolish the personal property. All purchases and
 23 contracts specified under the powers authorized under subdivision
 24 (4) and this subdivision are subject solely to applicable law
 25 relating to purchases and contracting by municipal corporations

30 (B) Fix and pay the salaries and compensation of persons and
 31 services described in this subdivision that are consistent with
 32 IC 20-28-9-1.5.

33 (C) Classify persons or services described in this subdivision
 34 and to adopt ~~schedules of salaries or a~~ compensation **plan**
 35 **with a salary range** that ~~are is~~ consistent with IC 20-28-9-1.5.

36 (D) Determine the number of the persons or the amount of the
 37 services employed or contracted for as provided in this
 38 subdivision.

39 (E) Determine the nature and extent of the duties of the
 40 persons described in this subdivision.

41 The compensation, terms of employment, and discharge of
 42 teachers are, however, subject to and governed by the laws



1 relating to employment, contracting, compensation, and discharge
2 of teachers. The compensation, terms of employment, and
3 discharge of bus drivers are subject to and governed by laws
4 relating to employment, contracting, compensation, and discharge
5 of bus drivers. The forms and procedures relating to the use of
6 computer and data processing equipment in handling the financial
7 affairs of the school corporation must be submitted to the state
8 board of accounts for approval so that the services are used by the
9 school corporation when the governing body determines that it is
10 in the best interest of the school corporation while at the same
11 time providing reasonable accountability for the funds expended.
12 (9) Notwithstanding the appropriation limitation in subdivision
13 (3), when the governing body by resolution considers a trip by an
14 employee of the school corporation or by a member of the
15 governing body to be in the interest of the school corporation,

31 attending the schools of the school corporation, including the

34 lunch program, and the purchase of material and supplies for the
35 lunch program, charging students for the operational costs of the
36 lunch program, fixing the price per meal or per food item. To
37 operate the lunch program as an extracurricular activity, subject
38 to the supervision of the governing body. To participate in a
39 surplus commodity or lunch aid program.
40 (12) To purchase curricular materials, to furnish curricular
41 materials without cost or to rent curricular materials to students,
42 to participate in a curricular materials aid program, all in



- 1 accordance with applicable law.
- 2 (13) To accept students transferred from other school corporations
- 3 and to transfer students to other school corporations in accordance
- 4 with applicable law.
- 5 (14) To make budgets, to appropriate funds, and to disburse the
- 6 money of the school corporation in accordance with applicable
- 7 law. To borrow money against current tax collections and
- 8 otherwise to borrow money, in accordance with IC 20-48-1.
- 9 (15) To purchase insurance or to establish and maintain a
- 10 program of self-insurance relating to the liability of the school
- 11 corporation or the school corporation's employees in connection
- 12 with motor vehicles or property and for additional coverage to the
- 13 extent permitted and in accordance with IC 34-13-3-20. To
- 14 purchase additional insurance or to establish and maintain a
- 15 program of self-insurance protecting the school corporation and
- 16 members of the governing body, employees, contractors, or agents
- 17 of the school corporation from liability, risk, accident, or loss
- 18 related to school property, school contract, school or school
- 19 related activity, including the purchase of insurance or the
- 20 establishment and maintenance of a self-insurance program
- 21 protecting persons described in this subdivision against false
- 22 imprisonment, false arrest, libel, or slander for acts committed in
- 23 the course of the persons' employment, protecting the school
- 24 corporation for fire and extended coverage and other casualty
- 25 risks to the extent of replacement cost, loss of use, and other
- 26 insurable risks relating to property owned, leased, or held by the
- 27 school corporation. In accordance with IC 20-26-17, to:

- 41 performance of the member's or employee's duties for or
