## SENATE BILL No. 625

---

DIGEST OF SB 625 (Updated February 6, 2019 1:04 pm - DI 133)

**Citations Affected:** IC 12-15.

**Synopsis:** Medicaid nursing facility services. Extends the prohibition on the office of Medicaid policy and planning from including certain Medicaid recipients who receive nursing facility services in a Medicaid risk based managed care program or a capitated managed care program through December 31, 2021. Includes Medicaid recipients who participate in certain waivers or reside in an intermediate care facility for individuals with intellectual disabilities setting in the prohibition of being placed into a risk based managed care program or capitated managed care program.

**Effective:** July 1, 2019.

## SENATE BILL No. 625

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 12-15-5-17, AS ADDED BY P.L.224-2017,  
2 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2019]: Sec. 17. (a) This section does not apply to a Medicaid  
4 recipient participating in the Program of All-Inclusive Care for the  
5 Elderly (PACE) program described in IC 12-15-43.  
6 (b) The office may not include a Medicaid recipient who is eligible  
7 to:  
8 (1) participate in the Medicare program (42 U.S.C. 1395 et seq.)  
9 and  
10 (2) receive nursing facility services;  
11 **(2) participate in the family support waiver program**  
12 **administered by the division of disability and rehabilitative**  
13 **services;**  
14 **(3) participate in the community integration and habilitation**  
15 **waiver program administered by the division of disability and**  
16 **rehabilitative services; or**  
17 **(4) reside in an intermediate care facility for individuals with**

- 1           **intellectual disabilities (ICF/ID) setting;**
- 2           in a risk based managed care program or capitated managed care
- 3           program.
- 4           (c) This section expires December 31, ~~2019~~: **2021**.
