6 *Whereas, Judge Richard Maughmer was born on December*
7 *2, 1953, in Cass County, Indiana, to Ned and Janice*
8 *Maughmer;*

9 *Whereas, On September 16, 2019, Judge Maughmer passed*
10 *away at the age of 65;*

11 *Whereas, Judge Maughmer graduated from Lewis Cass*
12 *High School in 1972, and shortly thereafter joined the United*
13 *States Air Force;*

14 *Whereas, Judge Maughmer continued to serve in the United*
15 *States Air Force for 37 years in both active duty and in reserve*
16 *capacity, and he retired with the rank of colonel in 2009;*

17 *Whereas, Alongside his military service, Judge Maughmer*
18 *began working in the Cass County Prosecutor's Office in 1983,*
19 *and in 1986, Governor Robert Orr appointed him as Cass*
20 *County Prosecutor;*

21 *Whereas, Judge Maughmer joined the bench in 2001, where*
22 *he went on to serve the people of Cass County for almost two*
23 *decades;*

1 *Whereas, Judge Maughmer was active in developing the*
2 *legal community and advancing the profession through his*
3 *service as the Chair of the Judicial Administration Committee,*
4 *as member on the Board of Directors of the Judicial*
5 *Conference of Indiana, and as a member of the Indiana Judges*
6 *Association and the Indiana Judges Association Civil*
7 *Instructions Committee; and*

8 *Whereas, It is appropriate that the portion of State Road*
9 *218 from County Road 500 E in Cass County to US 31 in*
10 *Miami County commemorate Judge Richard Maughmer and his*
11 *many contributions to the State of Indiana and the United*
12 *States of America: Therefore,*

13 *Be it resolved by the Senate of the General Assembly*
14 *of the State of Indiana, the House of Representatives*
15 *concurring:*

16 SECTION 1. That the Indiana General Assembly urges the
17 Indiana Department of Transportation to rename the section of
18 State Road 218 from County Road 500 E in Cass County to US
19 31 in Miami County as the "The Honorable Richard A.
20 Maughmer Highway".

21 SECTION 2. The Secretary of the Senate is directed to
22 transmit a copy of this Resolution to the Commissioner of the
23 Indiana Department of Transportation.
