6 *Whereas, The Corning Irish Heritage Center exists to*
7 *preserve the cultural legacy of nineteenth-century Irish*
8 *immigrants in southern Indiana through family activities,*
9 *educational seminars, conferences, pictorial and written*
10 *history, and genealogical material;*

11 *Whereas, The center maintains its mission by holding*
12 *events such as an Apple Festival, maple syrup making, a St.*
13 *Patrick's Day celebration, and its Summer Picnic to give*
14 *Corning and St. Patrick community members a chance to*
15 *reconnect and learn about Irish immigrant history; and*

16 *Whereas, It is fitting that the Indiana Department of*
17 *Transportation acknowledges the Corning Irish Heritage*
18 *Center by placing signs to indicate the center's location at the*
19 *areas designated on Highway 257, Highway 45/231 and*
20 *Highway 50: Therefore,*
