1           A CONCURRENT RESOLUTION honoring the Marian High  
2 School boys soccer team on their second straight Indiana High School  
3 Athletic Association ("IHSAA") Class 1-A state championship title.

4           *Whereas, On October 29, 2016, the Marian High School*  
5 *boys soccer team won 4-0 against Providence High School in*  
6 *the IHSAA Class 1-A boys soccer championship game at*  
7 *Carroll Stadium in Indianapolis;*

8           *Whereas, This was the second straight season in which the*  
9 *Marian Knights claimed the IHSAA Class 1-A boys soccer*  
10 *championship;*

11           *Whereas, "Win...Retool...Repeat" was the formula that the*  
12 *Marian Knights used this season to claim their second straight*  
13 *state championship;*

14           *Whereas, Junior Ontiveros scored the first goal for the*  
15 *Marian Knights during the first half of the game, Jordan*  
16 *Morris scored the second and third goals, and Johnathan*  
17 *Tavarez scored the fourth goal during the second half of the*  
18 *game;*

19           *Whereas, The members of the Marian boys soccer team are*  
20 *student-athletes who managed to balance countless hours of*  
21 *soccer practice on top of a full academic course load, and the*  
22 *Indiana General Assembly recognizes these young men for their*

2 *Whereas, It is fitting that the Indiana General Assembly*  
3 *gives special recognition to the hard work of these student-*  
4 *athletes, Head Coach Ben Householter, and the support staff of*  
5 *the Marian High School boys soccer team: Therefore,*

6 *Be it resolved by the Senate of the General Assembly*  
7 *of the State of Indiana, the House of Representatives concurring:*

8 SECTION 1. That the Indiana General Assembly honors the  
9 Marian High School boys soccer team on their second straight  
10 Class 1-A state championship.
