5 *Whereas, Deputy Morgan was a Madison County Sheriff's*
6 *deputy for 33 years after having served in the U.S. Army;*

7 *Whereas, Deputy Morgan spent many of his years on the*
8 *midnight shift patrolling the northwest quadrant of Madison*
9 *County on State Road 37;*

10 *Whereas, it is estimated that Deputy Morgan issued over*
11 *10,000 citations on this stretch of highway throughout his*
12 *career;*

13 *Whereas, Deputy Morgan made a difference in countless*
14 *lives because of his diligent traffic enforcement;*

15 *Whereas, throughout his time with the Madison County*
16 *Sheriff's Department, Deputy Morgan held positions of patrol*
17 *deputy, SWAT team member, and firearms instructor;*

18 *Whereas, he was an avid supporter of the Madison County*
19 *4-H, helping his children and later others raise pigs for the*
20 *annual fair;*

21 *Whereas, Deputy Morgan was blessed to have an amazing*
22 *family, which included his son Scott and three daughters Kathy,*

1 *Shelby, and Cheyenne, as well as his parents Richard and Sue*
2 *Morgan;*

3 *Whereas, Deputy Morgan passed away on September 10,*
4 *2017; and*

5 *Whereas, it is fitting that in honoring Deputy Morgan's*
6 *service, the portion of State Road 37 patrolled by Deputy*
7 *Morgan should be designated as the Deputy David Morgan*
8 *Memorial Highway: Therefore,*

9 *Be it resolved by the Senate of the General Assembly*
10 *of the State of Indiana, the House of Representatives*
11 *concurring:*

12 SECTION 1. That the Indiana General Assembly urges
13 INDOT to honor Deputy David Morgan for his service to the
14 Madison County Sheriff's office, by renaming the northwest
15 portion of State Road 37 passing through Madison County as
16 the Deputy David Morgan Memorial Highway.

17 SECTION 2. The Secretary of the Senate is hereby directed
18 to transmit a copy of this Resolution to Sue Morgan, Kathy
19 Morgan, Scott Morgan, Shelby Morgan, Cheyenne Morgan,
20 Bob Alderman, the Commissioner of INDOT, and Detective
21 Brian Holtzleiter.
