4 *Whereas, The Indiana State Bar Association Leadership*
5 *Development Academy (LDA) empowers and develops lawyers*
6 *to be informed, committed, and involved in order to serve as*
7 *role models in matters of ethics and professionalism in local*
8 *and state bar associations, Indiana communities, and*
9 *organizations;*

10 *Whereas, The LDA Class of 2023, the eleventh annual class*
11 *of the program, consists of 25 Indiana lawyers who have been*
12 *admitted to practice law for 15 years or less;*

13 *Whereas, The LDA incorporates professional facilitators*
14 *and prominent leaders from various disciplines to inform*
15 *participants about leadership principles and techniques, the*
16 *importance of effective leaders in organizations and*
17 *governments for maximum efficiency and effectiveness, and the*
18 *challenges and rewards of leadership in action;*

19 *Whereas, The LDA class members are selected from around*
20 *the state and are exposed to topics such as public service,*
21 *economic development, government, the military, leadership,*
22 *diversity and inclusion, and other related leadership topics;*

23 *Whereas, As LDA class members travel around the state,*
24 *they actively engage in panel discussions, group activities, and*
25 *demonstrations with faculty who include Indiana Supreme*



1 *Court Justices, Court of Appeals and trial court judges,*
2 *members of the executive and legislative branches of Indiana*
3 *government, and prominent business and military leaders;*

4 *Whereas, One of the principal themes of the LDA is*
5 *"Leadership begins with the attitude of a servant leader - to*
6 *serve first, and out of service we are given the honor to lead";*

8 *Whereas, In February 2023, the LDA session days focus on*
9 *local and state government by providing the class with an*
10 *opportunity to get acquainted with members of the Indiana*
11 *Supreme Court and Court of Appeals, to tour the Indiana*
12 *Statehouse, the Birch Bayh Federal Building, and the United*
13 *States Courthouse, to discuss issues with Indiana legislators,*
14 *and to hear an oral argument: Therefore,*

15 *Be it resolved by the Senate of the General Assembly*
16 *of the State of Indiana, the House of Representatives*
17 *concurring:*

18 SECTION 1. That the Indiana General Assembly
19 recognizes the 2023 class of the Indiana State Bar Association's
20 Leadership Development Academy and the importance of the
21 education provided by the program.

22 SECTION 2. The Secretary of the Senate is hereby directed
23 to transmit copies of this Resolution to the Indiana Supreme
24 Court, Indiana State Bar Association Leadership Development
25 Academy, and each member of the 2023 Leadership
26 Development Academy class.
