3 Association ("IHSAA") class 2-A state championship title.

4 *Whereas, On October 29, 2016, the Penn High School girls*
5 *soccer team won the Indiana High School Athletic Association*
6 *("IHSAA") class 2-A state championship game, defeating the*
7 *Brebeuf Jesuit Braves 2-0 at Carroll Stadium in Indianapolis;*

8 *Whereas, Maya Lacognato and Kristina Lynch each scored*
9 *goals during the second half of the game, and Sommer Domal*
10 *proved steadfast in the goal as the Penn High School Kingsmen*
11 *came away with their win over Brebeuf to claim the state*
12 *championship;*

13 *Whereas, After three previous visits to the state*
14 *championship game, including last year's 2-1 loss to Brebeuf,*
15 *Penn High School took home the championship trophy this*
16 *year;*

17 *Whereas, According to head coach Jeff Hart, the Kingsmen*
18 *have had a tremendous program, with great players and great*
19 *coaches;*

20 *Whereas, The Kingsmen finished their season with an*
21 *impressive record of 22-0-1;*

22 *Whereas, The assist and goal from Kristina Lynch, her 26th*



1 *and 38th of the season, respectively, gave her 102 points this*
2 *season, which was the best in the state;*

3 *Whereas, The Penn High School girls soccer team will miss*
4 *senior goalkeeper Sommer Domal next year, who recorded four*
5 *saves in the state championship game, as well as senior*
6 *midfielder Alexis Marks, who was named the Mental Attitude*
7 *Award winner;*

8 *Whereas, The members of the Penn High School girls*
9 *soccer team are student-athletes who balanced countless hours*
10 *of soccer practices and games on top of a full academic course*
11 *load; and*

12 *Whereas, It is fitting that the Indiana General Assembly*
13 *congratulates the Penn High School girls soccer team on its*
14 *successful season and state championship title: Therefore,*

15 *Be it resolved by the Senate of the General Assembly*
16 *of the State of Indiana, the House of Representatives concurring:*

18 Penn High School girls soccer team on its 2016 IHSAA class 2-
