10 *persistence built one of the most respected construction*
11 *companies in the region;*

12 *Whereas, Powers and Sons began as a home building*
13 *firm and has now grown to become a leading general*
14 *contractor, construction manager, and design builder*
15 *throughout Indiana and Illinois;*

16 *Whereas, Powers and Sons' staff has grown to a staff of*
17 *more than 70 professionals, including a support staff of*
18 *architects, registered engineers, and other specialists to help*
19 *the company meet its client's needs;*

20 *Whereas, today Powers and Sons is a highly respected*
21 *commercial, industrial, and institutional construction*

 11 *state of Indiana;*
