A CONCURRENT RESOLUTION urging the Indiana Department of Transportation to rename US 421 in Jefferson County from the junction of US 421 and SR 62 to the northern border of Jefferson County, Indiana as the "Maj. Samuel Woodfill Memorial Highway" in honor of the 100<sup>th</sup> anniversary of Indiana's only World War I Medal of Honor recipient and Jefferson County native.

# SENATE CONCURRENT RESOLUTION No. 26

1	A CONCURRENT RESOLUTION urging the Indiana
2	Department of Transportation to rename US 421 in Jefferson
3	County from the junction of US 421 and SR 62 to the northern
4	border of Jefferson County, Indiana as the "Maj. Samuel
5	Woodfill Memorial Highway" in honor of the 100 <sup>th</sup> anniversary
6	of Indiana's only World War I Medal of Honor recipient and
7	Jefferson County native.
8	Whereas, Major Samuel Woodfill, a native of Jefferson
9	County, was the only Hoosier to be awarded the Medal of
10	Honor during World War I;
11	Whereas, Major Woodfill was born on January 6, 1883 in
12	Bryantsburg, the son of Christina Woodfill and John S.G.
13	Woodfill, a veteran of the Mexican-American War and the Civil
14	War;
15	Whereas, Major Woodfill attended school at Belleview,
16	became an excellent marksman at a young age by hunting in
17	areas near his family's farm, and enlisted in the United States
18	Army 11 <sup>th</sup> Infantry on March 8, 1901 at the age of eighteen to
19	continue his father's military legacy;
20	Whereas, Major Woodfill served his country for more than
21	forty years as a veteran of the Philippine-American War, World
22	War I, and World War II;
23	Whereas, On October 12, 1918, the First Lieutenant
24	Woodfill and his regiment encountered heavy machine gun fire
25	from the Germans at Cunel, France where Major Woodfill went

2	killing or capturing the German soldiers each time;
3	Whereas, As a result of his great bravery, Major Woodfill
4	suffered from the effects of exposure to mustard gas as well as
5	a piece of shrapnel that struck his thigh during the last
6	encounter;
7	Whereas, Major Woodfill was the most decorated American
8	servicemember during World War I, receiving the Medal of
9	Honor, French Croix de Guerre with palm, the Cross of Prince
10	Danilo, Italy's Meriot di Guerra, and was made a Chevalier of
11	the French Legion of Honor;
12	Whereas, Major Woodfill was lauded as the "greatest
13	American Soldier of the World War" by General John
14	Pershing, Commander of the American Expeditionary Forces,
15	during World War I;
16	Whereas, As further recognition of his renown, Major
17	Woodfill was asked to serve as a pallbearer at the burial of the
18	Unknown Soldier during the 1921 dedication ceremonies at
19	Arlington National Cemetery and as pallbearer for General
20	Pershing in 1948;
21	Whereas, Major Woodfill was buried at a small church
22	cemetery in Hebron in Jefferson County in 1951 until moved to
23	Arlington National Cemetery in 1955 and buried approximately
24	fifty feet from General Pershing;
25	Whereas, Many states, including Indiana, have designated
26	and named parts of the state and federal highways as
27	memorials to those who served their nation in time of war;
28	Whereas, The people of Jefferson County wish to recognize
29	the designation of US 421 in Jefferson County from the junction
30	of US 421 and SR 62, to the northern border of Jefferson
31	County, Indiana in honor of Samuel Woodfill; and
32	Whereas, It is fitting that proper signage be placed along



1	US 421 to recognize the designation of that part of the highway
2	as the "Maj. Samuel Woodfill Memorial Highway" in honor of
3	Major Woodfill's service and sacrifice: Therefore,

Be it resolved by the Senate of the General Assembly of the State of Indiana, the House of Representatives concurring:

SECTION 1. That the Indiana General Assembly urges the Indiana Department of Transportation to rename US 421 in Jefferson County from the junction of US 421 and SR 62 to the northern border of Jefferson County, Indiana as the "Maj. Samuel Woodfill Memorial Highway" in honor of the 100<sup>th</sup> anniversary of Indiana's only World War I Medal of Honor recipient, Samuel Woodfill.

SECTION 2. The Secretary of the Senate is hereby directed to transmit copies of this Resolution to Robert Woodfill, Maj. Samuel Woodfill's closest living relative, the Commissioner of the Indiana Department of Transportation, and the Jefferson County Veterans Council.



### COMMITTEE REPORT
