1           A CONCURRENT RESOLUTION honoring Officer Shad  
2           Grile on being selected as the 2015 Officer of the Year by the  
3           Indiana Association of Chiefs of Police.

4           *Whereas, Officer Shad Grile is a member of the Anderson*  
5           *Police Department where he has been a police officer for 22*  
6           *years;*

7           *Whereas, Officer Grile responded to a call on July 3, 2015,*  
8           *where he faced an armed and dangerous man;*

9           *Whereas, Officer Grile was placed in a situation where he*  
10          *was forced to return fire on the armed suspect in order to*  
11          *preserve life and end the threat;*

12          *Whereas, During the shooting Howard McCoy was one of*  
13          *the victims who was shot;*

14          *Whereas, Officer Grile went above and beyond the call of*  
15          *duty when he and his family became aware of the financial*  
16          *burden that one of the shooting victims was dealing with;*

17          *Whereas, Howard McCoy was left with medical bills and*  
18          *other bills which he was struggling to pay because of his*  
19          *inability to work while recovering from the shooting;*

20          *Whereas, Officer Grile and his family stepped up to help*



1     *him in his time of need by helping to raise money towards his*  
2     *bills until he was able to return to work;*

3             *Whereas, it is because of these acts of kindness that Mr.*  
4     *McCoy was able to pay his bills, but he was also to find a*  
5     *friend in Officer Grile and Officer Grile in Mr. McCoy; and*

6             *Whereas, Officer Grile was also awarded several awards*  
7     *from the Anderson Police Department for his actions on that*  
8     *day, the Medal of Valor, the Life Saving Award, and the*  
9     *Combat Cross: Therefore,*

10            *Be it resolved by the Senate of the General Assembly*  
11            *of the State of Indiana, the House of Representatives*  
12            *concurring:*

13            SECTION 1. The Indiana Senate recognizes the work of  
14     Officer Shad Grile in serving the citizens of Anderson.
