SENATE CONCURRENT RESOLUTION No. 30

A CONCURRENT RESOLUTION condemning and denouncing genocide, crimes against humanity, and other mass atrocities and affirming the Indiana General Assembly's commitment to educate people about and take action to prevent genocide, crimes against humanity, and other mass atrocities in compliance with the genocide convention.

Whereas, After the atrocities of the Second World War, the
United Nations adopted the Convention on the Prevention and
Punishment of the Crime of Genocide on December 9th, 1948;

Whereas, That treaty defined "genocide" as: any of the 10 following acts committed with intent to destroy, in whole or in 11 part, a national, ethnical, racial or religious group, as such: 12 killing members of the group, causing serious bodily or mental 13 harm to members of the group, deliberately inflicting on the 14 group conditions of life calculated to bring about its physical 15 destruction in whole or in part, imposing measures intended to 16 prevent births within the group, and forcibly transferring 17 children of the group to another group; 18

19 Whereas, Crimes Against Humanity are defined according to Article 7 of the Rome Statute as: For the purpose of this 20 Statute, 'crime against humanity' means any of the following 21 acts when committed as part of a widespread or systematic 22 attack directed against any civilian population, with knowledge 23 of the attack: murder, extermination, enslavement, deportation 24 or forcible transfer of population, imprisonment or other severe 25 deprivation of physical liberty in violation of fundamental rules 26



of international law, torture, rape, sexual slavery, enforced 1 prostitution, forced pregnancy, enforced sterilization, or any 2 other form of sexual violence of comparable gravity, 3 persecution against any identifiable group or collectivity 4 5 on political, racial, national, ethnic, cultural, religious, [and] gender, enforced disappearance of persons, the crime of 6 apartheid, other inhumane acts of a similar character 7 intentionally causing great suffering, or serious injury to body 8 9 or to mental or physical health; 10 Whereas, Hoosiers and the State of Indiana value universal respect for human rights and fundamental freedoms and believe 11 that all persons and citizens of the world deserve justice, 12 equality, safety, and security; 13 Whereas, The Indiana House of Representatives in House 14 Resolution 8 of 2020 declared April each year as Genocide 15 Awareness Month: 16 Whereas, The State of Indiana routinely purchases from 17 and invests in corporations having global operations and 18 19 supply chains; 20 Whereas, Hoosiers and the Indiana General Assembly recognize the role that local communities and governments can 21 take to promote the practice of ethical procurement and ethical 22 investment in accordance with their values; 23 Whereas, Hoosiers have historically employed their 24 procurement and investment power to pressure corporations to 25 end their complicity in the apartheid system in South Africa, 26 27 religious discrimination in both Northern Ireland and against Jews in the former Soviet Union, and the genocide in Darfur, 28 Sudan: and 29 30 Whereas, communities throughout Indiana have themselves 31 been victims of, and endured acts of, genocide or human rights 32 atrocities in their countries of origin: Therefore, 33

Be it resolved by the Senate of the General Assembly





of the State of Indiana, the House of Representatives concurring:

SECTION 1. That the Indiana General Assembly and the State of Indiana supports and promotes that all persons, regardless of where they were born, have basic human rights and fundamental freedoms, and that it is all governments' and citizens' moral obligation to recognize and respect these rights and freedoms.

9 SECTION 2. That the Indiana General Assembly continues to condemn all internationally recognized genocides, crimes 10 against humanity, and other mass atrocities and that the Indiana 11 General Assembly seeks to foster relationships with 12 13 corporations and/or other organizations that avoid engaging in business practices with governments and/or corporations 14 complicit in genocide, crimes against humanity, and other mass 15 atrocities to ensure the ethical procurement of resources and 16 ethical development and maintenance of supply chains. 17

18 SECTION 3. That the Indiana General Assembly will 19 explore ways to support the ethical procurement and 20 responsible investment of taxpayer dollars in the marketplace 21 for goods, services, and capital in accordance with our values 22 and to employ our economic power as part of a global 23 constituency against genocide, crimes against humanity, and 24 other mass atrocities.

25 SECTION 4. That the Indiana General Assembly will look 26 for guidance from locally and nationally recognized 27 organizations to educate Hoosiers about genocide, crimes 28 against humanity, and other mass atrocities, as well as what 29 Hoosiers can do to help prevent or mitigate genocidal violence.
