7 *and prosperity;*

8 *Whereas, From its origins, the Indiana Chamber has grown*
9 *to partner with 25,000 members and investors, located across*
10 *all 92 Hoosier counties;*

11 *Whereas, Throughout its history, the Indiana Chamber has*
12 *bettered the state's business climate through legislative*
13 *advocacy, business education, and various affiliates and*
14 *programs;*

15 *Whereas, The Indiana Chamber Foundation funds studies,*
16 *initiates actions, and seeks solutions that positively impact*
17 *Indiana's economic future and enhance the quality of life for all*
18 *Hoosiers;*

19 *Whereas, The Indiana Chamber supports the business*
20 *community in many ways, including Work and Learn Indiana,*
21 *a program that provides a work-based learning marketplace*
22 *connecting Indiana employers with prospective employees, and*
23 *the Wellness Council of Indiana, which guides employers and*

6 *economic development plan, the Indiana Chamber has accepted*
7 *responsibility for securing and enhancing Indiana's economic*
