5 *Saturday, March 4, 2017, at the age of 63;*

6 *Whereas, Mark Davis graduated from West Lafayette High*
7 *School and Indiana University, where he earned a law*
8 *degree;*

9 *Whereas, Mark Davis began his career working in*
10 *economic development in Indianapolis, Greater Lafayette,*
11 *and Flint, Michigan, before opening an independent law*
12 *practice in Lafayette;*

13 *Whereas, His career highlights include helping to bring the*
14 *Subaru plant to Lafayette, working on agreements with the*
15 *United States and Canada on the Blue Water Bridge that*
16 *spans our two countries, and helping to promote the Hoosier*
17 *Heartland highway; and*

18 *Whereas, The death of Mark S. Davis left a huge void in the*
19 *lives of all who knew him; he will be greatly missed:*
