6 *completed the 2017 season with thirteen wins and two losses;*

7 *Whereas, Southridge High School prevailed against*
8 *South Spencer, Linton-Stockton, Evansville Mater Dei,*
9 *Providence, and Indianapolis Scecina Memorial High School*
10 *to play against Woodlan High School in the state*
11 *championship game at Lucas Oil Stadium;*

12 *Whereas, Senior quarterback Jayce Harter threw a 57-*
13 *yard pass to junior running back Tucker Schank to set up a*
14 *converted score for senior running back Colin Smith to tie*
15 *Woodlan High School with 2:08 left in the first quarter;*

16 *Whereas, Senior cornerback Jacob Masterson*
17 *intercepted a pass on fourth down with 2:40 left in the fourth*
18 *quarter;*

19 *Whereas, Tucker Schank caught a screen from Jayce*
20 *Harter and ran for 42 yards to score a touchdown with 1:22*
21 *left;*

22 *Whereas, Jayce Harter threw to Tucker Schank in the flat*
23 *for a two-point conversion to finalize the score at 15-14; and*
