1 A CONCURRENT RESOLUTION recognizing the 100th
2 anniversary of Indiana Farm Bureau.

3 *Whereas, Indiana Farm Bureau was founded on March 25,*
4 *1919, in Indianapolis;*

5 *Whereas, Since its inception, Indiana Farm Bureau has*
6 *worked to promote agriculture through public education,*
7 *member engagement, and advocacy for agricultural and rural*
8 *needs;*

9 *Whereas, Indiana Farm Bureau has a presence in all 92*
10 *counties and represents the interests of a variety of farmers,*
11 *agribusiness professionals, and rural citizens across the state;*

12 *Whereas, Indiana Farm Bureau created farmer*
13 *cooperatives for purchases of inputs such as seed, fertilizer,*
14 *feed, petroleum products, and farm equipment, and for the*
15 *marketing of livestock, dairy, and grain, which led to the*
16 *economic success and growth of farms and rural Indiana;*

17 *Whereas, In an effort to meet the insurance needs of*
18 *Indiana farmers, Indiana Farm Bureau organized a mutual*
19 *insurance company in 1934, which is now the largest farm*
20 *insurance company in Indiana;*

21 *Whereas, Indiana Farm Bureau's grassroots advocacy and*
22 *presence at the Indiana Statehouse and county courthouses*
23 *have allowed farmers to engage in the civic process of public*
24 *policy development and implementation;*



1 *Whereas, Indiana Farm Bureau has become the voice for*
2 *agriculture in Indiana; and*

3 *Whereas, In 2019, Indiana Farm Bureau celebrates its*
4 *centennial, honoring the dedication and hard work of Hoosier*
5 *farmers throughout the state: Therefore,*

6 *Be it resolved by the Senate of the General Assembly*
7 *of the State of Indiana, the House of Representatives*
8 *concurring:*

9 SECTION 1. That the Indiana General Assembly
10 recognizes the 100th anniversary of Indiana Farm Bureau.
