3	Whereas, The Junior League of Indianapolis ("JLI") was
4	founded in 1922, and has spearheaded countless community
5	service initiatives over its 95 years, including founding the
6	Occupational Therapy Department at Riley Hospital for
7	Children, playing a key role in the city's hospitality efforts at
8	the 1987 Pan Am Games, establishing the Docent Program
9	at the Indianapolis Museum of Art, and leading the first
10	Susan G. Komen Race for the Cure;
11	Whereas, JLI is committed to furthering its missions of
12	promoting voluntarism, developing the potential of women,
13	and improving the community through the effective action
14	and leadership of trained volunteers;
15	Whereas, JLI has served as an incubator of talent and for
16	95 years has invested in the future of its leaders and the
17	community by training, mentoring, and inspiring generations
18	of women to work together to build a better community;
19	Whereas, JLI has served Marion County and the
20	surrounding areas with projects focusing on social support,
21	family support, and access to strong educational
22	programming and resources;

1	Whereas, JLI members serve as volunteers to the city and
2	have demonstrated an unparalleled commitment to
3	community service in Indianapolis for generations;
4	Whereas, JLI partners with over a dozen organizations
5	each year to invest over \$200,000 in funding and countless
6	volunteer hours to build a better community since 2013,
7	which equates to an investment of over one million dollars in
8	Central Indiana;
9	Whereas, JLI held its inaugural "Around the Community
10	- Around the Clock" event in 2016, during which more than
11	160 members engaged in 94 hours of continuous community
12	service in donating a combined total of 506 volunteer hours
13	to 13 nonprofit organizations;
14	Whereas, JLI is expanding the "Around the Community -
15	Around the Clock" event to 95 continuous hours of
16	community service in honor of its 95th anniversary in 2017;
17	Whereas, JLI intends to expand "Around the Community
18	- Around the Clock" by one hour each year, leading up to
19	100 hours to celebrate its 100^{th} anniversary in 2022; and
20	Whereas, It is fitting that the Indiana General Assembly
21	honors JLI on the occasion of its 95th anniversary, commends
22	JLI for its enduring commitment to bettering the community,
23	and thanks JLI for its immeasurable service to Indianapolis:
