3 for Terre Haute North Vigo High School, Terre Haute South
4 Vigo High School, and West Vigo High School for their
5 commitment to community service learning.

6 *Whereas, Vigo County School Corporation (VCSC) is*
7 *resolved to equip all students with the skills necessary to be*
8 *productive and responsible citizens;*

9 *Whereas, Service learning is an excellent vehicle for*
10 *instilling the virtues of good citizenship as it provides students*
11 *the opportunity to develop skills in the areas of communication,*
12 *collaboration, and leadership while addressing real needs in*
13 *their community;*

14 *Whereas, VCSC has partnered with the Terre Haute*
15 *Chamber of Commerce, and both are committed to providing*
16 *an environment that is conducive to service learning;*

17 *Whereas, In July 2021, the VCSC superintendent, Dr. Rob*
18 *Haworth, challenged a group of high school students to lead*
19 *their peers in providing 50,000 hours of community service*
20 *during the 2021-22 school year;*

21 *Whereas, The students that comprise the Superintendent's*
22 *Student Advisory Councils for the three VCSC high schools -*
23 *Terre Haute North Vigo High School, Terre Haute South Vigo*
24 *High School, and West Vigo High School - rose to the challenge*
25 *and demonstrated exceptional leadership in the pursuit of the*



1 50,000-hour goal;

2 *Whereas, By the end of September 2021, the three VCSC*
3 *high schools had reported more than 24,000 hours and were*
4 *almost halfway toward the goal;*

5 *Whereas, In their efforts to reach this unprecedented*
6 *milestone, the students of all three Vigo County high schools*
7 *have exhibited outstanding community spirit and have brought*
8 *respect, honor, and integrity to all of Vigo County, their*
9 *schools, teachers, staff, parents, and guardians; and*

10 *Whereas, To encourage an active and productive citizenry,*
11 *it is altogether fitting that the Indiana General Assembly*
12 *acknowledge and congratulate outstanding community service*
13 *efforts like those of VCSC and its students: Therefore,*

14 *Be it resolved by the Senate of the General Assembly*
15 *of the State of Indiana, the House of Representatives*
16 *concurring:*

17 SECTION 1. That the Indiana General Assembly
18 recognizes Vigo County School Corporation and the Student
19 Advisory Councils for Terre Haute North Vigo High School,
20 Terre Haute South Vigo High School, and West Vigo High
21 School for their commitment to community service learning.

22 SECTION 2. The Secretary of the Senate is hereby directed
23 to transmit copies of this Resolution to the principals of Terre
24 Haute North Vigo High School, Terre Haute South Vigo High
25 School, and West Vigo High School; the Terre Haute Chamber
26 of Commerce; and the Vigo County School Corporation Board
27 of School Trustees.
