4 *Whereas, Jane Seigel received her Bachelors of Arts*
5 *degree from DePauw University in 1976 and her Juris*
6 *Doctorate from the Indiana University School of Law -*
7 *Indianapolis in 1979;*

8 *Whereas, Jane served as general counsel for the Indiana*
9 *Association of Cities and Towns and worked in various legal*
10 *positions at the Indianapolis-Marion County City-County*
11 *Legal Division, now the Office of Corporation Counsel,*
12 *before being appointed by Chief Justice Randall Shepard in*
13 *1998 as the executive director of the Indiana Judicial Center;*

14 *Whereas, During her tenure, Jane increased*
15 *collaboration with state and local criminal justice*
16 *stakeholders and oversaw the expansion of judicial*
17 *education, problem-solving courts, and juvenile detention*
18 *alternatives;*

19 *Whereas, Jane played a critical role in the merger of the*
20 *former Indiana Judicial Center and Division of State Court*
21 *of Administration in 2016 and currently leads a staff of 62*
22 *employees who provide high caliber training and education,*
23 *legal research, and technical assistance for trial court*
24 *judges, probation officers, and court personnel;*



1 *Whereas, As executive director, Jane serves as Indiana's*
2 *Commissioner on the Interstate Commission for Adult*
3 *Offender Supervision and the Interstate Juvenile Compact,*
4 *chairs the Justice Reinvestment Advisors Council and the*
5 *Rules Committee for the Adult Interstate Commission, serves*
6 *on the Board of Trustees of the Indiana Criminal Justice*
7 *Institute, and serves on the State Steering Committee for the*
8 *Juvenile Detention Alternatives Initiative, and is a member*
9 *of the Annie E. Casey's JDAI Applied Leadership Network;*

11 *Whereas, Jane was awarded the 2008 Founder's Award*
12 *from the Probation Officers Professional Association of*
13 *Indiana and the 2013 Executive Chair Award from the*
14 *Interstate Commission for Adult Offender Supervision; and*

15 *Whereas, Jane is retiring from her position as executive*
16 *director of the Indiana Office of Court Services after 20*
17 *years: Therefore,*

18 *Be it resolved by the Senate of the General Assembly*
19 *of the State of Indiana, the House of Representatives concurring:*

21 congratulates Jane Seigel on her retirement from the Indiana
