8	Whereas, Bishop Finnell graduated from Shortridge High
9	School in Indianapolis and attended IUPUI, where he majored
0	in Business Administration, and later he attended Aenon Bible
1	College and was ordained as an Elder by the Pentecostal
2	Assemblies of the World (P.A.W.);
3	Whereas, In 1980, Bishop Finnell founded and became
4	pastor of the Apostolic Lighthouse Church in Bloomington,
5	Indiana, where he traveled at least twice each week for
6	twenty-two years, despite residing in Indianapolis and
7	maintaining a full-time job with the U.S. Postal Service, to
8	minister to students from Indiana University and the
9	Bloomington community;
0	Whereas, During his tenure as pastor of the Apostolic
1	Lighthouse Church, Bishop Finnell exhibited his zeal and
	passion for the Word of God by overseeing the growth of the
2	church both spiritually and naturally, including the
4	construction of a new church edifice and the purchase of two
5	homes - one for housing and the other renovated to house a

3	pastor Christ Temple Apostolic Faith Assembly in Indianapolis
4	and was subsequently elevated to the office of Suffragan
5	Bishop, and in August 2012, he was elevated to full Bishop in
6	the Pentecostal Assemblies of the World and assigned to the
7	50th Episcopal District, Nigeria West Africa, Western District
8	Council;
9	Whereas, As pastor of Christ Temple, Bishop Finnell has
10	exhibited strong leadership in spiritual matters while also
11	leading his community through times of crisis, demonstrated by
12	his efforts to make sure his community was safe and provided
13	with food and necessities during the pandemic;
14	Whereas, Bishop Finnell is significantly involved in urban
15	ministry as he attempts to make a difference within the city and
16	the surrounding neighborhood of the church he now pastors;
17	Whereas, Bishop Finnell is a devoted family man, married
18	to Vivian Y. Price Finnell, and is the loving father of two sons

20	great-granddaughter, and a great-grandson due in June; and
