3 Agency.

4 *Whereas, After nearly 46 years of dedicated service to the*
5 *Indiana General Assembly and the citizens of Indiana, Judy*
6 *Stull is retiring;*

7 *Whereas, Judy joined the Legislative Services Agency in*
8 *August 1972 and began a career that has spanned nearly five*
9 *decades as she rose through the ranks to become the agency's*
10 *Data Processing Manager;*

11 *Whereas, During her career of selfless public service, Judy*
12 *has worked for the Legislative Services Agency and has*
13 *supported the Indiana General Assembly and its staff in using*
14 *computers and technology;*

15 *Whereas, Judy is regarded among her colleagues as a*
16 *preeminent problem solver, and likens her job to that of a*
17 *detective trying to solve the mysteries often posed by new and*
18 *ever-changing technology;*

19 *Whereas, Judy has been instrumental in the development of*
20 *the drafting systems used for the Indiana General Assembly,*
21 *starting with a basic system in the age before computers and*
22 *culminating in the technologically advanced drafting*
23 *environment used today;*

24 *Whereas, Judy is known as a "macro writer extraordinaire,"*
25 *has developed an expertise in the Word Perfect computer*



1 *system and its macro-based programming technology, and was*
2 *the architect of modernized processes for the in-house printing*
3 *of legislative documents and the annual publication of the*
4 *Indiana Code;*

5 *Whereas, Judy's commitment to efficiency and modernization*
6 *has continued throughout her career, resulting most recently in*
7 *the development of the "merge and markup" program that aids*
8 *legislative committees in their consideration of proposed*
9 *amendments;*

10 *Whereas, The State of Indiana has realized increased*
11 *efficiency and financial savings as a result of Judy's efforts,*
12 *which often required her to work through the night and into the*
13 *early morning hours to meet the requirements of the next day's*
14 *legislative session; and*

15 *Whereas, Even though Judy Stull will be leaving the*
16 *Legislative Services Agency for the joys of retirement and more*
17 *time with her family, she will be greatly missed by all her*
18 *colleagues at the Legislative Services Agency: Therefore,*

19 *Be it resolved by the Senate*
20 *of the General Assembly of the State of Indiana,*
21 *the House of Representatives concurring:*
