4 *Whereas, Phillip (Sean) Barrett will be retiring from the*
5 *Indianapolis Fire Department on March 19, 2018, after*
6 *thirty-three years of dedication and service to the greater*
7 *Indianapolis community;*

8 *Whereas, Sean grew up in Franklin Township in*
9 *Indianapolis, Indiana, and enlisted into the United States*
10 *Marine Corps in 1975 to serve honorably for six years*
11 *immediately following his graduation from high school;*

12 *Whereas, Upon discharge from the Marines, Sean*
13 *worked as an EMT for Wishard Hospital Ambulance Service*
14 *from 1982 to 1985 before joining the Indianapolis Fire*
15 *Department in March of 1985 as a firefighter, engineer, and*
16 *EMT;*

17 *Whereas, Sean began his tenure in the old City of*
18 *Indianapolis Fire Department before transferring to the*
19 *Franklin Township sector once both departments merged to*
20 *create the Indianapolis Fire Department, and will retire from*
21 *Station 52 in Acton, Indiana;*

22 *Whereas, In addition to his full-time position at the fire*
23 *department, Sean worked part-time at Consec's Fieldhouse's*
24 *First Aid Department, participated on Indiana Task Force 1,*



1 *and is a co-founder of Paranormal 911 with his wife, Mary;*

3 *Whereas, During retirement, Sean plans to spend*
4 *additional time in Franklin Township, where he still resides,*
5 *with his wife, children, grandchildren, and great-*
