1           A CONCURRENT RESOLUTION recognizing National Donate  
2 Life Month and the honorable service provided by Donate Life  
3 America and Donate Life Indiana.

4           *Whereas, National Donate Life Month ("NDLM") was*  
5 *instituted by Donate Life America and its partnering*  
6 *organizations in 2003;*

7           *Whereas, Celebrated in April each year, NDLM features*  
8 *an entire month of local, regional, and national activities to*  
9 *help encourage Americans to register as organ, eye, and*  
10 *tissue donors and to celebrate those who have saved lives*  
11 *through the gift of donation;*

12           *Whereas, Donate Life America is a not-for-profit alliance*  
13 *of national organizations and state teams across the United*  
14 *States committed to increasing the number of donated*  
15 *organs, eyes, and tissue available for transplant to save and*  
16 *heal lives;*

17           *Whereas, Founded as the Coalition on Donation in 1992*  
18 *by the transplant community, the Donate Life community has*  
19 *grown donor designation to nearly 135 million registered*  
20 *organ, eye, and tissue donors in the United States;*

21           *Whereas, On the state level, Donate Life Indiana is the*  
22 *state-authorized nonprofit organization responsible for*



1 *managing the Indiana Donor Registry. Donate Life Indiana's*  
2 *mission is to save lives by creating opportunities for all*  
3 *Indiana citizens to sign up on the official state registry while*  
4 *striving to raise awareness for organ, eye and tissue*  
5 *donation and transplantation through public education;*

6 *Whereas, The Indiana General Assembly commends*  
7 *Donate Life America and Donate Life Indiana for their*  
8 *honorable work that has saved and healed countless lives;*

10 *Whereas, It is fitting that the Indiana General Assembly*  
11 *recognizes National Donate Life Month and the honorable*  
12 *service provided by Donate Life America and Donate Life*  
13 *Indiana: Therefore,*

14 *Be it resolved by the Senate of the General Assembly*  
15 *of the State of Indiana, the House of Representatives concurring:*
