



SENATE JOINT RESOLUTION No. 2

DIGEST OF INTRODUCED RESOLUTION

Citations Affected: Article 4 of the Constitution of the State of Indiana.

Synopsis: Redistricting commission. Requires the general assembly to establish a commission to draw congressional and legislative districts. This proposed amendment has not been previously agreed to by a general assembly.

Effective: This proposed amendment must be agreed to by two consecutive general assemblies and ratified by a majority of the state's voters voting on the question to be effective.

Introduced

First Regular Session 120th General Assembly (2017)

A JOINT RESOLUTION proposing an amendment to Article 4 of the Constitution of the State of Indiana concerning the general assembly.

Be it resolved by the General Assembly of the State of Indiana:

- 1 SECTION 1. The following amendment to the Constitution of the
2 State of Indiana is proposed and agreed to by this, the One Hundred
3 Twentieth General Assembly of the State of Indiana, and is referred to
4 the next General Assembly for reconsideration and agreement.
5 SECTION 2. ARTICLE 4, SECTION 5 OF THE CONSTITUTION
6 OF THE STATE OF INDIANA IS AMENDED TO READ AS
7 FOLLOWS: Section 5. (a) The General Assembly ~~elected during the~~
8 ~~year in which a federal decennial census is taken~~ shall fix by law the
9 number of Senators and Representatives. ~~and apportion them among~~
