I offer the following resolution and move its adoption:

1 A SENATE RESOLUTION congratulating Judge Stephen
2 R. Heimann on his retirement from the Bartholomew County

4 *Whereas, Judge Heimann has served the people of Bartholomew*
5 *County as a Circuit Court Judge since October 1, 1991;*

6 *Whereas, Judge Heimann received his undergraduate degree from*
7 *Wabash College in 1977 and graduated cum laude from the Indiana*
8 *University School of Law, Indianapolis in 1980;*

9 *Whereas, Prior to his service on the bench, Judge Heimann had*
10 *an illustrious career as a clerk for Judge Cale Holder, a public*
11 *defender in Marion and Bartholomew counties, an attorney for the*
12 *Indiana Jaycees Charitable Foundation, and as a private practitioner;*

13 *Whereas, Judge Heimann has been a standard bearer in his*
14 *community as a prominent leader in the St. Bartholomew Catholic*
15 *Church, member of the Columbus Rotary, Columbus Jaycees, and*
16 *Knights of Columbus, and board member for the Foundation for Youth,*
17 *Bartholomew County Crime Stoppers, and the Bartholomew County*
18 *Bar Association;*

19 *Whereas, During his time on the bench, Judge Heimann served as*
20 *President of the Indiana Council of Juvenile Family Court Judges,*



1 *Director of the Indiana Judicial Conference, Chair of the Judicial*
2 *Ethics and Professionalism Committee, Judicial Education Committee,*
3 *Criminal Justice Coordinating Committee, and most recently, the*
4 *Judges and Lawyers Assistance Program;*

5 *Whereas, Demonstrating his commitment to the legal profession,*
6 *Judge Heimann has given numerous seminar presentations to fellow*
7 *lawyers and judges across the state;*

8 *Whereas, Judge Heimann has received numerous accolades*
9 *throughout his career including the Robert J. Kinsey Award "In*
10 *Recognition of Outstanding Judicial Service and Support to the Youth*
11 *of Indiana," the Outstanding Judge Award from the Indiana Bar*
12 *Association Young Lawyers Section, and the Indiana Judicial Service*
13 *Award;*

14 *Whereas, Judge Heimann has been married to his wife Ann for 41*
15 *years and has two children, Andrew and Emily, and a granddaughter,*
16 *Nora; and*

17 *Whereas, Judge Heimann is retiring from the Bartholomew*
18 *County Circuit Court after twenty five years of valuable service:*
