I offer the following resolution and move its adoption:

3 *Whereas, Ronald Roy Miner II, also known as DJ Indiana*
4 *Jones, of Indianapolis, Indiana, passed away on December 4,*
5 *2020;*

6 *Whereas, Born in June 1970 to Ron Miner and Barbara*
7 *Lawrence in Indianapolis, Indiana, Miner grew up on the West*
8 *side of Indianapolis, first graduating from Ben Davis High*
9 *School and then Indiana University - Purdue University*
10 *Indianapolis;*

11 *Whereas, Miner began DJing in 1984 at his family's roller*
12 *rink, Melody Skateland, where he began establishing himself as*
13 *a leader in the industry, and most recently owned the Casba*
14 *Bar in Broad Ripple;*

15 *Whereas, Miner influenced Indiana's DJ scene through his*
16 *extraordinary music and passion for mentoring and amplifying*
17 *others, including through the management group he*
18 *co-founded, Crush Entertainment, that represents artists*

12 *Whereas, Miner's legacy will be remembered through his*
13 *music, leadership, deep relationships with others, and his*
14 *generosity, and he will be greatly missed by his friends, family,*
