A SENATE RESOLUTION concerning the Motor Vehicle Inspection and Maintenance Programs in Lake and Porter Counties.

SENATE RESOLUTION No. 12

MADAM PRESIDENT:

I offer the following resolution and move its adoption:

1	A SENATE RESOLUTION concerning the Motor Vehicle
2	Inspection and Maintenance Programs in Lake and Porter Counties.
3	Whereas, The motor vehicle inspection and maintenance (I/M)
4	programs in Lake and Porter Counties were begun under federal
5	requirements in 1984 because Lake and Porter Counties were not in
6	"attainment" of federal standards for ozone;
7	Whereas, According to the United States Environmental Protection
8	Agency (EPA), cars and trucks collectively are the single greatest
9	contributor to ground-level ozone, the major component of smog;
10	Whereas, The purpose of an I/M program is to reduce ground-level
11	ozone by ensuring that the emission control systems on vehicles are
12	working correctly;
13	Whereas, An I/M program cannot reduce the ground-level ozone
14	caused by a vehicle if the vehicle is not subject to the I/M program;
15	Whereas, Generally, only vehicles registered in Lake and Porter
16	Counties are subject to the I/M programs in Lake and Porter Counties;
17	Whereas, Lake and Porter Counties in northwest Indiana are crossed
18	by Interstate Highway 80/90 and Interstate Highway 94, two of the
19	most heavily traveled highways in the Midwest, and Lake County is
20	also crossed by Interstate Highway 65, another heavily traveled
21	highway linking major southern cities with Chicago;
22	Whereas, The I/M programs, therefore, cannot do anything to
23	address a major source of ground-level ozone in Lake and Porter
24	Counties; namely, the many motor vehicles passing through Lake and
25	Porter Counties on Interstate Highways 80/90, 94, and 65;



1	Whereas, The United States EPA itself predicts that remote sensing
2	technologies may soon offer the potential for a fast and convenient way
3	to identify high-emitting vehicles by taking a "snapshot" of a vehicle's
4	emissions as it passes by a sensor located on the side of the road; and
5	Whereas, The United States EPA's establishment this past October
6	of a new, lower ozone standard of 70 parts per billion makes this an
7	appropriate point for federal and state environmental regulators to
8	appraise the ozone control measures in place and consider whether
9	new measures should replace them: Therefore,
10	Be it resolved by the Senate
11	of the General Assembly of the State of Indiana:
12	SECTION 1. That the Indiana Senate urges the Environmental
13	Protection Agency to revise or eliminate the requirements under which
13	the motor vehicle inspection and maintenance (I/M) programs in Lake

15	and Porter Counties are operated.
16	SECTION 2. That the Secretary of the Senate is hereby directed to
17	transmit a copy of this resolution to Gina McCarthy, the Administrator
18	of the United States Environmental Protection Agency, and to Susan
19	Hedman, Administrator for Region 5 Office of the Environmental
20	Protection Agency in Chicago.
