I offer the following resolution and move its adoption:

1 A SENATE RESOLUTION honoring the Indiana Citizens
2 Redistricting Commission for their work on the 2021
3 redistricting process.

12 *Commission were vetted through numerous criteria to ensure*
13 *the integrity of the Commission;*

14 *Whereas, The Indiana Citizens Redistricting Commission*
15 *was comprised of three members who identify as Republican,*
16 *three members who identify as Democrat, three members who*
17 *identify as independent, and two alternates;*
