I offer the following resolution and move its adoption:

4 *Whereas, Senator Lanane has faithfully and honorably*
5 *served the constituents of Senate District 25, encompassing*
6 *parts of Madison and Delaware counties for 25 years;*

7 *Whereas, Senator Lanane is one of the General Assembly's*
8 *longest serving members, in office from 1997 to 2022;*

9 *Whereas, Senator Lanane served as a member on numerous*
10 *committees, including Judiciary, Local Government, Rules and*
11 *Legislative Procedure, Agriculture, Natural Resources, Tax and*
12 *Fiscal Policy, Appropriations, Joint Rules, Public Policy,*
13 *Family and Children Services, Elections, Commerce and*
14 *Technology, Corrections and Criminal Law, Insurance and*
15 *Financial Institutions, Utilities, Civil Law, and Ethics;*

16 *Whereas, Senator Lanane advocated for the welfare of*
17 *Hoosiers on a variety of issues, including voting rights, civil*
18 *rights, protections against sex trafficking, predatory lending,*
19 *and enhanced concussion protocols to protect student athletes;*

4 *Whereas, For his work in the Indiana State Senate, Senator*
5 *Lanane was recognized by the General Assembly with the*
6 *Legislative Civility Award for his ability to prioritize the needs*
7 *of his constituents over partisan conflicts;*

9 *Senator Lanane's professional experiences include working as*
10 *an attorney for the City of Anderson, the Indiana Legal Services*
11 *Organization, and in his own private practice;*

12 *Whereas, Senator Lanane earned his undergraduate degree*
13 *from Ball State University in 1974 and has remained*
14 *steadfastly proud of his alma mater, authoring several*
15 *recognitions of the school's accomplishments;*

16 *Whereas, Senator Lanane earned his law degree from the*
17 *Indiana University Robert H. McKinney School of Law and has*
18 *committed his life to utilizing his degree to assist Hoosiers*
19 *across the state; and*

20 *Whereas, The work of Senator Tim Lanane in the Indiana*
21 *Senate over the past 25 legislative sessions is worthy of honor*
22 *and recognition: Therefore,*
