## SENATE RESOLUTION \_\_\_\_\_

MADAM PRESIDENT:

I offer the following resolution and move its adoption:

1           A SENATE RESOLUTION congratulating Elliot Cox for  
2 his successes on and off the racetrack and transition into the  
3 USF2000 Championship racing series.

4           *Whereas, Fifteen-year-old Indianapolis native Elliot Cox is*  
5 *a decorated race car driver who has been selected to be behind*  
6 *the wheel of the Number 67 Sarah Fisher Hartman Racing*  
7 *entry for all eighteen rounds of the 2023 USF2000 Program,*  
8 *which is just below the Indy Car Series;*

9           *Whereas, Elliot's love for racing began in the Fall of 2012,*  
10 *when his grandfather took Elliot to buy his first kart, after*  
11 *which Elliot accomplished his first win at New Castle*  
12 *Motorsports Park at the age of five, and has continued to excel*  
13 *as his career has progressed;*

14           *Whereas, Elliot's recent major racing accomplishments*  
15 *include being the 2020 Whiteland Raceway Park Champion in*  
16 *the KA100 Junior Class, 2021 Whiteland Raceway Park*  
17 *Champion in the KA100 Senior Class, third in points for the*  
18 *2022 USF Juniors YACademy Winter Series, 2022 Winner of*  
19 *the USF Juniors YACademy Winter Series Homestead Race 2,*  
20 *and obtaining the 2022 track record at Homestead Motor*



1 *Speedway for F4 Cars;*

2 *Whereas, Following his first and only season in the USF*  
3 *Juniors, Elliot continued to make an enormous impression on*  
4 *and off the track, finishing 11th overall while only running a*  
5 *partial season and solidifying Sarah Fisher Hartman Racing's*  
6 *decision to move Elliot upwards into the USF2000 series for*  
7 *2023;*

8 *Whereas, Off the racetrack, Elliot continues to set an*  
9 *example through a number of initiatives, including his*  
10 *nonprofit, Driving for Dyslexia, which has used motorsports as*  
11 *a platform to raise over \$250,000 to aid dyslexia-related*  
12 *causes;*

13 *Whereas, Throughout his time racing, Elliot also excels in*  
14 *the classroom as a 10th-grade honor roll student, volunteers*  
15 *with A Kid Again and Alex's Lemonade Stand, and speaks in*  
16 *schools and at camps with the Joseph Maley Foundation about*  
17 *his journey to success while having dyslexia; and*

18 *Whereas, Elliot continues to set a tremendous example for*  
19 *the next generation of Hoosiers as he moves closer to realizing*  
20 *his ultimate dream of being the youngest person to ever*  
21 *compete in the Indianapolis 500, "The Greatest Spectacle in*  
22 *Racing": Therefore,*

23 *Be it resolved by the Senate of the*  
24 *General Assembly of the State of Indiana:*

25 SECTION 1. That the Indiana Senate congratulates Elliot  
26 Cox for his continued successes on and off the racetrack and  
27 transition into the USF2000 Championship racing series.
