## SENATE RESOLUTION

MADAM PRESIDENT:

I offer the following resolution and move its adoption:

1           A SENATE RESOLUTION honoring Senator Sue Landske  
2 upon her retirement from the Indiana State Senate.

3           *Whereas, Senator Sue Landske has led a distinguished*  
4 *career of public service, starting with her election as the Lake*  
5 *County Center Township Assessor from 1978 to 1984, and as*  
6 *a Colonel in the National Guard Reserve, before being elected*  
7 *to the Indiana State Senate in 1984;*

8           *Whereas, Senator Landske currently serves as the Assistant*  
9 *President Pro Tempore, chairs the Senate Committee on*  
10 *Elections, and also serves as the ranking member of the Civil*  
11 *Law Committee and as a majority member on the Tax and*  
12 *Fiscal Policy Committee;*

13           *Whereas, Throughout her 30 years in the Senate, Senator*  
14 *Landske has championed a number of issues that have bettered*  
15 *the lives of the people in her district in Northwest Indiana and*  
16 *the lives of Hoosiers all across the state;*

17           *Whereas, Several of Senator Landske's key proposals*  
18 *include the sweeping redistricting reforms following the 2010*  
19 *census she authored that established objective guidelines for*



1 *creating legislative and congressional districts, the legislation*  
2 *to encourage women to enter the engineering field, the bill to*  
3 *expand free in-state tuition to all Hoosier Purple Heart*  
4 *recipients, and Senator Landske helped author and shepherd*  
5 *legislation that provided for living wills;*

6 *Whereas, For her contributions and efforts, Senator*  
7 *Landske has been awarded the Sagamore of the Wabash twice,*  
8 *was named both the Outstanding Republican Senator and the*  
9 *Business and Professional Woman of the year in 1985, and in*  
10 *2012, Senator Landske was named Republican Woman of the*  
11 *Year by the Indiana Federation of Republican Women;*

12 *Whereas, Senator Landske and her husband, William, own*  
13 *and operate All Golfcar, Inc., and have five children and seven*  
14 *grandchildren; and*

15 *Whereas, Senator Landske's dedication, hard work, and*  
16 *passion will be greatly missed in the Indiana State Senate and*  
17 *throughout the Statehouse: Therefore,*

18 *Be it resolved by the Senate of the*  
19 *General Assembly of the State of Indiana:*

20 SECTION 1. That the Indiana Senate honors Senator Landske  
21 upon her retirement and sincerely thanks her for her years of service to  
22 the Indiana State Senate.
