MR. CHAIRMAN:

I move to amend **HB 2749**, As Amended by House Committee, on page 1, in line 9, after "terminated" by inserting "and erectile dysfunction treatments that are prescribed, dispensed or administered"; in line 13, after "terminated" by inserting "and erectile dysfunction treatment that has been prescribed, dispensed or administered"; in line 18, after "terminated" by inserting "and erectile dysfunction cases treated"; in line 19, after "terminated" by inserting "or erectile dysfunction treatment was prescribed, dispensed or administered"; in line 26, by striking "or" and inserting a comma; in line 27, after "performed" by inserting "or who were prescribed, dispensed or administered treatment for erectile dysfunction";

On page 3, in line 2, after "(e)" by inserting "Each male patient shall be asked, prior to an erectile dysfunction treatment method that involves a drug or durable medical equipment being prescribed, dispensed or administered, which of the following reasons was the most important factor in such male patient's decision to seek treatment for erectile dysfunction:

- (1) The male patient wants to conceive a child with such patient's sexual partner;
- (2) the male patient wants to experience increased intimacy with such patient's sexual partner;
- (3) the male patient's wife or sexual partner wants the patient to seek treatment for erectile dysfunction;
- (4) the male patient wants to increase the pleasure of such patient's sexual partner;
- (5) erectile dysfunction is affecting the male patient's self-confidence;
- (6) erectile dysfunction is causing the male patient stress; or

(7) erectile dysfunction is causing the male patient shame or embarrassment.

If the male patient declines to answer, such response shall be recorded.

(f) Each report required by this section shall include, for the period of time covered by the report:

(1) The number of times each of the reasons listed in subsection (e) was described as the most important; and

(2) the number of times a male patient seeking treatment for erectile dysfunction was asked about the reasons listed in subsection (e) and declined to answer.

Also on page 3, in line 4, after "abortion" by inserting "or erectile dysfunction treatment"; in line 11, after "abortion" by inserting "or erectile dysfunction treatment"; in line 13, after "abortion" by inserting "or erectile dysfunction treatment"; in line 16, after "abortion" by inserting "or erectile dysfunction treatment"; in line 23, after "on" by inserting "or erectile dysfunction treatment method was prescribed, dispensed or administered to"; in line 43, by striking "(f)";

On page 4, in line 4, by striking (f) and inserting (h) in line 11, by striking "(f)" and inserting "(h)"; also in line 11, by striking "(g)" and inserting "(i)";

And by redesignating subsections, paragraphs, subparagraphs and clauses accordingly;

On page 1, in the title, in line 1, after "concerning" by inserting "sexual and reproductive healthcare; relating to"; also in line 1, after "abortion" by inserting "and erectile dysfunction treatment"; also in line 1, by striking "relating to" and inserting "requiring certain"; also in line 1, after "abortions" by inserting "and erectile dysfunction treatments"; in line 3, after "performed" by inserting "or erectile dysfunction treatment
