1 AN ACT concerning the behavioral sciences; ~~increasing the membership~~
2 ~~of the behavioral sciences regulatory board; requiring the behavioral~~
3 **sciences regulatory board to process applications within a certain**
4 **time and establish an expedited application process;** relating to
5 licensure and regulation; professional counselors, social workers,
6 marriage and family therapists, addiction counselors, behavior analysts,
7 psychologists and master's level psychologists; decreasing the years of
8 practice required for reciprocity licensure; ~~requiring that clinical social~~
9 ~~work supervisors be approved by the board; providing additional~~
10 **reduced diagnosis and treatment** continuing education requirements;
11 establishing license categories for applicants from social work
12 programs in candidacy for accreditation and for temporary
13 reinstatement; extending the license period of temporary licenses;
14 **establishing a community-based license for professional counselors,**
15 **social workers, marriage and family therapists and psychologists;**
16 amending K.S.A. 65-5802, 65-5806, 65-6302, 65-6313, 65-6314, 65-
17 6402, 65-6407, 65-6608, 65-6614, 65-6618, 65-7504, 65-7505, 74-
18 5302, 74-5318, 74-5361, 74-5365, 74-5366, 74-5367 and 74-7501 and
19 K.S.A. 2022 Supp. 65-5804a, 65-5807, 65-5808, 65-6306, 65-6309, 65-

21 6613, 74-5310, 74-5315, 74-5316, 74-5363 and 74-5375 and repealing

24 *Be it enacted by the Legislature of the State of Kansas:*

25 ~~New Section 1. (a) On and after January 1, 2024, any licensee~~
26 ~~providing postgraduate clinical supervision for any individual working~~
27 ~~toward licensure as a clinical social worker shall be a board-approved~~
28 ~~clinical supervisor.~~

29 ~~(b) An application for a board-approved clinical supervisor shall be~~
30 ~~made to the board on a form and in the manner prescribed by the board~~
31 ~~and shall be accompanied by the fee as provided by K.S.A. 65-6314, and~~
32 ~~amendments thereto.~~

33 ~~(c) Each applicant for board-approved clinical supervisor shall~~
34 ~~furnish evidence satisfactory to the board that the applicant:~~

1 ~~(1) Is currently licensed by the board as a specialist clinical social~~
2 ~~worker and has practiced as a specialist clinical social worker for at least~~
3 ~~two years following licensure;~~

4 ~~(2) is not the subject of any disciplinary action of the board that~~
5 ~~would prohibit providing clinical supervision, as determined by the board;~~
6 ~~and~~

7 ~~(3) (A) Has completed the minimum number of semester hours, or~~
8 ~~the academic equivalent, of coursework related to the enhancement of~~
9 ~~supervision skills approved by the board; or~~

10 ~~(B) has completed the minimum number of continuing education~~
11 ~~hours related to the enhancement of supervision skills approved by the~~
12 ~~board.~~

13 ~~(c) Each board-approved clinical supervisor shall complete, as a part~~
14 ~~of the continuing education required under K.S.A. 65-6313, and~~
15 ~~amendments thereto, at least three hours of continuing education related to~~
16 ~~the enhancement of supervision skills, including at least one hour related~~
17 ~~to ethics in supervision.~~

18 ~~(d) This section shall be a part of and supplemental to the social~~
19 ~~workers licensure act.~~

20 **New Section 1. (a) Within 15 business days after receipt of an**
21 **application for any license, registration, permit or certificate issued by**
22 **the behavioral sciences regulatory board, the board shall notify the**
23 **applicant whether the board believes that the application is complete.**
24 **If the application is determined to be incomplete, the board shall**
25 **notify the applicant of the information needed in order to complete the**
26 **application. Once the application is determined to be complete, the**
27 **board shall complete the review of the application and issue a decision**
28 **thereon within 30 business days.**

29 **(b) (1) The behavioral sciences regulatory board shall adopt rules**
30 **and regulations to establish an expedited application process for any**
31 **license, registration, permit or certificate issued by the board. Upon**
32 **request on the application to expedite the processing of such**
33 **application and payment of the fee, the board shall complete the**
34 **review of the application and issue a decision thereon within 15**
35 **business days.**

36 **(2) (A) The board shall set the fee for an expedited application**
37 **process by adopting rules and regulations. Such fee shall be in**
38 **addition to any other fee established for the application but shall not**
39 **exceed \$100. The board shall not charge such fee for an expedited**
40 **application process to any applicant who is a military servicemember**
41 **or military spouse.**

42 **(B) As used in this paragraph:**

43 **(i) "Military servicemember" means a current member of the**

1 **army, navy, marine corps, air force, coast guard, space force, air or**
2 **army national guard of any state or any branch of the military**
3 **reserves of the United States or a former member who separated from**
4 **service by honorable discharge or general discharge under honorable**
5 **conditions.**

6 **(ii) "Military spouse" means the spouse of an individual who is a**
7 **current member of the army, navy, marine corps, air force, coast**
8 **guard, space force, air or army national guard of any state or any**
9 **branch of the military reserves of the United States.**

12 (a) *"Assessment" means selecting, administering, scoring and*
13 *interpreting instruments designed to describe an individual's aptitudes,*
14 *abilities, achievements, interests and personal characteristics.*

15 (b) *"Board" means the behavioral sciences regulatory board created*
16 *by K.S.A. 74-7501, and amendments thereto.*

17 (c) *"Consultation" means the application of principles, methods and*
18 *techniques of the practice of counseling to assist in solving current or*
19 *potential problems of individuals or groups in relation to a third party.*

20 (d) *"Extenuating circumstances" means any condition or situation*
21 *caused by events beyond an individual's control that is sufficiently extreme*
22 *in nature to result in the:*

23 (1) *Individual's inability to comply with requirements; or*

24 (2) *inadvisability of requiring the individual to comply with*
25 *requirements.*

26 (e) *"Licensed clinical professional counselor" means a person who*
27 *engages in the independent practice of professional counseling including*
28 *the diagnosis and treatment of mental disorders specified in the edition of*
29 *the diagnostic and statistical manual of mental disorders of the American*
30 *psychiatric association designated by the board by rules and regulations*
31 *and who is licensed under this act.*

32 (f) *"Licensed professional counselor" means a person who is licensed*
33 *under this act and who engages in the practice of professional counseling*
34 *only under the direction of a licensed clinical professional counselor, a*
35 *licensed psychologist, a person licensed to practice medicine and surgery*
36 *or a person licensed to provide mental health services as an independent*
37 *practitioner and whose licensure allows for the diagnosis and treatment of*
38 *mental disorders.*

39 ~~(b)~~(g) *"Practice of professional counseling" means assisting an*
40 *individual or group for a fee, monetary or otherwise, through counseling,*
41 *assessment, consultation and referral and includes the diagnosis and*
42 *treatment of mental disorders as authorized under the professional*
43 *counselors licensure act.*

1 (e)(h) "Professional counseling" means to assist an individual or
2 group to develop understanding of personal strengths and weaknesses, to
3 restructure concepts and feelings, to define goals and to plan actions as
4 these are related to personal, social, educational and career development
5 and adjustment.

29 Sec. 3. K.S.A. 2022 Supp. 65-5804a is hereby amended to read as
30 follows: 65-5804a. (a) Applications for licensure as a professional
31 counselor shall be made to the board on a form and in the manner
32 prescribed by the board. Each application shall be accompanied by the fee
33 ~~fixed set~~ under K.S.A. 65-5808, and amendments thereto.

34 (b) Each applicant for licensure as a professional counselor shall
35 furnish evidence satisfactory to the board that the applicant:

36 (1) Is at least 21 years of age;

37 (2) has completed 60 graduate semester hours including a graduate
38 degree in counseling or a related field from a college or university
39 approved by the board and that includes 45 graduate semester hours of
40 counseling coursework distributed among each of the following areas:

41 (A) Counseling theory and practice;

42 (B) the helping relationship;

43 (C) group dynamics, processing and counseling;

- 1 (D) human growth and development;
- 2 (E) lifestyle and career development;
- 3 (F) appraisal of individuals;
- 4 (G) social and cultural foundations;
- 5 (H) research and evaluation;
- 6 (I) professional orientation; and
- 7 (J) supervised practicum and internship;
- 8 (3) has passed an examination required by the board; and
- 9 (4) has satisfied the board that the applicant is a person who merits
10 the public trust.

11 (c) (1) Applications for licensure as a clinical professional counselor
12 shall be made to the board on a form and in the manner prescribed by the
13 board. Each applicant shall furnish evidence satisfactory to the board that
14 the applicant:

15 (A) Is licensed by the board as a licensed professional counselor or
16 meets all requirements for licensure as a licensed professional counselor;

17 (B) has completed 15 credit hours, as part of or in addition to the
18 requirements under subsection (b), supporting diagnosis or treatment of
19 mental disorders with use of the American psychiatric association's
20 diagnostic and statistical manual through identifiable study of the
21 following content areas: Psychopathology, diagnostic assessment,
22 interdisciplinary referral and collaboration, treatment approaches and
23 professional ethics;

24 (C) has completed a graduate level supervised clinical practicum of
25 supervised professional experience including psychotherapy and
26 assessment with individuals, couples, families or groups, integrating
27 diagnosis and treatment of mental disorders with use of the American
28 psychiatric association's diagnostic and statistical manual, with not less
29 than 280 hours of direct client contact or additional postgraduate
30 supervised experience as determined by the board;

31 (D) has completed not less than two years of postgraduate supervised
32 professional experience in accordance with a clinical supervision plan
33 approved by the board of not less than 3,000 hours of supervised
34 professional experience, including at least 1,500 hours of direct client
35 contact conducting psychotherapy and assessments with individuals,
36 couples, families or groups and not less than 100 hours of face-to-face
37 clinical supervision, as defined by the board in rules and regulations,
38 including not less than 50 hours of individual supervision, except that the
39 board may waive the requirement that such supervision be face-to-face
40 upon a finding of extenuating circumstances, integrating diagnosis and
41 treatment of mental disorders with use of the American psychiatric
42 association's diagnostic and statistical manual, except that the board may
43 waive $\frac{1}{2}$ of the hours required by this subparagraph for an individual who

1 has a doctoral degree in professional counseling or a related field approved
2 by the board and who completes the required $\frac{1}{2}$ of the hours in not less
3 than one year of supervised professional experience;

4 (E) for persons who earned a degree under subsection (b) prior to
5 July 1, 2003, in lieu of the education requirements under subparagraphs
6 (B) and (C), has completed the education requirements for licensure as a
7 professional counselor in effect on the day immediately preceding the
8 effective date of this act;

9 (F) for persons who apply for and are eligible for a temporary permit
10 to practice as a licensed professional counselor on the day immediately
11 preceding the effective date of this act, in lieu of the education and training
12 requirements under subparagraphs (B), (C) and (D), has completed the
13 education and training requirements for licensure as a professional
14 counselor in effect on the day immediately preceding the effective date of
15 this act;

16 (G) has passed an examination approved by the board; and

17 (H) has paid the application fee ~~fixed~~ set under K.S.A. 65-5808, and
18 amendments thereto.

19 (2) A person who was licensed or registered as a professional
20 counselor in Kansas at any time prior to the effective date of this act, who
21 has been actively engaged in the practice of professional counseling as a
22 registered or licensed professional counselor within five years prior to the
23 effective date of this act and whose last license or registration in Kansas
24 prior to the effective date of this act was not suspended or revoked, upon
25 application to the board, payment of fees pursuant to K.S.A. 65-5808, and
26 amendments thereto, and completion of applicable continuing education
27 requirements, shall be licensed as a licensed clinical professional
28 counselor by providing demonstration of competence to diagnose and treat
29 mental disorders through at least two of the following areas acceptable to
30 the board:

31 (A) Either: (i) Graduate coursework; or (ii) passing a national,
32 clinical examination;

33 (B) either: (i) Three years of clinical practice in a community mental
34 health center, its contracted affiliate or a state mental hospital; or (ii) three
35 years of clinical practice in other settings with demonstrated experience in
36 diagnosing or treating mental disorders; or

37 (C) attestation from one professional licensed to diagnose and treat
38 mental disorders in independent practice or licensed to practice medicine
39 and surgery that the applicant is competent to diagnose and treat mental
40 disorders.

41 (3) A licensed clinical professional counselor may engage in the
42 independent practice of professional counseling and is authorized to
43 diagnose and treat mental disorders specified in the edition of the

1 diagnostic and statistical manual of mental disorders of the American
2 psychiatric association designated by the board by rules and regulations.
3 When a client has symptoms of a mental disorder, a licensed clinical
4 professional counselor shall consult with the client's primary care
5 physician or psychiatrist to determine if there may be a medical condition
6 or medication that may be causing or contributing to the client's symptoms
7 of a mental disorder. A client may request in writing that such consultation
8 be waived and such request shall be made a part of the client's record. A
9 licensed clinical professional counselor may continue to evaluate and treat
10 the client until such time that the medical consultation is obtained or
11 waived.

12 (4) A licensed professional counselor may diagnose and treat mental
13 disorders specified in the edition of the diagnostic and statistical manual of
14 mental disorders of the American psychiatric association designated by the
15 board by rules and regulations only under the direction of a licensed
16 clinical professional counselor, licensed psychologist, person licensed to
17 practice medicine and surgery or person licensed to provide mental health
18 services as an independent practitioner and whose licensure allows for the
19 diagnosis and treatment of mental disorders. When a client has symptoms
20 of a mental disorder, a licensed professional counselor shall consult with
21 the client's primary care physician or psychiatrist to determine if there may
22 be a medical condition or medication that may be causing or contributing
23 to the client's symptoms of a mental disorder. A client may request in
24 writing that such consultation be waived and such request shall be made a
25 part of the client's record. A licensed professional counselor may continue
26 to evaluate and treat the client until such time that the medical consultation
27 is obtained or waived.

28 (d) The board shall adopt rules and regulations establishing the
29 criteria that a college or university shall satisfy in order to be approved by
30 the board. The board may send a questionnaire developed by the board to
31 any college or university for which the board does not have sufficient
32 information to determine whether the school meets the requirements for
33 approval and rules and regulations adopted under this section. The
34 questionnaire providing the necessary information shall be completed and
35 returned to the board in order for the college or university to be considered
36 for approval. The board may contract with investigative agencies,
37 commissions or consultants to assist the board in obtaining information
38 about colleges and universities. In entering such contracts, the authority to
39 approve college and universities shall remain solely with the board.

40 (e) A person who is waiting to take the examination required by the
41 board may apply to the board for a temporary *professional counselor*
42 license to practice as a licensed professional counselor by:

43 (1) Paying an application fee of not more than \$150; and

1 (2) meeting the application requirements as stated in K.S.A. 65-
2 5804a(b)(1), (2) and (4), and amendments thereto.

3 (f) (1) A temporary *professional counselor* license may be issued by
4 the board after the application has been reviewed and approved by the
5 board and the applicant has paid the appropriate fee set by the board for
6 issuance of a temporary license.

7 (2) Absent extenuating circumstances approved by the board, a
8 temporary *professional counselor* license issued by the board shall expire
9 upon the date the board issues or denies a license to practice professional
10 counseling or ~~12~~ 24 months after the date of issuance of the temporary
11 license. No temporary license will be renewed or issued again on any
12 subsequent application for the same license level. The preceding
13 provisions in no way limit the number of times an applicant may take the
14 examination.

15 (g) A person practicing professional counseling with a temporary
16 *professional counselor* license may not use the title "licensed professional
17 counselor" or the initials "LPC" independently. The word "licensed" may
18 be used only when followed by the words "by temporary license," such as
19 licensed professional counselor by temporary license, or professional
20 counselor licensed by temporary license.

21 (h) No person may practice professional counseling under a
22 temporary *professional counselor* license except under the supervision of a
23 person licensed by the behavioral sciences regulatory board at the
24 independent level.

25 (i) Nothing in this section shall affect any temporary license to
26 practice issued under this section prior to the effective date of this act and
27 in effect on the effective date of this act. Such temporary license shall be
28 subject to the provisions of this section in effect at the time of its issuance
29 and shall continue to be effective until the date of expiration of the
30 temporary license provided under this section at the time of issuance of
31 such temporary license.

32 **(j) (1) An individual may apply to the board for a community-**
33 **based professional counselor license to practice professional**
34 **counseling in the scope of employment by a community mental health**
35 **center, as defined in K.S.A. 39-2002, and amendments thereto.**

36 **(2) A community-based professional counselor license may be**
37 **issued by the board after the board reviews and approves the**
38 **application and the applicant has paid the fee set by the board for**
39 **issuance of a community-based professional counselor license.**

40 **(3) (A) Absent extenuating circumstances approved by the board,**
41 **a community-based professional counselor license issued by the board**
42 **shall expire:**

43 **(i) Upon the date the board issues or denies a license to practice**

1 professional counseling; or

2 (ii) 24 months after the date of issuance of the community-based
3 professional counselor license.

4 (B) No community-based professional counselor license shall be
5 renewed or issued again on any subsequent application for the same
6 license level. This paragraph shall not be construed to limit the
7 number of times an applicant may take the examination.

8 (4) A person practicing professional counseling with a
9 community-based professional counselor license may use the title
10 "licensed professional counselor" or the initials "LPC" independently.

11 (5) No person may practice professional counseling under a
12 community-based professional counselor license except under the
13 supervision of a person licensed by the board to practice at the
14 independent level.

15 Sec. 4. K.S.A. 65-5806 is hereby amended to read as follows: 65-
16 5806. (a) An applicant who meets the requirements for licensure pursuant
17 to ~~this the professional counselors licensure act~~, has paid the license fee
18 provided for by K.S.A. 65-5808, and amendments thereto, and has
19 otherwise complied with the provisions of this act shall be licensed by the
20 board.

21 (b) Licenses issued pursuant to this act shall expire 24 months from
22 the date of issuance unless revoked prior to that time. A license may be
23 renewed upon application and payment of the fee provided for by K.S.A.
24 65-5808, and amendments thereto. The application for renewal shall be
25 accompanied by evidence satisfactory to the board that the applicant has
26 completed during the previous 24 months the continuing education
27 required by rules and regulations of the board. *Prior to July 1, 2025*, as
28 part of such continuing education, a licensee shall complete not less than
29 six continuing education hours relating to diagnosis and treatment of
30 mental disorders and not less than three continuing education hours of
31 professional ethics. *On and after July 1, 2025, as part of such continuing*
32 *education, a licensee shall complete not less than three continuing*
33 *education hours relating to diagnosis and treatment of mental disorders;*
34 **and not less than three continuing education hours of professional ethics**
35 ~~and not less than three continuing education hours in cultural diversity.~~
36 ~~Acceptable continuing education hours in cultural diversity shall include;~~
37 ~~but not be limited to, professional development regarding age, disability;~~
38 ~~ethnicity, gender, gender identity, language, national origin, race, religion;~~
39 ~~cultural, sexual orientation and socioeconomic status.~~

40 (c) (1) A licensee who is unable to complete the required continuing
41 education hours for renewal may request additional time to complete any
42 remaining continuing education hours. Such request shall be made to the
43 board not later than 30 calendar days prior to the expiration of the license

1 *and shall include:*

2 (A) *The licensee's reason for requesting additional time, showing*
3 *extenuating circumstances for why the hours could not be completed*
4 *during the license period; and*

5 (B) *a plan outlining the manner in which the licensee intends to*
6 *complete the remaining continuing education hours.*

7 (2) *The board may grant a licensee up to three additional months*
8 *beyond the license expiration date to complete the required continuing*
9 *education hours.*

10 (3) *A licensee who receives additional time to complete continuing*
11 *education hours under this subsection shall:*

12 (A) *Renew the license prior to the license expiration date and report*
13 *to the board the number of continuing education hours completed on such*
14 *date;*

15 (B) *notify the board upon completing the remaining continuing*
16 *education hours; and*

17 (C) *be subject to an audit by the board of the total number of*
18 *continuing education hours completed for the applicable license period.*

19 (4) *Continuing education hours completed during additional time*
20 *granted under this subsection shall be credited only toward the*
21 *requirements for the license period for which additional time is granted.*

22 (5) *A licensee shall not be approved for additional time to complete*
23 *continuing education requirements in consecutive license periods.*

24 (d) *A person whose license has been suspended or revoked may make*
25 *written application to the board requesting reinstatement of the license*
26 *upon termination of the period of suspension or revocation in a manner*
27 *prescribed by the board, which and such application shall be accompanied*
28 *by the fee provided for by K.S.A. 65-5808, and amendments thereto.*

29 (e) (1) *A person whose license has expired may make written*
30 *application to the board requesting reinstatement of the license in a*
31 *manner prescribed by the board, and such application shall be*
32 *accompanied by:*

33 (A) *The renewal fee established under K.S.A. 65-5808, and*
34 *amendments thereto, and, for any person whose license has been expired*
35 *for one year or less, an additional fee equal to the renewal fee; and*

36 (B) *evidence satisfactory to the board that the person has completed*
37 *during the previous 24 months the continuing education requirements for*
38 *one license period.*

39 (2) *A person requesting to reinstate a license that has been expired*
40 *for longer than one year who has not completed the necessary continuing*
41 *education hours for reinstatement may submit an application for a six-*
42 *month reinstatement temporary license in a manner prescribed by the*
43 *board, and such application shall be accompanied by the fee as provided*

1 by K.S.A. 65-5808, and amendments thereto. A licensee practicing under a
2 six-month reinstatement temporary license shall complete the continuing
3 education requirements required for a permanent license prior to the
4 expiration of the temporary license and notify the board upon such
5 completion. A six-month reinstatement temporary license shall not be
6 extended or renewed.

7 (d)(f) Within 30 days after any change of permanent address, a
8 licensee shall notify the board of such change.

9 Sec. 5. K.S.A. 2022 Supp. 65-5807 is hereby amended to read as
10 follows: 65-5807. (a) The board may issue a license to an individual who
11 is currently registered, certified or licensed to practice professional
12 counseling in another jurisdiction if the board determines that:

13 (1) The standards for registration, certification or licensure to practice
14 professional counseling in the other jurisdiction are substantially
15 equivalent to the requirements of this state; or

16 (2) the applicant demonstrates on forms provided by the board
17 compliance with the following standards as adopted by the board:

18 (A) Registration, certification or licensure to practice professional
19 counseling *with a similar scope of practice* for at least ~~48 of the last 54~~ 12
20 months immediately preceding the application ~~with at least the minimum~~
21 ~~professional experience as established by rules and regulations of the~~
22 ~~board;~~

23 (B) the absence of disciplinary actions of a serious nature brought by
24 a registration, certification or licensing board or agency; and

25 (C) at least a master's degree in counseling or a related field from a
26 regionally accredited university or college.

27 (b) Applicants for licensure as a clinical professional counselor shall
28 additionally demonstrate competence to diagnose and treat mental
29 disorders through meeting the requirements of either subsection (a)(1) or
30 (a)(2) and at least two of the following areas acceptable to the board:

31 (1) Either graduate coursework as established by rules and
32 regulations of the board or passing a national clinical examination
33 approved by the board;
