25 *Be it enacted by the Legislature of the State of Kansas:*

26 New Section 1. (a) No member of the state military forces may be
27 placed in confinement in immediate association with enemy prisoners,
28 both foreign and domestic, or other foreign nationals who are not members
29 of the armed forces.

30 New Sec. 2. (a) A person punished under K.S.A. 48-2301, and
31 amendments thereto, by a company-grade commanding officer who
32 considers the findings unsupported by the evidence or the punishment
33 unjust or disproportionate to the offense can demand from the
34 commanding officer a de novo review of the findings and punishment.

1 (1) Upon such demand, any punishment shall be stayed and the
 2 hearing record, evidence and supporting documents under K.S.A. 48-2301,
 3 and amendments thereto, shall be forwarded to the next superior field-
 4 grade commander.

5 (2) Upon receipt of such evidence, the next superior commander shall
 6 obtain a written legal review of the matter and, after providing the accused
 7 an opportunity to be heard, make a written decision on:

8 (A) Whether to uphold or reverse any finding of guilt; and

9 (B) whether to uphold, mitigate or reduce any punishment.

10 (b) A person punished under K.S.A. 48-2301, and amendments
 11 thereto, by a field-grade commanding officer, or an officer of a general or
 12 flag rank in command who considers the punishment unjust or
 13 disproportionate to the offense can, through the proper channel, appeal to
 14 the next superior commander within 10 days of being informed about the
 15 punishment.

16 (1) The appeal shall be promptly forwarded and decided, but the
 17 person punished may be required to undergo the punishment. The superior
 18 commander may exercise the same powers with respect to the punishment
 19 imposed in K.S.A. 48-2301(f), and amendments thereto.

20 (2) Before acting on an appeal, the superior commander in charge of
 21 the appeal must give the accused the opportunity to be heard and can refer
 22 the case to a judge advocate for consideration and advice. The manner in
 23 which the opportunity to be heard is exercised at the sole discretion of the
 24 superior commander.

25 **(c) A person punished under K.S.A. 48-2201, and amendments**
 26 **thereto, is entitled to one appeal but is not entitled to any appeal under**
 27 **this section.**

28 New Sec. 3. (a) The imposition and enforcement of disciplinary
 29 punishment under K.S.A. 48-2301, and amendments thereto, for any act or
 30 omission does not bar a trial by a civilian court of competent jurisdiction
 31 for a serious crime or offense related to the same act or omission and not
 32 properly punishable under this code.

33 (b) The enforcement of a disciplinary punishment may be shown by
 34 the accused during trial proceedings and, when shown, shall be considered
 35 in the determination of punishment if the accused is found guilty.

36 New Sec. 4. (a) Any person subject to this code shall be punished at
 37 the direction of a commanding officer if such person is:

38 (1) ~~An officer or noncommissioned officer;~~

39 ~~(2) In a training leadership position with respect to a specially~~
 40 ~~protected junior member of the armed forces; and~~

41 ~~(3) engaging~~ **(2) engages** in prohibited sexual activity with such
 42 specially protected junior member of the armed forces.

43 (b) Any person subject to this code shall be punished at the direction

1 of a commanding officer if they are:

2 (1) A military recruiter and engage in prohibited sexual activity with
3 an applicant for military service;

4 (2) a military recruiter and engage in prohibited sexual activity with a
5 specially protected **junior** member of the armed forces who is enlisted
6 under a delayed entry program; or

7 (3) a military cadre and engages in prohibited sexual activity with a
8 specially protected junior member of the armed forces who is enlisted
9 under a delayed entry program.

10 (c) Consent is not a defense for any conduct listed in this section.

11 (d) As used in this section:

12 (1) "Applicant for military service" means a person who, under
13 regulations prescribed by the secretary of the military department
14 concerned, is an applicant for original enlistment or appointment in the
15 United States armed forces or state military forces.

16 (2) "Military recruiter" means a person who, under regulations
17 prescribed by the secretary of the military department concerned, ~~is an~~
18 ~~applicant for original enlistment or appointment in the United States armed~~
19 ~~forces or state military forces~~ **has the primary duty to recruit persons**
20 **for military service.**

21 (3) "Prohibited sexual activity" means, as specified in military
22 regulations, inappropriate physical intimacy under circumstances
23 described in such regulations.

24 (4) "Specially protected junior member of the armed forces" means:

25 (A) A member of the armed forces or state military forces who is
26 assigned to, or is awaiting assignment to, basic training or other initial
27 active duty for training, including a member who is enlisted under a
28 delayed entry program;

29 (B) a member of the armed forces or state military forces who is a
30 cadet, midshipmen, an officer candidate or a student in any other officer
31 qualification program; and

32 (C) a member of the armed forces or state military forces in any
33 program that, by regulation prescribed by the secretary of the military
34 department concerned, is identified as a training program for initial career
35 qualification.

36 (5) "Training leadership position" means any person subject to this
37 code that is assigned or attached to a unit whose primary purpose is the
38 recruitment of members into the United States armed forces or state
39 military forces or who serve as faculty, staff, drill instructor or in other
40 leadership position in:

41 (A) A basic training program;

42 (B) a training program for entry into the United States armed forces
43 or state military forces;

- 1 (C) a reserve officers' training unit;
- 2 (D) an officers' candidate school; or
- 3 (E) any program that is identified as a training program or initial
- 4 career qualification.

5 New Sec. 5. Any person subject to this code shall **be guilty of the**
6 **offense of sexual harassment and shall** be punished at the direction of a
7 commanding officer if such ~~person~~ **person's conduct meets the following**
8 **elements:**

9 (a) ~~Repeatedly engages in behavior that involves unwelcome sexual~~
10 ~~advances;~~

11 (b) ~~requests sexual favors from or offers sexual favors to a~~
12 ~~subordinate; or~~

13 (c) ~~engages in other verbal or physical conduct of a sexual nature,~~
14 ~~if~~ **Such person made sexual advances, demands or requests for sexual**
15 **favors or knowingly engaged in other conduct of a sexual nature;**

16 (b) **such conduct was unwelcome; and**

17 (c) **under the circumstances, such conduct:**

18 (1) **Would cause a reasonable person to believe, and such person**
19 **did believe, that** submission to ~~or rejection of~~ such conduct ~~is~~ **would be**
20 **made, either explicitly or implicitly, a term or condition of a person's job,**
21 **pay, career, benefits or entitlements;**

22 (2) **would cause a reasonable person to believe, and such person**
23 **did believe, that** submission to or rejection of such conduct by a person is
24 used as a basis for career or employment decisions ~~against such person~~
25 **affecting such person's job, pay, career, benefits or entitlements; or**

26 (3) ~~the conduct has the purpose or effect of unreasonably interfering~~
27 ~~with a person's work performance or creates an intimidating, hostile or~~
28 ~~offensive working environment~~ **was so severe, repetitive or pervasive**
29 **that a reasonable person would perceive, and such person did**
30 **perceive, an intimidating, hostile or offensive work environment.**

31 New Sec. 6. (a) Any sentinel or lookout who is drunk, sleeps or
32 leaves while on post before being regularly relieved shall be punished at
33 the direction of a commanding officer.

34 (b) Any sentinel or lookout who loiters or wrongfully sits down on
35 post shall be punished at the direction of a commanding officer.

36 New Sec. 7. (a) Any person subject to this code who, knowing that
37 another person is a sentinel or lookout, uses wrongful and disrespectful
38 language that is directed toward and within the hearing of the sentinel or
39 lookout, who is in execution of duties as a sentinel or lookout, shall be
40 punished at the direction of a commanding officer.

41 (b) Any person subject to this code who, knowing that another person
42 is a sentinel or lookout, behaves in a wrongful and disrespectful manner
43 that is directed toward and within the sight of the sentinel or lookout, who

1 is in execution of duties as a sentinel or lookout, shall be punished at the
2 direction of a commanding officer.

3 New Sec. 8. Any person subject to this code shall be punished at the
4 direction of a commanding officer if such person willfully:

5 (a) Alters, conceals, removes, mutilates, obliterates or destroys a
6 public record; or

7 (b) takes a public record with the intent to alter, conceal, remove,
8 mutilate, obliterate or destroy such public record.

9 New Sec. 9. Any person subject to this code shall be punished at the
10 direction of a commanding officer if such person intentionally:

11 (a) Falsely makes or alters any signature or any part of any writing
12 that would, if genuine, impose a legal liability on another or change their
13 legal rights or liability; or

14 (b) utters, offers, issues or transfers such writing, known by the
15 person to be so made or altered.

16 New Sec. 10. (a) Any person subject to this code shall be punished at
17 the direction of a commanding officer if such person willfully
18 impersonates:

19 (1) An officer, noncommissioned officer or petty officer;

20 (2) an agent of superior authority of one of the armed forces or state
21 military forces; or

22 (3) a government official.

23 (b) Any person subject to this code shall be punished at the direction
24 of a commanding officer if such person, with intent to defraud,
25 impersonates any person referred to in subsection (a).

26 (c) Any person subject to this code shall be punished at the direction
27 of a commanding officer if such person, without intent to defraud,
28 impersonates a government official by committing an act that exercises or
29 asserts the authority of the office of the official being impersonated.

30 New Sec. 11. Any person subject to this code shall be punished at the
31 direction of a commanding officer if such person:

32 (a) Is not authorized to wear an insignia, decoration, badge, ribbon,
33 device or lapel button; and

34 (b) wrongfully wears such insignia, decoration, badge, ribbon, device
35 or lapel button upon the person's uniforms or civilian clothing.

36 New Sec. 12. (a) Any person subject to this code shall be punished at
37 the direction of a commanding officer if such person wrongfully takes any
38 mail before such mail is delivered to or received by the addressee, with the
39 intent to obstruct the correspondence, or to pry into the business secrets of
40 any person or organization.

41 (b) Any person subject to this code shall be punished at the direction
42 of a commanding officer if they wrongfully open, destroy or steal mail
43 before such mail is delivered to or received by the addressee.

1 New Sec. 13. (a) Any person subject to this code shall be punished at
2 the direction of a commanding officer if such person:

3 (1) Is the driver of a vehicle that is involved in an accident that results
4 in a personal injury or property damage; and

5 (2) wrongfully leaves the scene of the accident without providing:

6 (A) Assistance to an injured person; or

7 (B) personal identification to others involved in the accident or to
8 appropriate authorities.

9 (b) Any person subject to this code shall be punished at the direction
10 of a commanding officer if such person:

11 (1) Is a passenger in a vehicle that is involved in an accident that
12 results in personal injury or property damage;

13 (2) is the superior commissioned or noncommissioned officer of the
14 driver or commander of the vehicle; and

15 (3) wrongfully and unlawfully orders, causes or permits the driver to
16 leave the scene of the accident without providing:

17 (A) Assistance to an injured person; or

18 (B) personal identification to others involved in the accident or to
19 appropriate authorities.

20 New Sec. 14. Any person subject to this code shall be punished at the
21 direction of a commanding officer if such person willfully and wrongfully:

22 (a) Discharges or brandishes a firearm under any circumstances that
23 endanger a human life; or

24 (b) causes a reasonable person to be apprehensive of the potential
25 endangerment of human life.

26 New Sec. 15. (a) Any person subject to this code shall be guilty of
27 simple assault and shall be punished at the direction of a commanding
28 officer if such person:

29 ~~(a)~~(1) Attempts to do bodily harm to another person;

30 ~~(b)~~(2) offers to do bodily harm to another person; or

31 ~~(c)~~(3) does bodily harm to another person.

32 (b) **As used in this section, "another person" means a member,
33 cadet, trainee or recruit of the state military forces, the United States
34 armed forces or the state military forces of another state.**

35 New Sec. 16. (a) Any person subject to this code shall be punished at
36 the direction of a commanding officer if such person **commits a violent
37 offense against a spouse, intimate partner or immediate family
38 member of such person.**

39 (b) **Any person subject to this code shall be punished at the
40 direction of a commanding officer if such person, with the intent to
41 threaten or intimidate a spouse, intimate partner or immediate family
42 member of such person, commits an offense under this code against:**

43 (1) ~~Commits a violent offense against a spouse, an intimate partner or~~

1 ~~an immediate family member with the intent to threaten or intimidate~~Any
 2 ~~person;~~ or

3 (2) ~~commits a violent offense against any property, including animals.~~

4 ~~(b)(c)~~ Any person subject to this code shall be punished at the
 5 direction of a commanding officer if such person, **with the intent to**
 6 **threaten or intimidate a spouse, intimate partner or immediate family**
 7 **member of such person,** violates a protection order.

8 ~~(e)(d)~~ Any person subject to this code shall be punished at the
 9 direction of a commanding officer if such person ~~assaults a spouse, an~~
 10 ~~intimate partner or an immediate family member by strangling or~~
 11 ~~suffocating,~~ **with the intent to commit a violent offense against a**
 12 **spouse, intimate partner or immediate family member of such person,**
 13 **violates a protection order.**

14 New Sec. 17. (a) Any person subject to this code shall be punished at
 15 the direction of a commanding officer if such person communicates a
 16 threat to injure the person, property or reputation of another.

17 (b) Any person subject to this code shall be punished at the direction
 18 of a commanding officer if such person communicates a threat to injure the
 19 person or property of another by use of:

20 (1) An explosive;

21 (2) a weapon of mass destruction;

22 (3) a biological or chemical agent, substance or weapon; or

23 (4) a hazardous material.

24 (c) Any person subject to this code shall be punished at the direction
 25 of a commanding officer if such person maliciously communicates a false
 26 threat concerning the person or property of another by use of:

27 (1) An explosive;

28 (2) a weapon of mass destruction;

29 (3) a biological or chemical agent, substance or weapon; or

30 (4) a hazardous material.

31 (d) As used in this section, "false threat" means a threat that, at the
 32 time it is communicated, is known to be untrue by the person
 33 communicating the threat.

34 New Sec. 18. (a) Any person subject to this code is guilty of wrongful
 35 distribution of intimate visual images or visual images of sexually explicit
 36 conduct and shall be punished at the direction of a commanding officer if
 37 such person:

38 (1) Knowingly and wrongfully broadcasts or distributes an intimate
 39 visual image of another person or a visual image of sexually explicit
 40 conduct involving a person who:

41 (A) Is at least 18 years of age at the time the intimate visual image or
 42 visual image of sexually explicit conduct was created;

43 (B) is identifiable from the intimate visual image or visual image of

1 sexually explicit conduct or from information displayed in connection with
2 the intimate visual image or visual image of sexually explicit conduct; and

3 (C) does not explicitly consent to the broadcast or distribution of the
4 intimate visual image or visual image of sexually explicit conduct;

5 (2) knows or reasonably should have known that the intimate visual
6 image or visual image of sexually explicit conduct was made under
7 circumstances in which the person depicted in the intimate visual image or
8 visual image of sexually explicit conduct retained a reasonable expectation
9 of privacy regarding any broadcast or distribution of the intimate visual
10 image or visual image of sexually explicit conduct;

11 (3) knows or reasonably should have known that the broadcast or
12 distribution of the intimate visual image or visual image of sexually
13 explicit conduct is likely to:

14 (A) Cause harm, harassment, intimidation, emotional distress or
15 financial loss for the person depicted in the intimate visual image or visual
16 image of sexually explicit conduct; or

17 (B) harm substantially the depicted person with respect to that
18 person's health, safety, business, calling, career, financial condition,
19 reputation or personal relations; or

20 (4) engaged in conduct that had a reasonably direct connection to a
21 military mission or military environment.

22 (b) As used in this section:

23 (1) "Broadcast" means to electronically transmit a visual image with
24 the intent that it be viewed by a person or persons.

25 (2) "Distribute" means to deliver to the actual or constructive
26 possession of another person, including transmission by mail or electronic
27 means.

28 (3) "Intimate visual image" means a visual image that depicts the
29 ~~naked or underwear-clad genitalia, anus, buttocks or female areola or~~
30 ~~nipple~~ **private area of a person.**

31 (4) "Private area" means the naked or underwear-clad genitalia, anus,
32 buttocks or female areola or nipple.

33 (5) "Reasonable expectation of privacy" means circumstances in
34 which a reasonable person would believe that a private area of the person,
35 or sexually explicit conduct involving that person, would not be visible to
36 the public.

37 (6) "Sexually explicit conduct" means actual or simulated genital-to-
38 genital contact, oral-to-genital contact, anal-to-genital contact or oral-to-
39 anal contact, whether between persons of the same or opposite sex,
40 bestiality, masturbation or sadistic or masochistic abuse.

41 (7) "Visual image" means:

42 (A) Any developed or undeveloped photograph, picture, film or
43 video;

1 (B) any digital or computerized image, picture, film or video made by
2 any means, including those transmitted by any means, including streaming
3 media not stored in a permanent format; or

4 (C) any digital or electronic data capable of conversion into a visual
5 image.

6 New Sec. 19. (a) Any person subject to this code shall, if the
7 conditions in subsection (b) are satisfied, be punished at the direction of a
8 commanding officer if such person induces another person to:

9 (1) Take an oath; and

10 (2) falsely testify, depose or make a statement upon such oath.

11 (b) The conditions referred to in subsection (a) are the following:

12 (1) The oath is administered regarding a matter for which such oath is
13 required or authorized by law.

14 (2) The oath is administered by a person that has the authority to do
15 so.

16 (3) Upon making such oath, the other person willfully makes or
17 attests to a statement.

18 (4) The statement is material to the proceedings.

19 (5) The statement is false.

20 (6) When the statement is made or attested to, the person subject to
21 this code and the person induced into such conduct do not believe such
22 statement is true.

23 New Sec. 20. Any person subject to this code shall be punished at the
24 direction of a commanding officer if such person engages in conduct
25 intending to influence, impede or otherwise obstruct the due
26 administration of justice.

27 New Sec. 21. Any person subject to this code shall be punished at the
28 direction of a commanding officer if such person:

29 (a) Knows another person has committed a serious offense; and

30 (b) wrongfully conceals the commission of the offense and fails to
31 make the commission of the offense known to civilian or military
32 authorities as soon as possible.

33 New Sec. 22. Any person subject to this code shall be punished at the
34 direction of a commanding officer if such person, in the presence of a
35 court-martial, a board of officers, a military commission, a court of
36 inquiry, a preliminary hearing or an officer taking a deposition for the state
37 of Kansas or the United States, wrongfully refuses to qualify as a witness
38 or to answer a question after having been directed to do so by the presiding
39 authority.

40 New Sec. 23. Any person subject to this code shall be punished at the
41 direction of a commanding officer if such person knows that one or more
42 persons authorized to make searches and seizures are seizing, about to
43 seize or are endeavoring to seize property then destroy, remove or

1 otherwise dispose of the property with the intent to prevent the seizure of
2 such property.

3 New Sec. 24. Any person subject to this code shall be punished at the
4 direction of a commanding officer if such person has reason to believe that
5 an adverse administrative action is pending against any person subject to
6 this code and:

7 (a) Intentionally acts to influence, impede or obstruct the conduct of
8 the proceeding; or

9 (b) acts to obstruct the due administration of justice.

10 New Sec. 25. (a) Any person subject to this code shall be punished at
11 the direction of a commanding officer if such person:

12 ~~(a)(1)~~ Occupies an official position or has official duties; and

13 ~~(b)(2)~~ wrongfully asks for, accepts or receives something of value
14 with the intent to have the person's decision or action influenced regarding
15 an official matter in which the state of Kansas or the United States is
16 interested.

17 **(b) Any person subject to this code shall be punished at the**
18 **direction of a commanding officer if such person:**

19 **(1) Wrongfully promises, offers or gives something of value to a**
20 **person who occupies an official position or has official duties; and**

21 **(2) intends to influence the decisions or actions of the person**
22 **regarding an official matter in which the state of Kansas or the United**
23 **States is interested.**

24 New Sec. 26. (a) Any person subject to this code shall be punished at
25 the direction of a commanding officer if such person:

26 ~~(a)(1)~~ Occupies an official position or has official duties; and

27 ~~(b)(2)~~ wrongfully asks for, accepts or receives something of value as
28 compensation for or in recognition of services rendered or to be rendered
29 by the person regarding an official matter in which the state of Kansas or
30 the United States is interested.

31 **(b) Any person subject to this code shall be punished at the**
32 **direction of a commanding officer if such person promises, offers or**
33 **gives something of value to a person who occupies an official position**
34 **or who has official duties as compensation for or in recognition of**
35 **services rendered by such person regarding an official matter in which**
36 **the state of Kansas or the United States is interested.**

37 New Sec. 27. (a) Any person subject to this code shall be punished at
38 the direction of a commanding officer if such person, with the knowing
39 intent to defraud and obtain money, property, services or something of
40 value, uses:

41 (1) A stolen credit card, debit card or other access device;

42 (2) a revoked, canceled or otherwise invalid credit card, debit card or
43 other access device; or

1 (3) a credit card, debit card or other access device without the
2 authorization of a person whose authorization is required for such use.

3 (b) As used in this section:

4 (1) "Access device" means the same as defined in 18 U.S.C. § 1029.

5 (2) "Credit card" and "debit card" mean cards issued on behalf of the
6 United States government or the state of Kansas or because of the
7 member's service in the state military forces.

8 New Sec. 28. Any person subject to this code shall be guilty of
9 extortion and be punished at the direction of a commanding officer if such
10 person communicates threats to another person with the intention to obtain
11 something of value or any acquittance, advantage or immunity.

12 New Sec. 29. (a) Any person subject to this code shall be punished at
13 the direction of a commanding officer if such person, without legal
14 justification or lawful authorization:

15 (1) Knowingly and wrongfully views the private area of another
16 person without the other person's consent and when that other person has a
17 reasonable expectation of privacy;

18 (2) knowingly photographs, videotapes, films or records by any
19 means the private area of another person without that other person's
20 consent and when that other person has a reasonable expectation of
21 privacy; or

22 (3) knowingly broadcasts or distributes any such recording that the
23 person knew or reasonably should have known was made under the
24 circumstances prescribed in paragraphs (1) and (2).

25 (b) Any person subject to this code shall be punished at the direction
26 of a commanding officer and is guilty of forcible pandering if such person
27 compels another person to engage in an act of prostitution with any person.

28 (c) Any person subject to this code shall be punished at the direction
29 of a commanding officer and is guilty of indecent exposure if such person
30 intentionally exposes, in an indecent manner, the genitalia, anus, buttocks
31 or female areola or nipple.

32 (d) In this section:

33 (1) "Act of prostitution" means a sexual act or sexual contact as
