1 AN ACT concerning motor vehicles; relating to electric vehicles,
2 registration fees; amending K.S.A. 2013 Supp. 8-143 and repealing the
3 existing section.
4

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. K.S.A. 2013 Supp. 8-143 is hereby amended to read as
7 follows: 8-143. (a) All applications for the registration of motorcycles,
8 motorized bicycles and passenger vehicles other than trucks and truck
9 tractors, except as otherwise provided, shall be accompanied by an annual
10 license fee as follows:

11 (1) For motorized bicycles, \$11;
12 (2) for motorcycles, \$16;
13 (3) for passenger vehicles, other than motorcycles, used solely for the
14 carrying of persons for pleasure or business, and for hearses and
15 ambulances a fee of:

16 (A) For those having a gross weight of 4,500 pounds or less, \$30; and
17 (B) for those having a gross weight of more than 4,500 pounds, \$40;
18 (4) for each electrically propelled motor vehicle, except electrically
19 propelled vehicles intended for the purpose of transporting any
20 commodity, goods, merchandise, produce or freight, or passengers for hire,
21 a fee of ~~\$14~~ \$30.

22 (5) Except for motor vehicles, trailers or semitrailers registered under
23 the provisions of K.S.A. 8-1,134, and amendments thereto, the annual
24 registration fee for each motor vehicle, trailer or semitrailer owned by any
25 political or taxing subdivision of this state or by any agency or
26 instrumentality of any one or more political or taxing subdivisions of this
27 state and used exclusively for governmental purposes and not for any
28 private or utility purposes, which is not otherwise exempt from
29 registration, shall be \$2.

30 (b) (1) As used in this subsection, the term "gross weight" shall mean
31 and include the empty weight of the truck, or combination of the truck or
32 truck tractor and any type trailer or semitrailer, plus the maximum weight
33 of cargo which will be transported on or with the same, except when the
34 empty weight of a truck plus the maximum weight of cargo which will be
35 transported thereon is 12,000 pounds or less. The term gross weight shall
36 not include: The weight of any travel trailer propelled thereby which is

1 being used for private recreational purposes; or the weight of any vehicle
 2 or combination of vehicles for which wrecker or towing service, as defined
 3 in K.S.A. 66-1329, and amendments thereto, is to be provided by a
 4 wrecker or tow truck, as defined in K.S.A. 66-1329, and amendments
 5 thereto. Such wrecker or tow truck shall be registered for the empty weight
 6 of such vehicle fully equipped for the recovery or towing of vehicles. The
 7 gross weight license fees hereinafter prescribed shall only apply to the
 8 truck or truck tractor used as the propelling unit for the cargo and vehicle
 9 propelled, either as a single vehicle or combination of vehicles. On
 10 application for the registration of a truck or truck tractor, the owner thereof
 11 shall declare as a part of such application the maximum gross weight the
 12 owner desires to be applicable to such vehicle, which declared gross
 13 weight in no event shall be in excess of the limitations described by K.S.A.
 14 8-1908 and 8-1909, and amendments thereto, for such vehicle or
 15 combination of vehicles of which it will be a part. All applications for the
 16 registration of trucks or truck tractors, except as otherwise provided
 17 herein, shall be accompanied by an annual license fee as follows:

 29 (2) If the applicant for registration of any truck or truck tractor for a
 30 gross weight of more than 12,000 pounds is the state of Kansas or any
 31 political or taxing subdivision or agency of the state, except a city or
 32 county, whose truck or truck tractor is not otherwise entitled to the \$2
 33 license fee or otherwise exempt from all fees, such vehicle may be
 34 licensed for a fee in accordance with the schedule hereinafter prescribed
 35 for local trucks or truck tractors.

36 (3) If the applicant for registration of any truck or truck tractor for a
 37 gross weight of more than 12,000 pounds shall under oath state in writing
 38 on a form prescribed and furnished by the director of vehicles that the
 39 applicant does not expect to operate it more than 6,000 miles in the
 40 calendar year for which the applicant seeks registration, and that if the
 41 applicant shall operate it more than 6,000 miles during such registration
 42 year such applicant will pay an additional fee equal to the fee required by
 43 the schedule under paragraph (1), less the amount of the fee paid at time of

1 registration, such vehicle may be licensed for a fee in accordance with the
 2 schedule prescribed for local trucks or truck tractors. Whenever a truck or
 3 truck tractor is registered on a local truck or truck tractor fee basis a tab or
 4 marker shall be issued in connection with the regular license plate, which
 5 tab or marker shall be attached or affixed to and displayed with the regular
 6 license plate and the failure to have the same attached, affixed or displayed
 7 shall be subject to the same penalties as provided by law for the failure to
 8 display the regular license plate; and the secretary of revenue may adopt
 9 rules and regulations requiring the owners of trucks and truck tractors so
 10 registered on a local truck or truck tractor fee basis to keep such records
 11 and make such reports of mileage of such vehicles as the secretary of
 12 revenue shall deem proper.

13 (4) A transporter delivering vehicles not the transporter's own by the
 14 driveaway method where such vehicles are being driven, towed, or
 15 transported singly, or by the saddlemount, towbar, or fullmount methods,
 16 or by any lawful combination thereof, may apply for license plates which
 17 may be transferred from one such vehicle or combination to another for
 18 each delivery without further registration, and the annual license fee for
 19 such license plate shall be as follows:

33 (5) A truck or truck tractor registered for a gross weight of more than
 34 12,000 pounds, which is operated wholly within the corporate limits of a
 35 city or village or within a radius of 25 miles beyond the corporate limits,
 36 shall be classified as a local truck except that in no event shall such
 37 vehicles operated as contract or common carriers outside a radius of three
 38 miles beyond the corporate limits of the city or village in which such
 39 vehicles were based when registered and licensed be considered local
 40 trucks or truck tractors. The secretary of revenue is hereby authorized and
 41 directed to adopt rules and regulations prescribing a procedure for the
 42 issuance of permits by the division of vehicles whereby owners of local
 43 trucks or truck tractors may operate any such vehicle, empty, beyond the

1 radius hereinbefore prescribed, when such operation is solely for the
 2 purpose of having such vehicle repaired, painted or serviced or for adding
 3 additional equipment thereto. The annual license fee for a local truck or
 4 truck tractor, except as otherwise provided herein, shall be as follows:

 38 A vehicle licensed as a farm truck or truck tractor may be used by the
 39 owner thereof to transport, for charity and without compensation of any
 40 kind, commodities for religious or educational institutions. A truck which
 41 is licensed as a farm truck may also be used for the transportation of sand,
 42 gravel, slag stone, limestone, crushed stone, cinders, black top, dirt or fill
 43 material to a township road maintenance or construction site of the

1 township in which the owner of such truck resides. Any applicant for
 2 registration of any farm truck or farm truck tractor used in combination
 3 with a trailer or semitrailer shall register the farm truck or farm truck
 4 tractor for a gross weight which shall include the empty weight of the
 5 truck or truck tractor or of the combination of any truck or truck tractor
 6 and any type of trailer or semitrailer, plus the maximum weight of cargo
 7 which will be transported on or with the same. The applicant for
 8 registration of any farm truck or farm truck tractor used to transport a
 9 gross weight of more than 54,000 pounds shall durably letter on the side of
 10 the motor vehicle the words "farm vehicle—not for hire." If an applicant
 11 for registration of any farm truck or farm truck tractor operates such
 12 vehicle for any use or purpose not authorized for a farm truck or farm
 13 truck tractor, such applicant shall pay an additional fee equal to the fee
 14 required for the registration of all trucks or truck tractors not registered as
 15 local, 6,000-mile or farm truck or farm truck tractor motor vehicles, less
 16 the amount of the fee paid at time of registration. Nothing in this or the
 17 preceding paragraph shall authorize a gross weight of a vehicle or
 18 combination of vehicles on the national system of interstate and defense
 19 highways greater than permitted by laws of the United States congress.

20 (7) Except as hereinafter provided, the annual license fee for each
 21 local urban transit bus used in local urban transit operations exempted
 22 under the provisions of subsection (a) of K.S.A. 66-1,109, and
 23 amendments thereto, shall be based on the passenger seating capacity of
 24 the bus and shall be as follows:

41 The annual license fee for each local urban transit bus which is owned
 42 by a metropolitan transit authority established pursuant to articles 25 and
 43 28 of chapter 12 or pursuant to article 31 of chapter 13 of the Kansas

1 Statutes Annotated, *and amendments thereto*, shall be \$2.

2 (8) For licensing purposes, station wagons with a carrying capacity of
3 less than 10 passengers shall be subject to registration fees based on the
4 weight of the vehicles, as provided in subsection (a). Station wagons with
5 a carrying capacity of 10 or more passengers shall be subject to the truck
6 classifications and license fees as provided.

7 (9) For any trailer, semitrailer, travel trailer or pole trailer the annual
8 license fee shall be as follows:

9 (A) (i) Until January 1, 2013, for any such vehicle with a gross
10 weight of more than 12,000 pounds the annual fee shall be \$35;

11 (ii) On January 1, 2013, for any such vehicle with a gross weight of
12 more than 12,000 pounds but less than 54,000 pounds the annual fee shall
13 be \$45, on January 1, 2014, \$55;

14 (B) any such vehicle grossing more than 8,000 pounds but not over
15 12,000 pounds, the annual fee shall be \$25, on January 1, 2013, \$35, on
16 January 1, 2014, \$45;

17 (C) for any such vehicle grossing more than 2,000 pounds but not
18 over 8,000 pounds, the annual fee shall be \$15, on January 1, 2013, \$25,
19 on January 1, 2014, \$35.

20 Any such vehicle having a gross weight of 2,000 pounds or less may, at
21 the owner's option, be registered and the fee for such registration shall be
22 as provided in paragraph (C).

23 Any trailer, semitrailer or travel trailer owned by a nonresident of this
24 state and based in another state, which is properly registered and licensed
25 in the state of residence of the owner or in the state where based, may be
26 operated in this state without being registered or licensed in this state if the
27 truck or truck tractor propelling the same is properly registered and
28 licensed in this state, or is registered and licensed in some other state and
29 is entitled to reciprocal privileges of operation in this state, but this
30 provision shall not apply to any trailer or semitrailer owned by a
31 nonresident of this state when such trailer or semitrailer is owned by a
32 person who has proportionately registered and licensed a fleet of vehicles
33 under the provisions of K.S.A. 8-1,101 to 8-1,123, inclusive, and
34 amendments thereto, or under the terms of any reciprocal or proration
35 agreement made pursuant thereto.

36 At the option of the owner, any trailer, semitrailer or pole trailer, with a
37 gross weight of more than 12,000 pounds, may be issued a multi-year
38 registration for a five-year period upon payment of the appropriate
39 registration fee. The fee for a five-year registration of such trailer shall be
40 five times the annual fee for such trailer. If the annual registration fee is
41 increased during the multi-year registration period, the owner of the trailer
42 with such multi-year registration shall be subject to the amount of the
43 increase of the annual registration fee for the remaining calendar years of

1 such multi-year registration. When the owner of any trailer, semitrailer or
2 pole trailer registered under this multi-year provision transfers or assigns
3 the title, or interest thereto, the registration of such trailer shall expire. The
4 owner shall remove the license plate from such trailer and forward the
5 license plate to the division of vehicles or may have such license plate
6 assigned to another trailer, semitrailer or pole trailer upon the payment of
7 fees required by law. Any owner of a trailer, semitrailer or pole trailer
8 where the multi-year registration fee has been paid and the trailer is sold,
9 junked, repossessed, foreclosed by a mechanic's lien or title transferred by
10 operation of law, and the registration thereon is not going to be transferred
11 to another trailer, may secure a refund for the registration fee for the
12 remaining calendar years by making application to the division of vehicles
13 on a form and in the manner prescribed by the director of vehicles. The
14 secretary of revenue may adopt such rules and regulations necessary to
15 implement the multi-year registration of such trailers, semitrailers and pole
16 trailers.

17 (c) Any truck or truck tractor having a gross weight of 4,000 pounds
18 or over, using solid tires, shall pay a license fee of double the amount
19 herein charged. The annual fees herein provided for trucks, truck tractors
20 and trailers not subject to K.S.A. 8-134a, and amendments thereto, shall be
21 due January 1 of each year and payable on or before the last day of
22 February in each year. If the fee is not paid by such date a penalty of \$1
23 shall be added to the fee charged herein for each month or fraction thereof
24 and until December 31 of each registration year. The annual registration
25 fee for all passenger vehicles and vehicles subject to K.S.A. 8-134a, and
26 amendments thereto, shall be due on or before the last day of the month in
27 which the registration plate expires and shall be due for other vehicles as
28 provided by K.S.A. 8-134, and amendments thereto. If the registration fee
29 is not paid by such date a penalty of \$1 shall be added to the fee charged
30 herein for each month or fraction thereof until such registration fee is paid.
31 Members of the armed forces of the United States shall be permitted to
32 apply for registration at any time and be subject to registration fee, less
33 penalties, applicable at the time the application is made. If any motorcycle,
34 motorized bicycle, trailer, semitrailer, travel trailer, or pole trailer is either
35 purchased or acquired after the anniversary or renewal date in any
36 registration year there shall immediately become due and payable a
37 registration fee as follows: If purchased or acquired between the
38 anniversary or renewal date of any registration year and the first six
39 months of such registration year, the annual fee hereinbefore provided; if
40 purchased or acquired during the last six months of any registration year,
41 50% of such annual fee. If any truck or truck tractor, except trucks subject
42 to K.S.A. 8-134a, and amendments thereto, is purchased or acquired prior
43 to April 1 of any year the fee shall be the annual fee hereinbefore provided,

1 but if such truck or truck tractor is purchased or acquired after the end of
2 March of any year, the license fee for such year shall be reduced $\frac{1}{12}$ for
3 each calendar month which has elapsed since the beginning of the year. If
4 any truck registered for a gross weight of 12,000 pounds or less or
5 passenger vehicle is purchased or acquired and less than 12 months remain
6 in the registration period, the fee shall be $\frac{1}{12}$ of the annual fee for each
7 calendar month remaining in the registration period.

8 (d) The owner of any motorcycle, motorized bicycle, passenger
9 vehicle, truck, truck tractor, trailer, semitrailer, or electrically propelled
10 vehicle who fails to pay the registration fee or fees herein provided on the
11 date when the same become due and payable shall be guilty of a
12 misdemeanor, and upon conviction thereof shall be subject to a penalty in
13 the sum of \$1 for each month or fraction thereof during which such fee has
14 remained unpaid after it became due and payable; and in addition thereto
15 shall be subject to such other punishment as is provided in this act. Upon
16 the transfer of motorcycles, motorized bicycles, passenger vehicles,
17 trailers, semitrailers, trucks or truck tractors, on which registration fees
18 have been paid for the year in which the transfer is made, either: (1) To a
19 corporation by one or more persons, solely in exchange for stock or
20 securities in such corporation; or (2) by one corporation to another
21 corporation when all of the assets of such corporation are transferred to the
22 other corporation, then in either case (1) or case (2) the corporation shall
23 be exempt from the payment of registration fees on such vehicles for the
24 year in which such transfer is made. Applications for transfer or
25 registration shall be accompanied by a fee of \$1.50. When the registration
26 of a vehicle has expired at midnight on the last day of any registration
27 year, and such vehicle is not thereafter operated upon the highways, any
28 application for renewal of registration made subsequent to the anniversary
29 or renewal date of any registration year following the expiration of such
30 registration and for succeeding registration years in which such vehicle has
31 not been registered shall be accompanied by an affidavit of nonoperation
32 and nonuse, and such application for renewal or registration shall be
33 received by the division of vehicles upon payment of the proper fees for
34 the current registration year and without penalty.

35 (e) Any nonresident of Kansas purchasing a vehicle from a Kansas
36 resident and desiring to secure registration on the vehicle in the state of
37 such person's residence may make application in the office of any county
38 treasurer for a sixty-day temporary registration. The county treasurer upon
39 presentation of evidence of ownership in the applicant and evidence the
40 sales tax has been paid, if due, shall charge and collect a fee of \$3 for each
41 sixty-day temporary license and issue a sticker or paper registration as may
42 be determined by the director of vehicles, and the registration so issued
43 shall be valid for a period of 60 days from the date of issuance.

1 (f) Any owner of any motor vehicle which is subject to taxation under
2 the provisions of article 51 of chapter 79 of the Kansas Statutes Annotated,
3 *and amendments thereto*, or any other truck or truck tractor where the
4 annual registration fee has been paid and the vehicle is sold, junked,
5 repossessed, foreclosed by a mechanic's lien or title transferred by
6 operation of law, and the registration thereon is not going to be transferred
7 to another vehicle may secure a refund for the registration fee for the
8 remaining portion of the year by making application to the division of
9 vehicles on a form and in the manner prescribed by the director of
10 vehicles, accompanied by all license plates and attachments issued in
11 connection therewith. If the owner of the registration becomes deceased
12 and the vehicle is not going to be used on the highway, and title is not
13 being currently transferred, the proper representative of the estate shall be
14 entitled to the refund. The refund shall be made only for the period of time
15 remaining in the registration year from the date of completion and filing of
16 the application with and delivery of the license plate and attachments to
17 the division of vehicles. Where the registration is secured under a quarterly
18 payment annual registration fee, as provided for in K.S.A. 8-143a, and
19 amendments thereto, such refund shall be made on the quarterly fee paid
20 and unused and all remaining quarterly payments shall be canceled. Any
21 truck or truck tractor having the registration fee paid on quarterly payment
22 basis, all quarterly payments due or a fraction of quarterly payment due
23 shall be paid before title may be transferred, except that in case of death,
24 the filing of the application and returning of the license plate and
25 attachment shall cancel the remaining annual payments due. Whenever a
26 truck or truck tractor, where the registration is secured on a quarterly
27 payment of the annual registration, the one repossessing the truck or truck
28 tractor, or foreclosing by a mechanic's lien, or securing title by court order,
29 the mortgagor or the assigns of the mortgagor, or the one securing title
30 may pay the balance due on date of application for title, but the payments
31 for the remaining portion of the year shall not be canceled unless
32 application is made and the license plate and attachments are surrendered.
33 Nothing in this subsection shall apply when registration is secured under
34 the provisions of K.S.A. 8-1,101 to 8-1,123, inclusive, and amendments
35 thereto. Notwithstanding any of the foregoing provisions of this section,
36 no refund shall be made under the provisions of this section where the
37 amount thereof does not exceed \$5. The division of vehicles shall furnish
38 such blank forms as may be required under the provisions of this
39 subsection as it deems necessary to be completed by the applicant.
40 Whenever a registration which has been secured on a quarterly basis shall
41 be canceled as provided in this subsection, the division of vehicles shall
42 notify the county treasurer issuing the original registration of such
43 cancellation so that the county treasurer may, and the county treasurer shall

1 cancel the registration of such vehicle in the county treasurer's office and
2 release any lien issued in connection with such registration.

3 (g) Every owner of a travel trailer designed for or intended to be
4 moved upon any highway in this state shall, before the same is so moved,
5 apply for and obtain the proper registration thereof as provided in this act,
6 except when such unit is permitted to be moved under the special
7 provisions relating to secured parties, manufacturers, dealers and
8 nonresidents contained in this act. At the time of registering any travel
9 trailer for the purpose of moving any such vehicle upon any highway in
10 this state, the owner thereof shall indicate on the registration form whether
11 or not such vehicle is being moved permanently to a location outside of the
12 county in which such vehicle is being registered. No such vehicle which
13 the owner thereof intends to move to a permanent location outside the
14 boundaries of such county shall be registered for movement on the
15 highways of this state until all taxes levied against such vehicle have been
16 paid. A copy of such registration form shall be sent to the county clerk or
17 assessor of the county to which such vehicle is being moved. When such
18 travel trailer is used for living quarters and not operated on the highways,
19 the owner shall be exempt from the license fees as provided in subsection
20 (b)(9) so long as such travel trailer is not operated on the highway.
