1 AN ACT concerning motor vehicles; relating to antique vehicles; making
2 certain antique vehicle titling procedures applicable to vehicles having
3 a model year ~~of 1960 or later instead of 1950 or later~~ **newer than 50**
4 **years**; amending K.S.A. 2021 Supp. 8-170 and repealing the existing
5 section.

7 *Be it enacted by the Legislature of the State of Kansas:*

8 Section 1. K.S.A. 2021 Supp. 8-170 is hereby amended to read as
9 follows: 8-170. (a) Upon the transfer of ownership of any vehicle
10 registered under ~~the foregoing provisions of this act, its registration and~~
11 ~~right to use the license plates thereon on such vehicle shall expire and~~
12 ~~thereafter.~~ *Upon such transfer of ownership, there shall be no transfer of*
13 *any registration, and the license plates shall be removed by the owner*
14 *thereof and.* It shall be unlawful for any person other than the person to
15 whom such license plates were originally issued to have ~~the same such~~
16 *license plates* in possession. In *the* case of a transfer of ownership of a
17 registered vehicle the original owner of the license plates may register
18 another antique vehicle under the same license plate designation, upon
19 application therefor and the payment of a fee of \$1.50. ~~On and after~~
20 ~~January 1, 2000,~~ Any model year license plate transferred shall comply
21 with the provisions of ~~subsection (e) of~~ K.S.A. 8-172(c), and amendments
22 thereto.

23 (b) Upon the transfer and sale of a registered vehicle by any person,
24 the new owner thereof, before using a vehicle on the highways of this
25 state, shall make application to the division for registration of the vehicle.

26 (c) Certificate of title:

27 (1) Application for certificate of title on an antique vehicle shall be
28 made by the owner or the owner's agent upon a blank form to be furnished
29 by the division and shall contain such information as the division shall
30 determine necessary. The division may waive any information requested
31 on the form if it is not available. For any antique vehicle ~~having~~ **with** a
32 model year ~~prior to 1950-1960~~ **50 years old or older**, the application
33 together with a bill of sale for the antique vehicle shall be accepted as
34 prima facie evidence that the applicant is the owner of the vehicle and the
35 certificate of title shall be issued for such vehicle. If the application and
36 bill of sale are used to obtain a certificate of title for any antique vehicle

1 having a model year ~~of 1950-1960 or later~~ **newer than 50 years**, the
2 certificate of title shall not be issued until an inspection in accordance with
3 ~~subsection (a) of K.S.A. 8-116~~ *8-116a*, and amendments thereto, has been
4 completed. The certificate of title shall be delivered to the applicant. The
5 certificate shall contain the words "antique vehicle."

6 (2) The certificate of title shall contain upon the reverse side a form
7 for assignment of title to be executed by the owner. A certificate of title
8 may be issued under the provisions of this act without an application for
9 registration.

10 (3) The fee for each original certificate of title so issued shall be \$10.
11 The certificate of title shall be good for the life of the antique vehicle, so
12 long as ~~the same~~ *such certificate of title* is owned or held by the original
13 holder of the certificate of title, and shall not have to be renewed. In the
14 event of a sale or transfer of ownership of an antique vehicle for which a
15 certificate of title has been issued under the provisions of this subsection,
16 the holder of such certificate of title shall endorse on ~~the same~~ *certificate*
17 *of title* an assignment thereof, with warranty of title in form printed
18 thereon, as prescribed by the director, and the transferor ~~must~~ *shall* deliver
19 ~~the same such assigned certificate of title~~ to the buyer at the time of
20 delivery of the vehicle. The buyer shall then present such *assigned*
21 certificate of title, ~~assigned as aforesaid~~, to the director or an authorized
22 agent of the director, whereupon a new certificate of title shall be issued to
23 the buyer. The fee ~~therefor being~~ *for such new certificate of title shall be*
24 \$10.

25 Sec. 2. K.S.A. 2021 Supp. 8-170 is hereby repealed.

26 Sec. 3. This act shall take effect and be in force from and after its
27 publication in the statute book.
