1 AN ACT making and concerning appropriations for the fiscal years ending
2 June 30, 2018, and June 30, 2019, for the department of administration.

4 *Be it enacted by the Legislature of the State of Kansas:*

5 Section 1. (a) For the fiscal years ending June 30, 2018, and June 30,
6 2019, appropriations are hereby made, restrictions and limitations are
7 hereby imposed, and transfers, capital improvement projects, fees,
8 receipts, disbursements, procedures and acts incidental to the foregoing are
9 hereby directed or authorized as provided in this act.

10 (b) This act shall not be subject to the provisions of K.S.A. 75-
11 6702(a), and amendments thereto.

12 (c) The appropriations made by this act shall not be subject to the
13 provisions of K.S.A. 46-155, and amendments thereto.

15 DEPARTMENT OF ADMINISTRATION

16 (a) In addition to the other purposes for which expenditures may be
17 made by the department of administration from the moneys appropriated
18 from the state general fund or from any special revenue fund or funds for
19 fiscal year 2018 or fiscal year 2019 as authorized by section 65 or 66 of
20 chapter 104 of the 2017 Session Laws of Kansas, this act or other
21 appropriation act of the 2018 regular session of the legislature,
22 expenditures shall be made by the above agency from moneys
23 appropriated from the state general fund or from any special revenue fund
24 or funds for fiscal year 2018 or fiscal year 2019 to update the previous
25 plans for a capitol complex power plant or energy center: *Provided*, That
26 the above agency shall also implement the selection process for
27 architectural services pursuant to K.S.A. 75-1253, and amendments
28 thereto, to provide cost estimates to preserve and upgrade the existing
29 energy center of the Docking state office building, to provide for the
30 selective deconstruction of the existing building above grade and to
31 provide for the redevelopment of a renovated Docking state office
32 building: *And provided further*, That expenditures may be made by the
33 above agency from such funds to begin asbestos removal from the
34 Docking state office building: *Provided, however*, That expenditures shall
35 be made by the above agency from such funds to implement the provisions
36 of this proviso in an amount not to exceed \$100,000: *Provided further*,

1 That the above agency shall prepare and submit a report detailing the
2 various options for such building and the updated plans to the joint
3 committee on state building construction, the senate ways and means
4 committee and the house of representatives appropriations committee on
5 or before January 14, 2019.

6 Sec. 3. This act shall take effect and be in force from and after its
7 publication in the Kansas register.
