1 AN ACT concerning employment; relating to employment requirements in
2 certain state contracts; relating to employment requirements for certain
3 state tax benefits; amending K.S.A. 2016 Supp. 12-17,166, 74-50,131,
4 74-50,212, 74-50,217, 79-32,154 and 79-32,243 and repealing the
5 existing sections.
6

7 *Be it enacted by the Legislature of the State of Kansas:*

8 New Section 1. (a) As used in this section:

9 (1) "Division of purchasing" means the division of purchasing of the
10 department of administration.

11 (2) "Kansas worker" means any individual having a residence in
12 Kansas as determined by the employment records of such individual held
13 by the individual's employer.

14 (3) "State agency" means any state office or officer, department,
15 board, commission, institution or bureau, or any agency, division or unit
16 thereof.

17 (4) "State contract" means any agreement entered into on and after
18 January 1, 2018, by a state agency for the procurement of services with an
19 annual cost to the state agency of at least \$100,000, excluding lease
20 agreements, lease-purchase agreements and agreements entered into solely
21 for the acquisition of goods or commodities by the state agency.

22 (b) Any contractor entering into a state contract, including any
23 subcontractors contracted by such contractor to perform work required by
24 such state contract, shall employ a sufficient number of Kansas workers
25 such that at least 70% of the employees assigned by such contractor to
26 perform work under the state contract shall be Kansas workers. An
27 employee shall be considered assigned to perform work under the state
28 contract if the employee performs any work that is directly related to
29 fulfilling the contractor's obligations under the state contract regardless of
30 the proportion of such work to the employee's regular employment duties.

31 (c) All state agencies shall provide a copy of any state contract to the
32 division of purchasing for verification that the contractor is in compliance
33 with this section. A contractor subject to the requirements of this section
34 shall provide any personnel information to the division of purchasing as
35 required by the secretary of administration. The division of purchasing

1 shall determine if the contractor's employees are Kansas workers and
2 verify whether the contractor is in compliance with this section. The
3 division of purchasing shall submit a report to the state agency contracting
4 with the contractor stating whether the contractor is in compliance with
5 this section.

6 (d) A determination by the division of purchasing that a contractor is
7 not in compliance with this section is subject to review pursuant to the
8 Kansas administrative procedure act upon request by the contractor. Any
9 contractor aggrieved by the final decision under the Kansas administrative
10 procedure act may seek review of such decision under the Kansas judicial
11 review act.

12 (e) An employee who performs work under a state contract and is not
13 a Kansas worker may be exempt from the requirements of this section if
14 such employee provides expertise in a field necessary to fulfillment of the
15 contractor's contractual obligations, and such expertise cannot reasonably
16 be provided by a Kansas worker. A contractor may submit an application
17 to the division of purchasing for an exemption from this section for such
18 employees classified as experts. Such application shall include the name,
19 residence, position and job description of the employee, a detailed
20 explanation as to why such employee is an expert, a detailed explanation
21 as to why such expertise cannot reasonably be provided by a Kansas
22 worker, and such other information as required by the secretary of
23 administration. The division of purchasing shall determine whether such
24 employee shall be exempt from this section and shall include such
25 determination in its report to the state agency pursuant to subsection (c).

26 (f) The secretary of administration shall adopt such rules and
27 regulations the secretary deems necessary to implement and enforce the
28 provisions of this section.

29 Sec. 2. K.S.A. 2016 Supp. 12-17,166 is hereby amended to read as
30 follows: 12-17,166. (a) One or more projects may be undertaken by a city
31 or county within an established STAR bond project district. Any city or
32 county proposing to undertake a STAR bond project, shall prepare a STAR
33 bond project plan in consultation with the planning commission of the city,
34 and in consultation with the planning commission of the county, if any, if
35 such project is located wholly outside the boundaries of the city. Any such
36 project plan may be implemented in separate development stages.

37 (b) Any city or county proposing to undertake a STAR bond project
38 within a STAR bond project district established pursuant to K.S.A. 2016
39 Supp. 12-17,165, and amendments thereto, shall prepare a feasibility
40 study. The feasibility study shall contain the following:

41 (1) Whether a STAR bond project's revenue and tax increment
42 revenue and other available revenues under K.S.A. 2016 Supp. 12-17,169,
43 and amendments thereto, are expected to exceed or be sufficient to pay for

1 the project costs;

2 (2) the effect, if any, a STAR bond project will have on any
3 outstanding special obligation bonds payable from the revenues described
4 in K.S.A. 2016 Supp. 12-17,169, and amendments thereto;

5 (3) a statement of how the jobs and taxes obtained from the STAR
6 bond project will contribute significantly to the economic development of
7 the state and region;

8 (4) visitation expectations;

9 (5) the unique quality of the project;

10 (6) economic impact study;

11 (7) market study;

12 (8) market impact study;

13 (9) integration and collaboration with other resources or businesses;

14 (10) the quality of service and experience provided, as measured
15 against national consumer standards for the specific target market;

16 (11) project accountability, measured according to best industry
17 practices;

18 (12) the expected return on state and local investment that the project
19 is anticipated to produce;

20 (13) a statement concerning whether a portion of the local sales and
21 use taxes are pledged to other uses and are unavailable as revenue for the
22 STAR bond project. If a portion of local sales and use taxes is so
23 committed, the applicant shall describe the following:

24 (A) The percentage of city and county sales and use taxes collected
25 that are so committed; and

26 (B) the date or dates on which the city and county sales and use taxes
27 pledged to other uses can be pledged for repayment of bonds; and

28 (14) an anticipated principal and interest payment schedule on the
29 bond issue.

30 The failure to include all information enumerated in this subsection in
31 the feasibility study for a STAR bond project shall not affect the validity of
32 bonds issued pursuant to this act.

33 (c) If the city or county determines the project is feasible, the project
34 plan shall include:

35 (1) A summary of the feasibility study done as defined in subsection
36 (b) of this section, ~~and amendments thereto;~~

37 (2) a reference to the district plan established under K.S.A. 2016
38 Supp. 12-17,165, and amendments thereto, that identifies the project area
39 that is set forth in the project plan that is being considered;

40 (3) a description and map of the project area to be redeveloped;

41 (4) the relocation assistance plan as described in K.S.A. 2016 Supp.
42 12-17,172, and amendments thereto;

43 (5) a detailed description of the buildings and facilities proposed to be

1 constructed or improved in such area; and

2 (6) any other information the governing body of the city or county
3 deems necessary to advise the public of the intent of the project plan.

4 (d) A copy of the STAR bond project plan prepared by a city shall be
5 delivered to the board of county commissioners of the county and the
6 board of education of any school district levying taxes on property within
7 the STAR bond project area. A copy of the STAR bond project plan
8 prepared by a county shall be delivered to the board of education of any
9 school district levying taxes on property within the STAR bond project
10 area.

11 (e) Upon a finding by the planning commission that the STAR bond
12 project plan is consistent with the intent of the comprehensive plan for the
13 development of the city, and a finding by the planning commission of the
14 county, if any, with respect to a STAR bond project located wholly outside
15 the boundaries of the city, that the STAR bond project plan is consistent
16 with the intent of the comprehensive plan for the development of the
17 county, the governing body of the city or county shall adopt a resolution
18 stating that the city or county is considering the adoption of the STAR
19 bond project plan. Such resolution shall:

20 (1) Give notice that a public hearing will be held to consider the
21 adoption of the STAR bond project plan and fix the date, hour and place of
22 such public hearing;

23 (2) describe the boundaries of the STAR bond project district within
24 which the STAR bond project will be located and the date of establishment
25 of such district;

26 (3) describe the boundaries of the area proposed to be included within
27 the STAR bond project area; and

28 (4) state that the STAR bond project plan, including a summary of the
29 feasibility study, market study, relocation assistance plan and financial
30 guarantees of the prospective developer and a description and map of the
31 area to be redeveloped or developed are available for inspection during
32 regular office hours in the office of the city clerk or county clerk,
33 respectively.

34 (f) (1) The date fixed for the public hearing to consider the adoption
35 of the STAR bond project plan shall be not less than 30 nor more than 70
36 days following the date of the adoption of the resolution fixing the date of
37 the hearing.

38 (2) A copy of the city or county resolution providing for the public
39 hearing shall be by certified mail, return receipt requested, sent by the city
40 to the board of county commissioners of the county and by the city or
41 county to the board of education of any school district levying taxes on
42 property within the proposed STAR bond project area. Copies also shall be
43 sent by certified mail, return receipt requested to each owner and occupant

1 of land within the proposed STAR bond project area not more than 10 days
2 following the date of the adoption of the resolution. The resolution shall be
3 published once in the official city or county newspaper not less than one
4 week nor more than two weeks preceding the date fixed for the public
5 hearing. A sketch clearly delineating the area in sufficient detail to advise
6 the reader of the particular land proposed to be included within the STAR
7 bond project area shall be published with the resolution.

8 (3) At the public hearing, a representative of the city or county shall
9 present the city's or county's proposed STAR bond project plan. Following
10 the presentation of the STAR bond project area, all interested persons shall
11 be given an opportunity to be heard. The governing body for good cause
12 shown may recess such hearing to a time and date certain, which shall be
13 fixed in the presence of persons in attendance at the hearing.

14 (g) The public hearing records and feasibility study shall be subject to
15 the open records act, K.S.A. 45-215, and amendments thereto.

16 (h) Upon conclusion of the public hearing, the governing body may
17 adopt the STAR bond project plan by ordinance or resolution passed upon
18 a two-thirds vote of the members.

19 (i) After the adoption by the city or county governing body of a
20 STAR bond project plan, the clerk of the city or county shall transmit a
21 copy of the description of the land within the STAR bond project district, a
22 copy of the ordinance or resolution adopting the plan and a map or plat
23 indicating the boundaries of the district to the clerk, appraiser and treasurer
24 of the county in which the district is located and to the governing bodies of
25 the county and school district which levy taxes upon any property in the
26 district. Such documents shall be transmitted following the adoption or
27 modification of the plan or a revision of the plan on or before January 1 of
28 the year in which the increment is first allocated to the taxing subdivision.

29 (j) If the STAR bond project plan is approved, the feasibility study
30 shall be supplemented to include a copy of the minutes of the governing
31 body meetings of any city or county whose bonding authority will be
32 utilized in the STAR bond project, evidencing that a STAR bond project
33 plan has been created, discussed and adopted by the city or county in a
34 regularly scheduled open public meeting.

35 (k) Any substantial changes as defined in K.S.A. 2016 Supp. 12-
36 17,162, and amendments thereto, to the STAR bond project plan as
37 adopted shall be subject to a public hearing following publication of notice
38 thereof at least twice in the official city or county newspaper.

39 (l) Any STAR bond project shall be completed within 20 years from
40 the date of the approval of the STAR bond project plan. The maximum
41 maturity on bonds issued to finance projects pursuant to this act shall not
42 exceed 20 years.

43 (m) ~~(l) Kansas resident employees shall be given priority~~

1 ~~consideration for employment in construction projects located in a STAR~~
2 ~~bond project area~~ *On and after January 1, 2018, any contractor, including*
3 *any subcontractors, contracted to perform work on a STAR bond project*
4 *shall employ a sufficient number of Kansas workers such that at least 70%*
5 *of the employees assigned by such contractor to perform such work shall*
6 *be Kansas workers. An employee shall be considered assigned to perform*
7 *such work if the employee performs any work that is directly related to*
8 *fulfilling the contractor's obligations with respect to the STAR bond*
9 *project regardless of the proportion of such work to the employee's regular*
10 *employment duties.*

11 *(2) All contractors subject to the provisions of this subsection shall*
12 *provide any personnel information to the department of commerce as*
13 *required by the secretary of commerce. The secretary shall notify the city*
14 *or county proposing the STAR bond project of any contractor that is not in*
15 *compliance with the provisions of this subsection. Upon such notification,*
16 *the city or county shall either provide the contractor an opportunity to*
17 *cure the noncompliance within a reasonable time, or terminate the*
18 *contract with such contractor.*

19 *(3) For the purposes of this subsection, the term "Kansas worker"*
20 *shall have the same meaning as provided in section 1, and amendments*
21 *thereto.*

22 *(n) Any developer of a STAR bond project shall commence work on*
23 *the project within two years from the date of adoption of the STAR bond*
24 *project plan. Should the developer fail to commence work on the STAR*
25 *bond project within the two-year period, funding for such project shall*
26 *cease and the developer of such project or complex shall have one year to*
27 *appeal to the secretary for reapproval of such project and the funding for*
28 *it. Should the project be reapproved, the two-year period for*
29 *commencement shall apply.*

30 *Sec. 3. K.S.A. 2016 Supp. 74-50,131 is hereby amended to read as*
31 *follows: 74-50,131. Commencing after December 31, 1999: (a) As used in*
32 *this act: "Qualified firm" means a for-profit business establishment,*
33 *subject to state income, sales or property taxes, identified under the North*
34 *American industry classification system (NAICS) subsectors 221, 311 to*
35 *339, 423 to 425, 481 to 519, 521 to 721 and 811 to 928 or is identified as a*
36 *corporate or regional headquarters or back-office operation of a national or*
37 *multi-national corporation regardless of NAICS designation. The secretary*
38 *of commerce shall determine eligibility when a difference exists between a*
39 *firm's primary business activity and NAICS designation. A business*
40 *establishment may be assigned a NAICS designation according to the*
41 *primary business activity at a single physical location in the state.*

42 *(b) In the case of firms in NAICS subsectors 221, 423 to 425, 481 to*
43 *519, 521 to 721 and 811 to 928, the business establishment must also*

1 demonstrate the following:

2 (1) More than $\frac{1}{2}$ of its gross revenues are a result of sales to
3 commercial or governmental customers outside the state of Kansas; or

4 (2) more than $\frac{1}{2}$ of its gross revenues are a result of sales to Kansas
5 manufacturing firms within NAICS subsectors 311 to 339; or

6 (3) more than $\frac{1}{2}$ of its gross revenues are a result of a combination of
7 sales described in (1) and (2).

8 (c) For purposes of determining whether one of the average wage
9 options described in subsection (d) below is satisfied, business
10 establishments located within a metropolitan county, as defined in K.S.A.
11 74-50,114, and amendments thereto, will be compared only to other
12 businesses within that metropolitan county, and business establishments
13 located outside of a metropolitan county will be compared to businesses
14 within an aggregation of counties representing the business establishment's
15 region of the state, which regional aggregation will exclude metropolitan
16 counties. Such aggregation shall be determined by the department of
17 commerce.

18 (d) Additionally, a business establishment having met the criteria as
19 established in subsection (a) or (b), and using the comparison method
20 described in subsection (c), must meet one of the following criteria:

21 (1) The establishment with 500 or fewer full-time equivalent
22 employees will provide an average wage that is above the average wage
23 paid by all firms with 500 or fewer full-time equivalent employees which
24 share the appropriate NAICS designation.

25 (2) The establishment with 500 or fewer full-time equivalent
26 employees is the sole firm within its appropriate NAICS designation
27 which has 500 or fewer full-time equivalent employees.

28 (3) The establishment with more than 500 full-time equivalent
29 employees will provide an average wage that is above the average wage
30 paid by firms with more than 500 full-time equivalent employees which
31 share the appropriate NAICS designation.

32 (4) The establishment with more than 500 full-time equivalent
33 employees is the sole firm within its appropriate NAICS designation
34 which has more than 500 full-time equivalent employees, in which event it
35 shall either provide an average wage that is above the average wage paid
36 by all firms with 500 or fewer full-time equivalent employees which share
37 the appropriate NAICS designation, or be the sole firm within its
38 appropriate NAICS designation.

39 (e) As an alternative to the requirements of subsections (c) and (d), a
40 firm having met the requirements of subsections (a) or (b), may qualify, if
41 excluding taxable disbursements to company owners, the business
42 establishment's annual average wage must be greater than or equal to 1.5
43 times the aggregate average wage paid by industries covered by the

1 employment security law based on data maintained by the secretary of
2 labor.

3 (f) For the purposes of this section, the number of full-time
4 equivalent employees shall be determined by dividing the number of hours
5 worked by part-time employees during the pertinent measurement interval
6 by an amount equal to the corresponding multiple of a 40-hour work week
7 and adding the quotient to the number of full-time employees.

8 (g) (1) *On and after January 1, 2018, a qualified firm shall employ a*
9 *sufficient number of Kansas workers such that at least 70% of the*
10 *employees assigned by such qualified firm to perform work in the state of*
11 *Kansas shall be Kansas workers. An employee shall be considered*
12 *assigned to perform work in the state of Kansas if the employee performs*
13 *any work that is performed in Kansas regardless of the proportion of such*
14 *work to the employee's regular employment duties.*

15 (2) *For the purposes of this subsection, the term "Kansas worker"*
16 *shall have the same meaning as provided in section 1, and amendments*
17 *thereto.*

18 (h) The secretary of commerce shall certify annually to the secretary
19 of revenue that a firm meets the criteria for a qualified firm and that the
20 firm is eligible for the benefits and assistance provided under this act. The
21 secretary of commerce is hereby authorized to obtain any and all
22 information necessary to determine such eligibility. Information obtained
23 under this section shall not be subject to disclosure pursuant to K.S.A. 45-
24 215 et seq., and amendments thereto, but shall upon request be made
25 available to the legislative post audit division. The secretary of commerce
26 shall publish rules and regulations for the implementation of this act. Such
27 rules and regulations shall include, but not be limited to:

28 (1) A definition of "training and education" for purposes of K.S.A.
29 74-50,132, and amendments thereto.

30 (2) Establishment of eligibility requirements and application
31 procedures for expenditures from the high performance incentive fund
32 created in K.S.A. 74-50,133, and amendments thereto.

33 (3) Establishment of approval guidelines for private consultants
34 authorized pursuant to K.S.A. 74-50,133, and amendments thereto.

35 (4) Establishment of guidelines for prioritizing business assistance
36 programs pursuant to K.S.A. 74-50,133, and amendments thereto.

37 (5) A definition of "commercial customer" for the purpose of K.S.A.
38 74-50,133, and amendments thereto.

39 (6) A definition of "headquarters" for the purpose of K.S.A. 74-
40 50,133, and amendments thereto.

41 (7) Establishment of guidelines concerning the use and disclosure of
42 any information obtained to determine the eligibility of a firm for the
43 assistance and benefits provided for by this act.

1 Sec. 4. K.S.A. 2016 Supp. 74-50,212 is hereby amended to read as
2 follows: 74-50,212. (a) In order to qualify for benefits under this act a
3 qualified company shall:

4 (1) Relocate to Kansas an existing business facility, office,
5 department or other operation doing business outside the state of Kansas
6 and locate the jobs directly related to such relocated business facility,
7 office, department or other operation in Kansas;

8 (2) locate a new business facility, office, department or other
9 operation in Kansas and locate the jobs directly related to such business
10 facility, office, department or other operation in Kansas; or

11 (3) expand an existing business facility, office, department or other
12 operation located in the state of Kansas and locate the jobs directly related
13 to such business facility, office, department or other operation in Kansas,
14 except that no payroll withholding taxes shall be retained prior to January
15 1, 2012.

16 A qualified company may utilize or contract with a third-party
17 employer to perform services whereby the third-party employer serves as
18 the legal employer of the new employees providing services to the
19 qualified company and such services are performed in Kansas and the
20 third-party employer and the new employees are subject to the Kansas
21 withholding and declaration of estimated tax act.

22 (b) Any qualified company, approved by the secretary for benefits
23 pursuant to paragraph (a), that locates its business operation in a
24 metropolitan county and will hire at least 10 new employees within two
25 years from the date the qualified company enters into an agreement with
26 the secretary pursuant to K.S.A. 2016 Supp. 74-50,213, and amendments
27 thereto, or any qualified company, approved by the secretary for benefits
28 pursuant to paragraph (a), that locates its business operation in a non-
29 metropolitan county and will hire at least five new employees within two
30 years from the date the qualified company enters into an agreement with
31 the secretary pursuant to K.S.A. 2016 Supp. 74-50,213, and amendments
32 thereto, shall: (1) Be eligible to retain 95% of the qualified company's
33 Kansas payroll withholding taxes for such new employees being paid the
34 county median wage or higher for a period of up to:

35 (A) Five years if the median wage or average wage paid to the new
36 employees is equal to at least 100% of the county median wage;

37 (B) six years if the median wage or average wage paid to the new
38 employees is equal to at least 110% of the county median wage;

39 (C) seven years if the median wage or average wage paid to the new
40 employees is equal to at least 120% of the county median wage; or

41 (2) be eligible to retain 95% of the qualified company's Kansas
42 payroll withholding taxes for such new employees being paid the county
43 median wage or higher for a period of up to five years if the median wage

1 or average wage paid to the new employees is equal to at least 100% of the
2 NAICS code industry average wage.

3 (c) Any qualified company, approved by the secretary for benefits
4 pursuant to paragraph (a), that engages in a high-impact project whereby
5 the qualified company will hire at least 100 new employees within two
6 years from the date the qualified company enters into an agreement with
7 the secretary pursuant to K.S.A. 2016 Supp. 74-50,213, and amendments
8 thereto, shall be eligible to retain 95% of the qualified company's Kansas
9 payroll withholding taxes for such new employees being paid the county
10 median wage or higher for a period of up to:

11 (1) Seven years if the median wage or average wage paid to the new
12 employees is equal to at least 100% of the county median wage;

13 (2) eight years if the median wage or average wage paid to the new
14 employees is equal to at least 110% of the county median wage;

15 (3) nine years if the median wage or average wage paid to the new
16 employees is equal to at least 120% of the county median wage; or

17 (4) ten years if the median wage or average wage paid to the new
18 employees is equal to at least 140% of the county median wage.

19 (d) In the event that a qualified company contracts with a third party
20 as described in subsection (a), the third party shall remit payments equal to
21 the amount of Kansas payroll withholding taxes the qualified company is
22 eligible to retain under this section to the qualified company, and report
23 such amount to the department of revenue as required pursuant to
24 ~~subsection (a)~~ of K.S.A. 2016 Supp. 74-50,214(a), and amendments
25 thereto.

26 (e) *(1) On and after January 1, 2018, a qualified company shall*
27 *employ a sufficient number of Kansas workers such that at least 70% of*
28 *the employees assigned by such qualified firm to perform work in the state*
29 *of Kansas shall be Kansas workers. An employee shall be considered*
30 *assigned to perform work in the state of Kansas if the employee performs*
31 *any work that is performed in Kansas regardless of the proportion of such*
32 *work to the employee's regular employment duties.*

33 *(2) For the purposes of this subsection, the term "Kansas worker"*
34 *shall have the same meaning as provided in section 1, and amendments*
35 *thereto.*

36 (f) Commencing January 1, 2013, and ending June 30, 2018, any
37 company, which meets the criteria provided pursuant to the provisions of
38 K.S.A. 2016 Supp. 74-50,211, and amendments thereto, that retains the
39 employees of an existing business unit located in Kansas and enters into an
40 agreement with the secretary pursuant to K.S.A. 2016 Supp. 74-50,213,
41 and amendments thereto, shall be eligible to retain 95% of the qualified
42 company's Kansas payroll withholding taxes for such employees for a
43 period of up to five years.

1 ~~(f)~~ (g) (1) Commencing January 1, 2013, and ending June 30, 2018,
 2 pursuant to the provisions of subsection ~~(e)~~ (f), the secretary of commerce,
 3 in the secretary's sole determination, may provide the benefits of the
 4 promoting employment across Kansas act for situations where it is deemed
 5 necessary by the secretary that the state of Kansas provide incentives for a
 6 company or its operations currently located in Kansas to remain in Kansas
 7 so as to keep its retained jobs. The secretary shall establish and verify that
 8 a prospective company has competitive alternatives that it is seriously
 9 considering and that a company's relocation may be imminent.
 10 Furthermore, the secretary shall assess:

11 (A) Whether the retention of the company or its operations is
 12 important to the economic vitality of the state;

13 (B) the area where such company or operations is located; or

14 (C) whether the retention of the company or its operations is

 16 including, but not limited to, the quantity, quality or wages of the retained

18 (2) Effective January 1, 2013, and ending June 30, 2018, the secretary
 19 may use the promoting employment across Kansas act in conjunction with
 20 other economic development programs to develop a retention package.

21 ~~(g)~~ (h) The provisions of this act as in effect prior to the effective date
 22 of this act shall apply to employers who have entered into agreements with
 23 the secretary prior to July 1, 2011. The provisions of this act shall apply to
 24 employers who enter into agreements with the secretary on and after July
 25 1, 2011.

26 ~~(h)~~ (i) In the event a qualified company entered into an agreement for
 27 benefits under this section prior to January 1, 2013, such qualified

26 performs duties in connection with the operation of the qualified business
