1 AN ACT concerning **alcoholic liquor; relating to** the Kansas state fair;
2 ~~relating to alcoholic liquor~~; sales during the state fair; issuance of
3 temporary permits; liquor enforcement tax and liquor drink tax;
4 crediting a portion of such tax moneys collected to the state fair capital
5 improvements fund; amending K.S.A. **41-719, 41-1201**, 79-4108 and
6 79-41a03 ~~and K.S.A. 2020 Supp. 41-719 and 41-1201~~ and repealing the
7 existing sections.
8

9 *Be it enacted by the Legislature of the State of Kansas:*

10 Section 1. K.S.A. ~~2020 Supp.~~ 41-719 is hereby amended to read as
11 follows: 41-719. (a) (1) Except as otherwise provided herein and in K.S.A.
12 8-1599, and amendments thereto, no person shall drink or consume
13 alcoholic liquor on the public streets, alleys, roads or highways or inside
14 vehicles while on the public streets, alleys, roads or highways.

15 (2) Alcoholic liquor may be consumed on public streets, alleys, roads,
16 sidewalks or highways when:

17 (A) A temporary permit has been issued pursuant to K.S.A. **41-1201**
18 **or 41-2703**, and amendments thereto, ~~or K.S.A. 2020 Supp. 41-1201, and~~
19 ~~amendments thereto~~; for such an event;

20 (B) a caterer's licensee has provided the required notification for a
21 catered event pursuant to K.S.A. 41-2643, and amendments thereto; or

22 (C) a public venue, hotel, hotel caterer, drinking establishment caterer
23 or drinking establishment licensee has been authorized to extend its
24 licensed premises pursuant to K.S.A. 41-2608, and amendments thereto.

25 (3) Consumption of alcoholic liquor on public streets, alleys, roads,
26 sidewalks or highways must be approved, by ordinance or resolution, by
27 the local governing body of any city, county or township where such
28 consumption will occur. No alcoholic liquor may be consumed inside
29 vehicles while on public streets, alleys, roads or highways at any time.

30 (4) No person shall remove any alcoholic liquor from inside the
31 boundaries of an event as designated by the governing body of any city,
32 county or township, from the boundaries of a catered event or from the
33 extended licensed premises of a public venue, hotel, hotel caterer, drinking
34 establishment caterer or drinking establishment. Such boundaries shall be
35 clearly marked by signs, a posted map or other means which reasonably
36 identify the area in which alcoholic liquor may be possessed or consumed.

1 (b) Alcoholic liquor may be consumed within common consumption
2 areas designated by a city or county on public streets, alleys, roads,
3 sidewalks or highways pursuant to K.S.A. ~~2020 Supp.~~ 41-2659, and
4 amendments thereto, except that no alcoholic liquor may be consumed
5 inside vehicles while on public streets, alleys, roads or highways within a
6 common consumption area. Further, no person shall remove any alcoholic
7 liquor from inside the boundaries of the common consumption area which
8 shall be clearly designated by a physical barrier.

9 (c) No person shall drink or consume alcoholic liquor on private
10 property except:

11 (1) On premises where the sale of liquor by the individual drink is
12 authorized by the club and drinking establishment act;

13 (2) upon private property by a person occupying such property as an
14 owner or lessee of an owner and by the guests of such person, if no charge
15 is made for the serving or mixing of any drink or drinks of alcoholic liquor
16 or for any substance mixed with any alcoholic liquor and if no sale of
17 alcoholic liquor in violation of K.S.A. 41-803, and amendments thereto,
18 takes place;

19 (3) in a lodging room of any hotel, motel or boarding house by the
20 person occupying such room and by the guests of such person, if no charge
21 is made for the serving or mixing of any drink or drinks of alcoholic liquor
22 or for any substance mixed with any alcoholic liquor and if no sale of
23 alcoholic liquor in violation of K.S.A. 41-803, and amendments thereto,
24 takes place;

25 (4) in a private dining room of a hotel, motel or restaurant, if the
26 dining room is rented or made available on a special occasion to an
27 individual or organization for a private party and if no sale of alcoholic
28 liquor in violation of K.S.A. 41-803, and amendments thereto, takes place;

29 (5) on the premises of a manufacturer, microbrewery, microdistillery
30 or farm winery, if authorized by K.S.A. 41-305, 41-308a, 41-308b **or 41-**
31 **354, and amendments thereto, ~~or K.S.A. 2020 Supp. 41-354, and~~**
32 **~~amendments thereto;~~**

33 (6) on the premises of an unlicensed business as authorized pursuant
34 to subsection (j); or

35 (7) within a common consumption area established pursuant to
36 K.S.A. ~~2020 Supp.~~ 41-2659, and amendments thereto.

37 (d) No person shall drink or consume alcoholic liquor on public
38 property except:

39 (1) On real property leased by a city to others under the provisions of
40 K.S.A. 12-1740 through 12-1749, and amendments thereto, if such real
41 property is actually being used for hotel or motel purposes or purposes
42 incidental thereto.

43 (2) In any state-owned or operated building or structure, and on the

1 surrounding premises, which is furnished to and occupied by any state
2 officer or employee as a residence.

3 (3) On premises licensed as a club or drinking establishment and
4 located on property owned or operated by an airport authority created
5 pursuant to chapter 27 of the Kansas Statutes Annotated, and amendments
6 thereto, or established by a city.

7 (4) On the state fair grounds on the day of any race held thereon
8 pursuant to the Kansas parimutuel racing act.

9 (5) On the state fairgrounds, *within boundaries that have been*
10 *marked with a three-dimensional barrier*, if: (A) The alcoholic liquor is
11 domestic beer or wine or wine imported under K.S.A. 41-308a(e), and
12 amendments thereto, and is consumed only for purposes of judging
13 competitions; (B) the alcoholic liquor is wine or beer ~~and that is sold and~~
14 ~~consumed during the days of the Kansas state fair on premises leased by~~
15 ~~the state fair board to a person who holds a temporary permit issued~~
16 ~~pursuant to K.S.A. 41-2703, and amendments thereto, or K.S.A. 2020~~
17 ~~Supp. 41-1201, and amendments thereto, authorizing the sale and serving~~
18 ~~of such wine or beer, or both, or as authorized by the Kansas state fair~~
19 ~~board, by the holder of a temporary permit in accordance with the~~
20 ~~provisions of K.S.A. 2020 Supp. 41-1201(g), and amendments thereto; or~~
21 (C) the alcoholic liquor is consumed on nonfair days in conjunction with
22 bona fide scheduled events involving not less than 75 invited guests and
23 the state fair board, in its discretion, authorizes the consumption of the
24 alcoholic liquor, subject to any conditions or restrictions the board may
25 require.

26 (6) In the state historical museum provided for by K.S.A. 76-2036,
27 and amendments thereto, on the surrounding premises and in any other
28 building on such premises, as authorized by rules and regulations of the
29 state historical society.

30 (7) On the premises of any state-owned historic site under the
31 jurisdiction and supervision of the state historical society, on the
32 surrounding premises and in any other building on such premises, as
33 authorized by rules and regulations of the state historical society.

34 (8) In a lake resort within the meaning of K.S.A. 32-867, and
35 amendments thereto, on state-owned or leased property.

36 (9) On the premises of any Kansas national guard regional training
37 center or armory, and any building on such premises, as authorized by
38 rules and regulations of the adjutant general and upon approval of the
39 Kansas military board.

40 (10) On the premises of any land or waters owned or managed by the
41 department of wildlife, parks and tourism, except as otherwise prohibited
42 by rules and regulations of the department adopted by the secretary
43 pursuant to K.S.A. 32-805, and amendments thereto.

1 (11) On property exempted from this subsection pursuant to
2 subsection (e), (f), (g), (h) or (i).

3 (12) On the premises of the state capitol building or on its
4 surrounding premises during an official state function of a nonpartisan
5 nature that has been approved by the legislative coordinating council.

6 (13) On premises of a common consumption area established by
7 K.S.A. ~~2020 Supp.~~ 41-2659, and amendments thereto.

8 (e) Any city may exempt, by ordinance, from the provisions of
9 subsection (d) specified property the title of which is vested in such city.

10 (f) The board of county commissioners of any county may exempt,
11 by resolution, from the provisions of subsection (d) specified property the
12 title of which is vested in such county.

13 (g) The state board of regents may exempt from the provisions of
14 subsection (d) the Sternberg museum on the campus of Fort Hays state
15 university, or other specified property which is under the control of such
16 board and which is not used for classroom instruction, where alcoholic
17 liquor may be consumed in accordance with policies adopted by such
18 board.

19 (h) The board of regents of Washburn university may exempt from
20 the provisions of subsection (d) the Mulvane art center and the Bradbury
21 Thompson alumni center on the campus of Washburn university, and other
22 specified property the title of which is vested in such board and which is
23 not used for classroom instruction, where alcoholic liquor may be
24 consumed in accordance with policies adopted by such board.

25 (i) The board of trustees of a community college may exempt from
26 the provisions of subsection (d) specified property ~~which~~ *that* is under the
27 control of such board and ~~which~~ is not used for classroom instruction,
28 where alcoholic liquor may be consumed in accordance with policies
29 adopted by such board.

30 (j) (1) An unlicensed business may authorize patrons or guests of
31 such business to consume alcoholic liquor on the premises of such
32 business provided:

33 (A) Such alcoholic liquor is in the personal possession of the patron
34 and is not sold, offered for sale or given away by the owner of such
35 business or any employees thereof;

36 (B) possession and consumption of alcoholic liquor shall not be
37 authorized between the hours of 12 a.m. and 9 a.m.;

38 (C) the business, or any owner thereof, shall not have had a license
39 issued under either the Kansas liquor control act or the club and drinking
40 establishment act revoked for any reason; and

41 (D) no charge of any sort may be made by the business for the
42 privilege of possessing or consuming alcoholic liquor on the premises, or
43 for mere entry onto the premises.

1 (2) It shall be a violation of this section for any unlicensed business to
2 authorize the possession or consumption of alcoholic liquor by a patron of
3 such business when such authorization is not in accordance with the
4 provisions of this subsection.

5 (3) For the purposes of this subsection, "patron" means a natural
6 person who is a customer or guest of an unlicensed business.

7 (k) Violation of any provision of this section is a misdemeanor
8 punishable by a fine of not less than \$50 or more than \$200 or by
9 imprisonment for not more than six months, or both.

10 (l) For the purposes of this section, "common consumption area" ~~has~~
11 ~~means the same meaning as that term is defined in K.S.A. 2020 Supp. 41-~~
12 ~~2659, and amendments thereto.~~

13 Sec. 2. ~~K.S.A. 2020 Supp. 41-1201~~ is hereby amended to read as
14 follows: 41-1201. (a) A temporary permit shall allow the permit holder to
15 offer for sale, sell and serve alcoholic liquor for consumption on licensed
16 or unlicensed premises, or on premises that are otherwise subject to a
17 separate temporary permit, that may be open to the public, subject to the
18 terms of such permit. A temporary permit shall also authorize the permit
19 holder to sell, in accordance with rules and regulations adopted by the
20 secretary, alcoholic liquor at a charitable auction, or one or more limited
21 issue porcelain containers containing alcoholic liquor.

22 (b) A temporary permit holder may charge a fee for entrance into the
23 premises described in the permit, or any portion thereof.

24 (c) The director may issue a temporary permit to any one or more
25 persons or organizations applying for such a permit, in accordance with
26 rules and regulations of the secretary. The permit shall be issued in the
27 names of the persons or organizations to which it is issued.

28 (d) **(1)** Applications for temporary permits shall be required to be
29 filed with the director not less than 14 days before the event for which the
30 permit is sought, unless the director waives such requirement for good
31 cause. The application shall be upon a form prescribed by the director.
32 Each application shall be electronically submitted and accompanied by a
33 non-refundable permit fee of \$25 for each day for which the permit is
34 issued, and such fee shall be paid by a check or credit card in the full
35 amount thereof. All permit fees collected by the director pursuant to this
36 section shall be remitted to the state treasurer in accordance with the
37 provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of
38 each such remittance, the state treasurer shall deposit the entire amount in
39 the state treasury to the credit of the state general fund.

40 **(2) No city, county or township shall charge more than a \$25 non-**
41 **refundable fee for each day for which the permit is issued.**

42 (e) Each application for a temporary permit shall specify the premises
43 for which ~~they are~~ *such permit is* issued, including a diagram of the

1 premises covered by the temporary permit. The diagram shall clearly show
2 the boundaries of the premises, entrances to and exits from the premises
3 and the area in which the service of alcoholic liquor would take place. A
4 temporary permit shall be issued only for premises where the city, county
5 or township zoning code allows the use for which the permit is issued. No
6 temporary permit shall be issued for premises that are not located in a
7 county where the qualified electors of the county:

8 (1) (A) Approved, by a majority vote of those voting thereon, to
9 adopt the proposition amending section 10 of article 15 of the constitution
10 of the state of Kansas at the general election in November, 1986; or

11 (B) have approved a proposition to allow the sale of liquor by the
12 individual drink in public places within the county at an election pursuant
13 to K.S.A. 41-2646, and amendments thereto; and

14 (2) have not approved a proposition to prohibit such sales of alcoholic
15 liquor in such places at a subsequent election pursuant to K.S.A. 41-2646,
16 and amendments thereto.

17 (f) (1) (A) A temporary permit may be issued for the consumption of
18 alcoholic liquor on a city, county or township street, alley, road, sidewalk
19 or highway for an event if: ~~(A)~~ (i) Such street, alley, road, sidewalk or
20 highway is closed to motor vehicle traffic by the governing body of such
21 city, county or township for such event; ~~(B)~~ (ii) a written request for such
22 consumption and possession of such alcoholic liquor has been made to the
23 local governing body; and ~~(C)~~ (iii) the event has been approved by the
24 governing body of such city, county or township by ordinance or
25 resolution.

26 (B) The boundaries of any such event shall be clearly marked by
27 signs, a posted map or other means ~~which~~ that reasonably identify the area
28 in which alcoholic liquor may be possessed or consumed at such event.

29 (2) Drinking establishments that are immediately adjacent to, or
30 located within the licensed premises of an event, for which a temporary
31 permit has been issued and the consumption of alcoholic liquor on public
32 property has been approved, may request that the drinking establishment's
33 licensed premises be extended into and made a part of the licensed
34 premises of the event, for the duration of the temporary permit issued for
35 such event.

36 (3) Each licensee selling alcoholic liquor for consumption on the
37 premises of an event for which a temporary permit has been issued shall be
38 liable for violations of all laws governing the sale and consumption of
39 alcoholic liquor.

40 (4) Each temporary permit holder selling alcoholic liquor for
41 consumption on the permit premises shall be liable for all violations of
42 laws governing the sale and consumption of alcoholic liquor that occur in
43 areas covered by multiple temporary permits.

1 (g) (1) *A temporary permit may be issued for the sale of wine ~~or~~, beer~~,~~*
2 *or ~~both~~ **other alcoholic liquor** on the Kansas state fairgrounds during the*
3 *days of the Kansas state fair, or as authorized by the Kansas state fair*
4 *board, if the Kansas state fair board has authorized such consumption and*
5 *possession of such wine ~~or~~, beer~~,~~ or ~~both~~ **other alcoholic liquor**. Each*
6 *application for such temporary permit shall specify the premises within*
7 *the fairgrounds for which the permit is issued, including a diagram of the*
8 *premises covered by the temporary permit. Such diagram shall match the*
9 *entirety of the premises as leased from the Kansas state fair board. The*
10 *boundaries of the Kansas state fairgrounds shall be clearly marked by*
11 *signs, a posted map or other means that reasonably identify the area in*
12 *which wine ~~or~~, beer~~,~~ or ~~both~~ **other alcoholic liquor**, may be possessed or*
13 *consumed at the state fair.*

14 (2) *Each temporary permit holder selling wine ~~or~~, beer~~,~~ or ~~both~~ **other***
15 ***alcoholic liquor** for consumption on the premises of the Kansas state*
16 *fairgrounds that is covered by such temporary permit shall be liable for all*
17 *violations of laws governing the sale and consumption of such alcoholic*
18 *liquor that occur on such temporary premises.*

19 (3) *Any temporary permit holder who has received a temporary*
20 *permit for the sale of wine ~~or~~, beer~~,~~ or ~~both~~ **other alcoholic liquor** on the*
21 *Kansas state fairgrounds may allow such wine ~~or~~, beer **or other alcoholic***
22 ***liquor** to be removed from the temporary permit premises and onto the*
23 *Kansas state fairgrounds.*

24 (h) (1) *Except as otherwise provided in this subsection, a temporary*
25 *permit shall be issued for a period of time not to exceed three consecutive*
26 *days, the dates and hours of which shall be specified in the permit. An*
27 *applicant may not be issued more than four temporary permits in a*
28 *calendar year.*

29 (2) *The director may issue a sufficient number of temporary permits*
30 *as required by the state fair board, valid for the entire period of time of the*
31 *Kansas state fair, which authorizes the sale of wine in its original,*
32 *unopened container and the serving by the drink of wine ~~or~~, beer~~,~~ or ~~both~~ **other***
33 ***alcoholic liquor** on the state fairgrounds on premises specified in*
34 *the temporary permit, by a person who has entered into an agreement with*
35 *the state fair board for that purpose subject to the conditions imposed by*
36 *the state fair board. Nothing in this paragraph shall be construed to limit*
37 *the number of temporary permits the director may issue for the sale of*
38 *wine ~~or~~, beer~~,~~ or ~~both~~ **other alcoholic liquor** on the state fairgrounds*
39 *consistent with the requirements of the state fair board.*

40 (3) *For an event approved by the governing body of a city, county or*
41 *township pursuant to subsection (e)(1), the director may issue a temporary*
42 *permit, which may, at the director's discretion, be valid for the entire*
43 *period of such event, but in no event shall such permit be issued for a*

1 period of time that exceeds 30 consecutive days.

2 ~~(h)~~(i) An application for a temporary permit may be rejected by the
3 director if:

4 (1) The applicant has been granted ~~four~~ **12** permits in the current
5 calendar year;

6 (2) the application was not filed with the director at least 14 days
7 prior to the event;

8 (3) the applicant, or any officer, director, partner, registered agent,
9 trustee, manager or owner of the applicant has previously owned or
10 operated any entity holding a temporary permit, club, drinking
11 establishment or caterer's license, had such permit or license surrendered,
12 and at the time such permit or license was surrendered had been ordered to
13 appear and show cause why the permit or license should not be revoked or
14 suspended;

15 (4) the applicant has designated an area for an event that was the
16 subject of the order to appear and show cause as set forth in paragraph (3),
17 and it appears that the new application for a temporary permit covering the
18 premises is an attempt to avoid any possible remedial action taken by the
19 director against the former permit or license holder; ~~or~~

20 (5) the applicant has had a license or permit revoked under the club
21 and drinking establishment act, or has been convicted of a violation of the
22 Kansas liquor control act, the club and drinking establishment act, the
23 Kansas cereal malt beverage act or the provisions of K.S.A. 79-41a01 et
24 seq., and amendments thereto; **or**

25 **(6) the applicant has not remitted all liquor drink taxes due from**
26 **a previous temporary permit.**

27 ~~(i)~~(j) (1) A temporary permit holder may purchase and possess
28 alcoholic liquor for resale for a period of three days prior to the first day of
29 sale of such alcoholic liquor. A distributor may, without any further
30 permission from the director, deliver such alcoholic liquor to the permit
31 premises.

32 (2) If a licensee has sold alcoholic liquor to a temporary permit
33 holder, and a distributor directly delivers such alcoholic liquor to such
34 temporary permit holder, but such licensee's normal hours of operation
35 make immediate payment to the distributor impossible, the licensee may
36 pay the retailer and the retailer may pay the distributor for such alcoholic
37 liquor within 48 hours of the sale.

38 (3) Within three business days after the end of an event conducted
39 pursuant to a temporary permit, the temporary permit holder may sell back
40 to the retailer or farm winery from whom alcoholic liquor was purchased
41 any alcoholic liquor sold to the temporary permit holder for such event.

42 (4) Upon written permission from the director and after four business
43 days after the end of an event conducted pursuant to a temporary permit,

1 the temporary permit holder may sell back to the licensee from whom
2 alcoholic liquor was purchased any alcoholic liquor sold to the temporary
3 permit holder for such event.

4 ~~(j)~~(k) A temporary permit shall not be transferable or assignable.

5 ~~(k)~~(l) Each temporary permit holder shall not employ or use the
6 services of any person:

7 (1) Who is under ~~the age of~~ 18 years *of age* to serve alcoholic liquor;

8 (2) who is under ~~the age of~~ 21 years *of age* to mix or dispense drinks
9 containing alcoholic liquor;

10 (3) who is under ~~the age of~~ 21 years *of age* and not supervised by the
11 temporary permit holder or an employee who is at least 21 years of age;

12 (4) who has been convicted of a felony or of any crime involving a
13 morals charge to dispense, mix or serve alcoholic liquor; or

14 (5) who has been convicted within the previous two years of a
15 violation of any intoxicating liquor law of this state, any other state or the
16 United States, to dispense, mix or serve alcoholic liquor.

17 Sec. 3. K.S.A. 79-4108 is hereby amended to read as follows: 79-
18 4108. (a) All revenue collected or received by the director of taxation from
19 taxes imposed by K.S.A. 79-4101 ~~to~~ through 79-4105, and amendments
20 thereto, shall be remitted to the state treasurer in accordance with the
21 provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of
22 each such remittance, *except as provided for in subsection (b)*, the state
23 treasurer shall deposit the entire amount in the state treasury to the credit
24 of the state general fund. The state treasurer shall transfer any moneys
25 remaining in the county and city alcoholic liquor control enforcement fund
26 on the effective date of this act to the state general fund.

27 (b) *For each remittance of the taxes collected upon the gross receipts*
28 *derived from the sale of alcoholic liquor to consumers while on the*
29 *Kansas state fairgrounds, 30% shall be credited to the state general fund,*
30 *and the remainder shall be credited to the state fair capital improvements*
31 *fund established pursuant to K.S.A. 2-223, and amendments thereto. The*
32 *provisions of this subsection shall expire and have no effect if the state fair*
33 *is located outside the city limits of the city of Hutchinson, Kansas.*

34 Sec. 4. K.S.A. 79-41a03 is hereby amended to read as follows: 79-
35 41a03. (a) The tax levied and collected pursuant to K.S.A. 79-41a02, and
36 amendments thereto, shall become due and payable by the club, caterer,
37 drinking establishment, public venue or temporary permit holder monthly,
38 or on or before the 25th day of the month immediately succeeding the
39 month in which it is collected, but any club, caterer, drinking
40 establishment, public venue or temporary permit holder filing an annual or
41 quarterly return under the Kansas retailers' sales tax act, as prescribed in
42 K.S.A. 79-3607, and amendments thereto, shall, upon such conditions as
43 the secretary of revenue may prescribe, pay the tax required by this act on

1 the same basis and at the same time the club, caterer, drinking
2 establishment, public venue or temporary permit holder pays such retailers'
3 sales tax. Each club, caterer, drinking establishment, public venue or
4 temporary permit holder shall make a true report to the department of
5 revenue, on a form prescribed by the secretary of revenue, providing such
6 information as may be necessary to determine the amounts to which any
7 such tax shall apply for all gross receipts derived from the sale of alcoholic
8 liquor by the club, caterer, drinking establishment, public venue or
9 temporary permit holder for the applicable month or months, which report
10 shall be accompanied by the tax disclosed thereby. Records of gross
11 receipts derived from the sale of alcoholic liquor shall be kept separate and
12 apart from the records of other retail sales made by a club, caterer,
13 drinking establishment, public venue or temporary permit holder in order
14 to facilitate the examination of books and records as provided herein.

15 (b) The secretary of revenue or the secretary's authorized
16 representative shall have the right at all reasonable times during business
17 hours to make such examination and inspection of the books and records
18 of a club, caterer, drinking establishment, public venue or temporary
19 permit holder as may be necessary to determine the accuracy of such
20 reports required hereunder.

21 (c) The secretary of revenue is hereby authorized to administer and
22 collect the tax imposed hereunder and to adopt such rules and regulations
23 as may be necessary for the efficient and effective administration and
24 enforcement of the collection thereof. Whenever any club, caterer,
25 drinking establishment, public venue or temporary permit holder liable to
26 pay the tax imposed hereunder refuses or neglects to pay the same, the
27 amount, including any penalty, shall be collected in the manner prescribed
28 for the collection of the retailers' sales tax by K.S.A. 79-3617, and
29 amendments thereto.

30 (d) (1) The secretary of revenue shall remit all revenue collected
31 under the provisions of this act to the state treasurer in accordance with the
32 provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of
33 each such remittance, the state treasurer shall deposit the entire amount in
34 the state treasury.

35 (2) *Except as provided for in paragraph (3) and* subject to the
36 maintenance requirements of the local alcoholic liquor refund fund created
37 under K.S.A. 79-41a09, and amendments thereto, 25% of the remittance
38 shall be credited to the state general fund, 5% shall be credited to the
39 community alcoholism and intoxication programs fund created by K.S.A.
40 41-1126, and amendments thereto, and the balance shall be credited to the
41 local alcoholic liquor fund created by K.S.A. 79-41a04, and amendments
42 thereto.

43 (3) *For each remittance of the taxes collected upon the gross receipts*

1 *derived from the sale of alcoholic liquor by any temporary permit holder*
2 *to consumers while on the Kansas state fairgrounds, 30% shall be credited*
3 *to the state general fund, and the remainder shall be credited to the state*
4 *fair capital improvements fund established pursuant to K.S.A. 2-223, and*
5 *amendments thereto. The provisions of this subsection shall expire and*
6 *have no effect if the state fair is located outside the city limits of the city of*

8 (e) Whenever, in the judgment of the secretary of revenue, it is
9 necessary, in order to secure the collection of any tax, penalties or interest
10 due, or to become due, under the provisions of this act, the secretary may
11 require any person subject to such tax to file a bond with the director of
12 taxation under conditions established by and in such form and amount as
13 prescribed by rules and regulations adopted by the secretary.

14 (f) The amount of tax imposed by this act shall be assessed within
15 three years after the return is filed, and no proceedings in court for the
16 collection of such taxes shall be begun after the expiration of such period
17 except in the cases of fraud. In the case of a false or fraudulent return with
18 intent to evade tax, the tax may be assessed or a proceeding in court for
19 collection of such tax may be begun at any time, within two years from the
20 discovery of such fraud. No refund or credit shall be allowed by the
21 director after three years from the date of payment of the tax as provided
22 in this act unless before the expiration of such period a claim therefor is
23 filed by the taxpayer, and no suit or action to recover on any claim for
24 refund shall be commenced until after the expiration of six months from
25 the date of filing a claim therefor with the director. Before the expiration
26 of time prescribed in this section for the assessment of additional tax or the
27 filing of a claim for refund, the director is hereby authorized to enter into
28 an agreement in writing with the taxpayer consenting to the extension of
29 the periods of limitations for the assessment of tax or for the filing of a
30 claim for refund, at any time prior to the expiration of the periods of
31 limitations. The period so agreed upon may be extended by subsequent
32 agreements in writing made before the expiration of the period previously
33 agreed upon.
