1 AN ACT concerning taxation; relating to income tax~~s~~, addition and
2 subtraction modifications, treatment of deferred foreign income, global
3 intangible low-taxed income, business interest, capital contributions
4 and FDIC premiums~~s~~, Kansas itemized deduction, election; **sales and**
5 **compensating use tax, imposition of tax, nexus, remote sellers,**
6 **marketplace facilitators, food and food ingredients, rates;** amending
7 K.S.A. 2018 Supp. 79-32,117, 79-32,120 ~~and~~, 79-32,138, **79-3602, 79-**

11 *Be it enacted by the Legislature of the State of Kansas:*

12 Section 1. K.S.A. 2018 Supp. 79-32,117 is hereby amended to read as
13 follows: 79-32,117. (a) The Kansas adjusted gross income of an individual
14 means such individual's federal adjusted gross income for the taxable year,
15 with the modifications specified in this section.

16 (b) There shall be added to federal adjusted gross income:

17 (i) Interest income less any related expenses directly incurred in the
18 purchase of state or political subdivision obligations, to the extent that the
19 same is not included in federal adjusted gross income, on obligations of
20 any state or political subdivision thereof, but to the extent that interest
21 income on obligations of this state or a political subdivision thereof issued
22 prior to January 1, 1988, is specifically exempt from income tax under the
23 laws of this state authorizing the issuance of such obligations, it shall be
24 excluded from computation of Kansas adjusted gross income whether or
25 not included in federal adjusted gross income. Interest income on
26 obligations of this state or a political subdivision thereof issued after
27 December 31, 1987, shall be excluded from computation of Kansas
28 adjusted gross income whether or not included in federal adjusted gross
29 income.

30 (ii) Taxes on or measured by income or fees or payments in lieu of
31 income taxes imposed by this state or any other taxing jurisdiction to the
32 extent deductible in determining federal adjusted gross income and not

1 credited against federal income tax. This paragraph shall not apply to taxes
2 imposed under the provisions of K.S.A. 79-1107 or 79-1108, and
3 amendments thereto, for privilege tax year 1995, and all such years
4 thereafter.

5 (iii) The federal net operating loss deduction, except that the federal
6 net operating loss deduction shall not be added to an individual's federal
7 adjusted gross income for tax years beginning after December 31, 2016.

8 (iv) Federal income tax refunds received by the taxpayer if the
9 deduction of the taxes being refunded resulted in a tax benefit for Kansas
10 income tax purposes during a prior taxable year. Such refunds shall be
11 included in income in the year actually received regardless of the method
12 of accounting used by the taxpayer. For purposes hereof, a tax benefit shall
13 be deemed to have resulted if the amount of the tax had been deducted in
14 determining income subject to a Kansas income tax for a prior year
15 regardless of the rate of taxation applied in such prior year to the Kansas
16 taxable income, but only that portion of the refund shall be included as
17 bears the same proportion to the total refund received as the federal taxes
18 deducted in the year to which such refund is attributable bears to the total
19 federal income taxes paid for such year. For purposes of the foregoing
20 sentence, federal taxes shall be considered to have been deducted only to
21 the extent such deduction does not reduce Kansas taxable income below
22 zero.

23 (v) The amount of any depreciation deduction or business expense
24 deduction claimed on the taxpayer's federal income tax return for any
25 capital expenditure in making any building or facility accessible to the
26 handicapped, for which expenditure the taxpayer claimed the credit
27 allowed by K.S.A. 79-32,177, and amendments thereto.

28 (vi) Any amount of designated employee contributions picked up by
29 an employer pursuant to K.S.A. 12-5005, 20-2603, 74-4919 and 74-4965,
30 and amendments thereto.

31 (vii) The amount of any charitable contribution made to the extent the
32 same is claimed as the basis for the credit allowed pursuant to K.S.A. 79-
33 32,196, and amendments thereto.

34 (viii) The amount of any costs incurred for improvements to a swine
35 facility, claimed for deduction in determining federal adjusted gross
36 income, to the extent the same is claimed as the basis for any credit
37 allowed pursuant to K.S.A. 2018 Supp. 79-32,204, and amendments
38 thereto.

39 (ix) The amount of any ad valorem taxes and assessments paid and
40 the amount of any costs incurred for habitat management or construction
41 and maintenance of improvements on real property, claimed for deduction
42 in determining federal adjusted gross income, to the extent the same is
43 claimed as the basis for any credit allowed pursuant to K.S.A. 79-32,203,

1 and amendments thereto.

2 (x) Amounts received as nonqualified withdrawals, as defined by
3 K.S.A. 2018 Supp. 75-643, and amendments thereto, if, at the time of
4 contribution to a family postsecondary education savings account, such
5 amounts were subtracted from the federal adjusted gross income pursuant
6 to K.S.A. 79-32,117(c)(xv), and amendments thereto, or if such amounts
7 are not already included in the federal adjusted gross income.

8 (xi) The amount of any contribution made to the same extent the
9 same is claimed as the basis for the credit allowed pursuant to K.S.A. 74-
10 50,154, and amendments thereto.

11 (xii) For taxable years commencing after December 31, 2004,
12 amounts received as withdrawals not in accordance with the provisions of
13 K.S.A. 74-50,204, and amendments thereto, if, at the time of contribution
14 to an individual development account, such amounts were subtracted from
15 the federal adjusted gross income pursuant to subsection (c)(xiii), or if
16 such amounts are not already included in the federal adjusted gross
17 income.

18 (xiii) The amount of any expenditures claimed for deduction in
19 determining federal adjusted gross income, to the extent the same is
20 claimed as the basis for any credit allowed pursuant to K.S.A. 2018 Supp.
21 79-32,217 through 79-32,220 or 79-32,222, and amendments thereto.

22 (xiv) The amount of any amortization deduction claimed in
23 determining federal adjusted gross income to the extent the same is
24 claimed for deduction pursuant to K.S.A. 2018 Supp. 79-32,221, and
25 amendments thereto.

26 (xv) The amount of any expenditures claimed for deduction in
27 determining federal adjusted gross income, to the extent the same is
28 claimed as the basis for any credit allowed pursuant to K.S.A. 2018 Supp.
29 79-32,223 through 79-32,226, 79-32,228 through 79-32,231, 79-32,233
30 through 79-32,236, 79-32,238 through 79-32,241, 79-32,245 through 79-
31 32,248 or 79-32,251 through 79-32,254, and amendments thereto.

32 (xvi) The amount of any amortization deduction claimed in
33 determining federal adjusted gross income to the extent the same is
34 claimed for deduction pursuant to K.S.A. 2018 Supp. 79-32,227, 79-
35 32,232, 79-32,237, 79-32,249, 79-32,250 or 79-32,255, and amendments
36 thereto.

37 (xvii) The amount of any amortization deduction claimed in
38 determining federal adjusted gross income to the extent the same is
39 claimed for deduction pursuant to K.S.A. 2018 Supp. 79-32,256, and
40 amendments thereto.

41 (xviii) For taxable years commencing after December 31, 2006, the
42 amount of any ad valorem or property taxes and assessments paid to a state
43 other than Kansas or local government located in a state other than Kansas

1 by a taxpayer who resides in a state other than Kansas, when the law of
2 such state does not allow a resident of Kansas who earns income in such
3 other state to claim a deduction for ad valorem or property taxes or
4 assessments paid to a political subdivision of the state of Kansas in
5 determining taxable income for income tax purposes in such other state, to
6 the extent that such taxes and assessments are claimed as an itemized
7 deduction for federal income tax purposes.

8 (xix) For taxable years beginning after December 31, 2012, and
9 ending before January 1, 2017, the amount of any: (1) Loss from business
10 as determined under the federal internal revenue code and reported from
11 schedule C and on line 12 of the taxpayer's form 1040 federal individual
12 income tax return; (2) loss from rental real estate, royalties, partnerships, S
13 corporations, except those with wholly owned subsidiaries subject to the
14 Kansas privilege tax, estates, trusts, residual interest in real estate
15 mortgage investment conduits and net farm rental as determined under the
16 federal internal revenue code and reported from schedule E and on line 17
17 of the taxpayer's form 1040 federal individual income tax return; and (3)
18 farm loss as determined under the federal internal revenue code and
19 reported from schedule F and on line 18 of the taxpayer's form 1040
20 federal income tax return; all to the extent deducted or subtracted in
21 determining the taxpayer's federal adjusted gross income. For purposes of
22 this subsection, references to the federal form 1040 and federal schedule
23 C, schedule E, and schedule F, shall be to such form and schedules as they
24 existed for tax year 2011, and as revised thereafter by the internal revenue
25 service.

26 (xx) For taxable years beginning after December 31, 2012, and
27 ending before January 1, 2017, the amount of any deduction for self-
28 employment taxes under section 164(f) of the federal internal revenue
29 code as in effect on January 1, 2012, and amendments thereto, in
30 determining the federal adjusted gross income of an individual taxpayer, to
31 the extent the deduction is attributable to income reported on schedule C,
32 E or F and on line 12, 17 or 18 of the taxpayer's form 1040 federal income
33 tax return.

34 (xxi) For taxable years beginning after December 31, 2012, and
35 ending before January 1, 2017, the amount of any deduction for pension,
36 profit sharing, and annuity plans of self-employed individuals under
37 section 62(a)(6) of the federal internal revenue code as in effect on January
38 1, 2012, and amendments thereto, in determining the federal adjusted gross
39 income of an individual taxpayer.

40 (xxii) For taxable years beginning after December 31, 2012, and
41 ending before January 1, 2017, the amount of any deduction for health
42 insurance under section 162(l) of the federal internal revenue code as in
43 effect on January 1, 2012, and amendments thereto, in determining the

1 federal adjusted gross income of an individual taxpayer.

2 (xxiii) For taxable years beginning after December 31, 2012, and
3 ending before January 1, 2017, the amount of any deduction for domestic
4 production activities under section 199 of the federal internal revenue code
5 as in effect on January 1, 2012, and amendments thereto, in determining
6 the federal adjusted gross income of an individual taxpayer.

7 (xxiv) For taxable years commencing after December 31, 2013, that
8 portion of the amount of any expenditure deduction claimed in
9 determining federal adjusted gross income for expenses paid for medical
10 care of the taxpayer or the taxpayer's spouse or dependents when such
11 expenses were paid or incurred for an abortion, or for a health benefit plan,
12 as defined in K.S.A. 65-6731, and amendments thereto, for the purchase of
13 an optional rider for coverage of abortion in accordance with K.S.A. 2018
14 Supp. 40-2,190, and amendments thereto, to the extent that such taxes and
15 assessments are claimed as an itemized deduction for federal income tax
16 purposes.

17 (xxv) For taxable years commencing after December 31, 2013, that
18 portion of the amount of any expenditure deduction claimed in
19 determining federal adjusted gross income for expenses paid by a taxpayer
20 for health care when such expenses were paid or incurred for abortion
21 coverage, a health benefit plan, as defined in K.S.A. 65-6731, and
22 amendments thereto, when such expenses were paid or incurred for
23 abortion coverage or amounts contributed to health savings accounts for
24 such taxpayer's employees for the purchase of an optional rider for
25 coverage of abortion in accordance with K.S.A. 2018 Supp. 40-2,190, and
26 amendments thereto, to the extent that such taxes and assessments are
27 claimed as a deduction for federal income tax purposes.

28 (xxvi) For all taxable years beginning after December 31, 2016, the
29 amount of any charitable contribution made to the extent the same is
30 claimed as the basis for the credit allowed pursuant to K.S.A. 72-99a07,
31 and amendments thereto, and is also claimed as an itemized deduction for
32 federal income tax purposes.

33 *(xxvii) For all taxable years commencing after December 31, 2016,*
34 *the amount of any deduction claimed under section 965(c) of the federal*
35 *internal revenue code of 1986, in determining federal adjusted gross*
36 *income.*

37 *(xxviii) For all taxable years commencing after December 31, 2017,*
38 *the amount of any deduction claimed under section 250(a)(1)(B) of the*
39 *federal internal revenue code of 1986, in determining federal adjusted*
40 *gross income.*

41 *(xxiv) For all taxable years commencing after December 31, 2017,*
42 *the amount deducted by reason of a carry forward of disallowed business*
43 *interest pursuant to section 163(j) of the federal internal revenue code of*

1 *1986, as in effect on January 1, 2018.*

2 (c) There shall be subtracted from federal adjusted gross income:

3 (i) Interest or dividend income on obligations or securities of any
4 authority, commission or instrumentality of the United States and its
5 possessions less any related expenses directly incurred in the purchase of
6 such obligations or securities, to the extent included in federal adjusted
7 gross income but exempt from state income taxes under the laws of the
8 United States.

9 (ii) Any amounts received which are included in federal adjusted
10 gross income but which are specifically exempt from Kansas income
11 taxation under the laws of the state of Kansas.

12 (iii) The portion of any gain or loss from the sale or other disposition
13 of property having a higher adjusted basis for Kansas income tax purposes
14 than for federal income tax purposes on the date such property was sold or
15 disposed of in a transaction in which gain or loss was recognized for
16 purposes of federal income tax that does not exceed such difference in
17 basis, but if a gain is considered a long-term capital gain for federal
18 income tax purposes, the modification shall be limited to that portion of
19 such gain which is included in federal adjusted gross income.

20 (iv) The amount necessary to prevent the taxation under this act of
21 any annuity or other amount of income or gain which was properly
22 included in income or gain and was taxed under the laws of this state for a
23 taxable year prior to the effective date of this act, as amended, to the
24 taxpayer, or to a decedent by reason of whose death the taxpayer acquired
25 the right to receive the income or gain, or to a trust or estate from which
26 the taxpayer received the income or gain.

27 (v) The amount of any refund or credit for overpayment of taxes on
28 or measured by income or fees or payments in lieu of income taxes
29 imposed by this state, or any taxing jurisdiction, to the extent included in
30 gross income for federal income tax purposes.

31 (vi) Accumulation distributions received by a taxpayer as a
32 beneficiary of a trust to the extent that the same are included in federal
33 adjusted gross income.

34 (vii) Amounts received as annuities under the federal civil service
35 retirement system from the civil service retirement and disability fund and
36 other amounts received as retirement benefits in whatever form which
37 were earned for being employed by the federal government or for service
38 in the armed forces of the United States.

39 (viii) Amounts received by retired railroad employees as a
40 supplemental annuity under the provisions of 45 U.S.C. §§ 228b (a) and
41 228c (a)(1) et seq.

42 (ix) Amounts received by retired employees of a city and by retired
43 employees of any board of such city as retirement allowances pursuant to

1 K.S.A. 13-14,106, and amendments thereto, or pursuant to any charter
2 ordinance exempting a city from the provisions of K.S.A. 13-14,106, and
3 amendments thereto.

4 (x) For taxable years beginning after December 31, 1976, the amount
5 of the federal tentative jobs tax credit disallowance under the provisions of
6 26 U.S.C. § 280 C. For taxable years ending after December 31, 1978, the
7 amount of the targeted jobs tax credit and work incentive credit
8 disallowances under 26 U.S.C. § 280 C.

9 (xi) For taxable years beginning after December 31, 1986, dividend
10 income on stock issued by Kansas venture capital, inc.

11 (xii) For taxable years beginning after December 31, 1989, amounts
12 received by retired employees of a board of public utilities as pension and
13 retirement benefits pursuant to K.S.A. 13-1246, 13-1246a and 13-1249,
14 and amendments thereto.

15 (xiii) For taxable years beginning after December 31, 2004, amounts
16 contributed to and the amount of income earned on contributions deposited
17 to an individual development account under K.S.A. 74-50,201 et seq., and
18 amendments thereto.

19 (xiv) For all taxable years commencing after December 31, 1996, that
20 portion of any income of a bank organized under the laws of this state or
21 any other state, a national banking association organized under the laws of
22 the United States, an association organized under the savings and loan
23 code of this state or any other state, or a federal savings association
24 organized under the laws of the United States, for which an election as an
25 S corporation under subchapter S of the federal internal revenue code is in
26 effect, which accrues to the taxpayer who is a stockholder of such
27 corporation and which is not distributed to the stockholders as dividends of
28 the corporation. For taxable years beginning after December 31, 2012, and
29 ending before January 1, 2017, the amount of modification under this
30 subsection shall exclude the portion of income or loss reported on schedule
31 E and included on line 17 of the taxpayer's form 1040 federal individual
32 income tax return.

33 (xv) For all taxable years beginning after December 31, 2006,
34 amounts not exceeding \$3,000, or \$6,000 for a married couple filing a
35 joint return, for each designated beneficiary which are contributed to a
36 family postsecondary education savings account established under the
37 Kansas postsecondary education savings program or a qualified tuition
38 program established and maintained by another state or agency or
39 instrumentality thereof pursuant to section 529 of the internal revenue
40 code of 1986, as amended, for the purpose of paying the qualified higher
41 education expenses of a designated beneficiary at an institution of
42 postsecondary education. The terms and phrases used in this paragraph
43 shall have the meaning respectively ascribed thereto by the provisions of

1 K.S.A. 2018 Supp. 75-643, and amendments thereto, and the provisions of
2 such section are hereby incorporated by reference for all purposes thereof.

3 (xvi) For all taxable years beginning after December 31, 2004,
4 amounts received by taxpayers who are or were members of the armed
5 forces of the United States, including service in the Kansas army and air
6 national guard, as a recruitment, sign up or retention bonus received by
7 such taxpayer as an incentive to join, enlist or remain in the armed services
8 of the United States, including service in the Kansas army and air national
9 guard, and amounts received for repayment of educational or student loans
10 incurred by or obligated to such taxpayer and received by such taxpayer as
11 a result of such taxpayer's service in the armed forces of the United States,
12 including service in the Kansas army and air national guard.

13 (xvii) For all taxable years beginning after December 31, 2004,
14 amounts received by taxpayers who are eligible members of the Kansas
15 army and air national guard as a reimbursement pursuant to K.S.A. 48-
16 281, and amendments thereto, and amounts received for death benefits
17 pursuant to K.S.A. 48-282, and amendments thereto, or pursuant to section
18 1 or section 2 of chapter 207 of the 2005 Session Laws of Kansas, and
19 amendments thereto, to the extent that such death benefits are included in
20 federal adjusted gross income of the taxpayer.

21 (xviii) For the taxable year beginning after December 31, 2006,
22 amounts received as benefits under the federal social security act which
23 are included in federal adjusted gross income of a taxpayer with federal
24 adjusted gross income of \$50,000 or less, whether such taxpayer's filing
25 status is single, head of household, married filing separate or married filing
26 jointly; and for all taxable years beginning after December 31, 2007,
27 amounts received as benefits under the federal social security act which
28 are included in federal adjusted gross income of a taxpayer with federal
29 adjusted gross income of \$75,000 or less, whether such taxpayer's filing
30 status is single, head of household, married filing separate or married filing
31 jointly.

32 (xix) Amounts received by retired employees of Washburn university
33 as retirement and pension benefits under the university's retirement plan.

34 (xx) For taxable years beginning after December 31, 2012, and
35 ending before January 1, 2017, the amount of any: (1) Net profit from
36 business as determined under the federal internal revenue code and
37 reported from schedule C and on line 12 of the taxpayer's form 1040
38 federal individual income tax return; (2) net income, not including
39 guaranteed payments as defined in section 707(c) of the federal internal
40 revenue code and as reported to the taxpayer from federal schedule K-1,
41 (form 1065-B), in box 9, code F or as reported to the taxpayer from federal
42 schedule K-1, (form 1065) in box 4, from rental real estate, royalties,
43 partnerships, S corporations, estates, trusts, residual interest in real estate

1 mortgage investment conduits and net farm rental as determined under the
2 federal internal revenue code and reported from schedule E and on line 17
3 of the taxpayer's form 1040 federal individual income tax return; and (3)
4 net farm profit as determined under the federal internal revenue code and
5 reported from schedule F and on line 18 of the taxpayer's form 1040
6 federal income tax return; all to the extent included in the taxpayer's
7 federal adjusted gross income. For purposes of this subsection, references
8 to the federal form 1040 and federal schedule C, schedule E, and schedule
9 F, shall be to such form and schedules as they existed for tax year 2011
10 and as revised thereafter by the internal revenue service.

11 (xxi) For all taxable years beginning after December 31, 2013,
12 amounts equal to the unreimbursed travel, lodging and medical
13 expenditures directly incurred by a taxpayer while living, or a dependent
14 of the taxpayer while living, for the donation of one or more human organs
15 of the taxpayer, or a dependent of the taxpayer, to another person for
16 human organ transplantation. The expenses may be claimed as a
17 subtraction modification provided for in this section to the extent the
18 expenses are not already subtracted from the taxpayer's federal adjusted
19 gross income. In no circumstances shall the subtraction modification
20 provided for in this section for any individual, or a dependent, exceed
21 \$5,000. As used in this section, "human organ" means all or part of a liver,
22 pancreas, kidney, intestine, lung or bone marrow. The provisions of this
23 paragraph shall take effect on the day the secretary of revenue certifies to
24 the director of the budget that the cost for the department of revenue of
25 modifications to the automated tax system for the purpose of
26 implementing this paragraph will not exceed \$20,000.

27 (xxii) For taxable years beginning after December 31, 2012, and
28 ending before January 1, 2017, the amount of net gain from the sale of: (1)
29 Cattle and horses, regardless of age, held by the taxpayer for draft,
30 breeding, dairy or sporting purposes, and held by such taxpayer for 24
31 months or more from the date of acquisition; and (2) other livestock,
32 regardless of age, held by the taxpayer for draft, breeding, dairy or
33 sporting purposes, and held by such taxpayer for 12 months or more from
34 the date of acquisition. The subtraction from federal adjusted gross income
35 shall be limited to the amount of the additions recognized under the
36 provisions of subsection (b)(xix) attributable to the business in which the
37 livestock sold had been used. As used in this paragraph, the term
38 "livestock" shall not include poultry.

39 (xxiii) For all taxable years beginning after December 31, 2012,
40 amounts received under either the Overland Park, Kansas police
41 department retirement plan or the Overland Park, Kansas fire department
42 retirement plan, both as established by the city of Overland Park, pursuant
43 to the city's home rule authority.

1 (xxiv) For taxable years beginning after December 31, 2013, and
2 ending before January 1, 2017, the net gain from the sale from Christmas
3 trees grown in Kansas and held by the taxpayer for six years or more.

4 (xxv) *For all taxable years commencing after December 31, 2016,*
5 *100% of deferred foreign income as used in determining federal adjusted*
6 *gross income. ~~Deferred foreign income shall include income under section~~*
7 *965(a) of the federal internal revenue code of 1986, before any deductions*
8 *allowed under section 965(c) of the code.*

9 (xxvi) *For all taxable years commencing after December 31, 2017,*
10 *100% of global intangible low-taxed income. ~~Global intangible low-taxed~~*
11 *income shall include income under section 951A of the federal internal*
12 *revenue code of 1986, before any deductions allowed under section 250(a)*
13 *(1)(B) of the code.*

14 (xxvii) *For all taxable years commencing after December 31, 2017,*
15 *the amount disallowed as a deduction pursuant to section 163(j) of the*
16 *federal internal revenue code of 1986, as in effect on January 1, 2018.*

17 (d) There shall be added to or subtracted from federal adjusted gross
18 income the taxpayer's share, as beneficiary of an estate or trust, of the
19 Kansas fiduciary adjustment determined under K.S.A. 79-32,135, and
20 amendments thereto.

21 (e) The amount of modifications required to be made under this
22 section by a partner which relates to items of income, gain, loss, deduction
23 or credit of a partnership shall be determined under K.S.A. 79-32,131, and
24 amendments thereto, to the extent that such items affect federal adjusted
25 gross income of the partner.

26 (f) No taxpayer shall be assessed penalties and interest from the
27 underpayment of taxes due to changes to this section that became law on
28 July 1, 2017, so long as such underpayment is rectified on or before April
29 17, 2018.

30 (g) ~~*A taxpayer may file an amended return, as provided by law, for a*~~
31 ~~*prior tax year due to any changes to this section that became law on July*~~
32 ~~*1, 2019. Any changes to this section that became law on July 1, 2019,*~~
33 ~~*shall be applied retroactively to the dates indicated in those subsections.*~~

34 Sec. 2. K.S.A. 2018 Supp. 79-32,120 is hereby amended to read as
35 follows: 79-32,120. (a) (1) *For all tax years prior to tax year 2018, if*
36 *federal taxable income of an individual is determined by itemizing*
37 *deductions from such individual's federal adjusted gross income, such*

26 **(h) "Delivered electronically" means delivered to the purchaser**
27 **by means other than tangible storage media.**

31 **including, but not limited to, transportation, shipping, postage,**

33 **charges for delivery of direct mail if the charges are separately stated**

40 **property supplied directly or indirectly by the purchaser to the direct**
41 **mail seller for inclusion in the package containing the printed**
42 **material. Direct mail does not include multiple items of printed**
43 **material delivered to a single address.**

1 (k) "Director" means the state director of taxation.

2 (l) "Educational institution" means any nonprofit school, college
3 and university that offers education at a level above the 12th grade,
4 and conducts regular classes and courses of study required for
5 accreditation by, or membership in, the higher learning commission,
6 the state board of education, or that otherwise qualify as an
7 "educational institution," as defined by K.S.A. 74-50,103, and
8 amendments thereto. Such phrase shall include: (1) A group of
9 educational institutions that operates exclusively for an educational
10 purpose; (2) nonprofit endowment associations and foundations
11 organized and operated exclusively to receive, hold, invest and
12 administer moneys and property as a permanent fund for the support
13 and sole benefit of an educational institution; (3) nonprofit trusts,
14 foundations and other entities organized and operated principally to
15 hold and own receipts from intercollegiate sporting events and to
16 disburse such receipts, as well as grants and gifts, in the interest of
17 collegiate and intercollegiate athletic programs for the support and
18 sole benefit of an educational institution; and (4) nonprofit trusts,
19 foundations and other entities organized and operated for the primary
20 purpose of encouraging, fostering and conducting scholarly
21 investigations and industrial and other types of research for the
22 support and sole benefit of an educational institution.

23 (m) "Electronic" means relating to technology having electrical,
24 digital, magnetic, wireless, optical, electromagnetic or similar
25 capabilities.

26 (n) "Food and food ingredients" means substances, whether in
27 liquid, concentrated, solid, frozen, dried or dehydrated form, that are
28 sold for ingestion or chewing by humans and are consumed for their
29 taste or nutritional value. "Food and food ingredients" does not
30 include alcoholic beverages, ~~candy, dietary supplements, food sold~~
31 ~~through vending machines, soft drinks~~ or tobacco. "Food and food
32 ingredients" ~~does include bottled water~~ {includes any items eligible to be
33 purchased with food stamps issued by the United States department of
34 agriculture}.

35 (o) "Gross receipts" means the total selling price or the amount
36 received as defined in this act, in money, credits, property or other
37 consideration valued in money from sales at retail within this state;
38 and embraced within the provisions of this act. The taxpayer, may
39 take credit in the report of gross receipts for: (1) An amount equal to
40 the selling price of property returned by the purchaser when the full
41 sale price thereof, including the tax collected, is refunded in cash or by
42 credit; and (2) an amount equal to the allowance given for the trade-in
43 of property.

1 **(p) "Ingredient or component part" means tangible personal**
2 **property which is necessary or essential to, and which is actually used**
3 **in and becomes an integral and material part of tangible personal**
4 **property or services produced, manufactured or compounded for sale**
5 **by the producer, manufacturer or compounder in its regular course of**
6 **business. The following items of tangible personal property are hereby**
7 **declared to be ingredients or component parts, but the listing of such**
8 **property shall not be deemed to be exclusive nor shall such listing be**
9 **construed to be a restriction upon, or an indication of, the type or**
10 **types of property to be included within the definition of "ingredient or**
11 **component part" as herein set forth:**

12 **(1) Containers, labels and shipping cases used in the distribution**
13 **of property produced, manufactured or compounded for sale which**
14 **are not to be returned to the producer, manufacturer or compounder**
15 **for reuse.**

16 **(2) Containers, labels, shipping cases, paper bags, drinking**
17 **straws, paper plates, paper cups, twine and wrapping paper used in**
18 **the distribution and sale of property taxable under the provisions of**
19 **this act by wholesalers and retailers and which is not to be returned to**
20 **such wholesaler or retailer for reuse.**

21 **(3) Seeds and seedlings for the production of plants and plant**
22 **products produced for resale.**

23 **(4) Paper and ink used in the publication of newspapers.**

24 **(5) Fertilizer used in the production of plants and plant products**
25 **produced for resale.**

26 **(6) Feed for animals, fowl and aquatic plants and animals, the**
27 **primary purpose of which is use in agriculture or aquaculture, as**
28 **defined in K.S.A. 47-1901, and amendments thereto, the production of**
29 **food for human consumption, the production of animal, dairy, poultry**
30 **or aquatic plant and animal products, fiber, fur, or the production of**
31 **offspring for use for any such purpose or purposes.**

32 **(q) "Isolated or occasional sale" means the nonrecurring sale of**
33 **tangible personal property, or services taxable hereunder by a person**
34 **not engaged at the time of such sale in the business of selling such**
35 **property or services. Any religious organization which makes a**
36 **nonrecurring sale of tangible personal property acquired for the**
37 **purpose of resale shall be deemed to be not engaged at the time of such**
38 **sale in the business of selling such property. Such term shall include:**
39 **(1) Any sale by a bank, savings and loan institution, credit union or**
40 **any finance company licensed under the provisions of the Kansas**
41 **uniform consumer credit code of tangible personal property which has**
42 **been repossessed by any such entity; and (2) any sale of tangible**
43 **personal property made by an auctioneer or agent on behalf of not**

1 more than two principals or households if such sale is nonrecurring
2 and any such principal or household is not engaged at the time of such
3 sale in the business of selling tangible personal property.

4 (r) "Lease or rental" means any transfer of possession or control
5 of tangible personal property for a fixed or indeterminate term for
6 consideration. A lease or rental may include future options to purchase
7 or extend.

8 (1) Lease or rental does not include: (A) A transfer of possession
9 or control of property under a security agreement or deferred
10 payment plan that requires the transfer of title upon completion of the
11 required payments;

12 (B) a transfer or possession or control of property under an
13 agreement that requires the transfer of title upon completion of
14 required payments and payment of an option price does not exceed
15 the greater of \$100 or 1% of the total required payments; or

16 (C) providing tangible personal property along with an operator
17 for a fixed or indeterminate period of time. A condition of this
18 exclusion is that the operator is necessary for the equipment to
19 perform as designed. For the purpose of this subsection, an operator
20 must do more than maintain, inspect or set-up the tangible personal
21 property.

22 (2) Lease or rental does include agreements covering motor
23 vehicles and trailers where the amount of consideration may be
24 increased or decreased by reference to the amount realized upon sale
25 or disposition of the property as defined in 26 U.S.C. § 7701(h)(1).

26 (3) This definition shall be used for sales and use tax purposes
27 regardless if a transaction is characterized as a lease or rental under
28 generally accepted accounting principles, the internal revenue code,
29 the uniform commercial code, K.S.A. 84-1-101 et seq., and
30 amendments thereto, or other provisions of federal, state or local law.

31 (4) This definition will be applied only prospectively from the
32 effective date of this act and will have no retroactive impact on
33 existing leases or rentals.

34 (s) "Load and leave" means delivery to the purchaser by use of a
35 tangible storage media where the tangible storage media is not
36 physically transferred to the purchaser.

37 (t) "Member state" means a state that has entered in the
38 agreement, pursuant to provisions of article VIII of the agreement.

39 (u) "Model 1 seller" means a seller that has selected a CSP as its
40 agent to perform all the seller's sales and use tax functions, other than
41 the seller's obligation to remit tax on its own purchases.

42 (v) "Model 2 seller" means a seller that has selected a CAS to
43 perform part of its sales and use tax functions, but retains

1 responsibility for remitting the tax.

2 (w) "Model 3 seller" means a seller that has sales in at least five
3 member states, has total annual sales revenue of at least \$500,000,000,
4 has a proprietary system that calculates the amount of tax due each
5 jurisdiction and has entered into a performance agreement with the
6 member states that establishes a tax performance standard for the
7 seller. As used in this subsection a seller includes an affiliated group of
8 sellers using the same proprietary system.

9 (x) "Municipal corporation" means any city incorporated under
10 the laws of Kansas.

11 (y) "Nonprofit blood bank" means any nonprofit place,
12 organization, institution or establishment that is operated wholly or in
13 part for the purpose of obtaining, storing, processing, preparing for
14 transfusing, furnishing, donating or distributing human blood or parts
15 or fractions of single blood units or products derived from single blood
16 units, whether or not any remuneration is paid therefor, or whether
17 such procedures are done for direct therapeutic use or for storage for
18 future use of such products.

19 (z) "Persons" means any individual, firm, copartnership, joint
20 adventure, association, corporation, estate or trust, receiver or trustee,
21 or any group or combination acting as a unit, and the plural as well as
22 the singular number; and shall specifically mean any city or other
23 political subdivision of the state of Kansas engaging in a business or
24 providing a service specifically taxable under the provisions of this act.

25 (aa) "Political subdivision" means any municipality, agency or
26 subdivision of the state which is, or shall hereafter be, authorized to
27 levy taxes upon tangible property within the state or which certifies a
28 levy to a municipality, agency or subdivision of the state which is, or
29 shall hereafter be, authorized to levy taxes upon tangible property
30 within the state. Such term also shall include any public building
31 commission, housing, airport, port, metropolitan transit or similar
32 authority established pursuant to law and the horsethief reservoir
33 benefit district established pursuant to K.S.A. 82a-2201, and
34 amendments thereto.

35 (bb) "Prescription" means an order, formula or recipe issued in
36 any form of oral, written, electronic or other means of transmission by
37 a duly licensed practitioner authorized by the laws of this state.

38 (cc) "Prewritten computer software" means computer software,
39 including prewritten upgrades, which is not designed and developed
40 by the author or other creator to the specifications of a specific
41 purchaser. The combining of two or more prewritten computer
42 software programs or prewritten portions thereof does not cause the
43 combination to be other than prewritten computer software.

1 Prewritten computer software includes software designed and
2 developed by the author or other creator to the specifications of a
3 specific purchaser when it is sold to a person other than the purchaser.
4 Where a person modifies or enhances computer software of which the
5 person is not the author or creator, the person shall be deemed to be
6 the author or creator only of such person's modifications or
7 enhancements. Prewritten computer software or a prewritten portion
8 thereof that is modified or enhanced to any degree, where such
9 modification or enhancement is designed and developed to the
10 specifications of a specific purchaser, remains prewritten computer
11 software, except that where there is a reasonable, separately stated
12 charge or an invoice or other statement of the price given to the
13 purchaser for such modification or enhancement, such modification or
14 enhancement shall not constitute prewritten computer software.

15 (dd) "Property which is consumed" means tangible personal
16 property which is essential or necessary to and which is used in the
17 actual process of and consumed, depleted or dissipated within one
18 year in: (1) The production, manufacture, processing, mining, drilling,
19 refining or compounding of tangible personal property; (2) the
20 providing of services; (3) the irrigation of crops, for sale in the regular
21 course of business; or (4) the storage or processing of grain by a public
22 grain warehouse or other grain storage facility, and which is not
23 reusable for such purpose. The following is a listing of tangible
24 personal property, included by way of illustration but not of
25 limitation, which qualifies as property which is consumed:

26 (A) Insecticides, herbicides, germicides, pesticides, fungicides,
27 fumigants, antibiotics, biologicals, pharmaceuticals, vitamins and
28 chemicals for use in commercial or agricultural production,
29 processing or storage of fruit, vegetables, feeds, seeds, grains, animals
30 or animal products whether fed, injected, applied, combined with or
31 otherwise used;

32 (B) electricity, gas and water; and

33 (C) petroleum products, lubricants, chemicals, solvents, reagents

35 (ee) "Purchase price" applies to the measure subject to use tax
36 and has the same meaning as sales price.

37 (ff) "Purchaser" means a person to whom a sale of personal
38 property is made or to whom a service is furnished.

39 (gg) "Quasi-municipal corporation" means any county, township,
40 school district, drainage district or any other governmental
41 subdivision in the state of Kansas having authority to receive or hold
42 moneys or funds.

43 (hh) "Registered under this agreement" means registration by a

1 seller with the member states under the central registration system
2 provided in article IV of the agreement.

3 (ii) "Retailer" means a seller regularly engaged in the business of
4 selling, leasing or renting tangible personal property at retail or
5 furnishing electrical energy, gas, water, services or entertainment, and
6 selling only to the user or consumer and not for resale.

7 (jj) "Retail sale" or "sale at retail" means any sale, lease or rental
8 for any purpose other than for resale, sublease or subrent.

9 (kk) "Sale" or "sales" means the exchange of tangible personal
10 property, as well as the sale thereof for money, and every transaction,
11 conditional or otherwise, for a consideration, constituting a sale,
12 including the sale or furnishing of electrical energy, gas, water,
13 services or entertainment taxable under the terms of this act and
14 including, except as provided in the following provision, the sale of the
15 use of tangible personal property by way of a lease, license to use or
16 the rental thereof regardless of the method by which the title,
17 possession or right to use the tangible personal property is
18 transferred. The term "sale" or "sales" shall not mean the sale of the
19 use of any tangible personal property used as a dwelling by way of a
20 lease or rental thereof for a term of more than 28 consecutive days.

21 (ll) (1) "Sales or selling price" applies to the measure subject to
22 sales tax and means the total amount of consideration, including cash,
23 credit, property and services, for which personal property or services
24 are sold, leased or rented, valued in money, whether received in money
25 or otherwise, without any deduction for the following:

26 (A) The seller's cost of the property sold;

27 (B) the cost of materials used, labor or service cost, interest,
28 losses, all costs of transportation to the seller, all taxes imposed on the
29 seller and any other expense of the seller;

30 (C) charges by the seller for any services necessary to complete
31 the sale, other than delivery and installation charges;

32 (D) delivery charges; and

33 (E) installation charges.

34 (2) "Sales or selling price" includes consideration received by the
35 seller from third parties if:

36 (A) The seller actually receives consideration from a party other
37 than the purchaser and the consideration is directly related to a price
38 reduction or discount on the sale;

39 (B) the seller has an obligation to pass the price reduction or
40 discount through to the purchaser;

41 (C) the amount of the consideration attributable to the sale is
42 fixed and determinable by the seller at the time of the sale of the item
43 to the purchaser; and

1 (D) one of the following criteria is met:

2 (i) The purchaser presents a coupon, certificate or other
3 documentation to the seller to claim a price reduction or discount
4 where the coupon, certificate or documentation is authorized,
5 distributed or granted by a third party with the understanding that
6 the third party will reimburse any seller to whom the coupon,
7 certificate or documentation is presented;

8 (ii) the purchaser identifies to the seller that the purchaser is a
9 member of a group or organization entitled to a price reduction or
10 discount. A preferred customer card that is available to any patron
11 does not constitute membership in such a group; or

12 (iii) the price reduction or discount is identified as a third party
13 price reduction or discount on the invoice received by the purchaser or
14 on a coupon, certificate or other documentation presented by the
15 purchaser.

16 (3) "Sales or selling price" shall not include:

17 (A) Discounts, including cash, term or coupons that are not
18 reimbursed by a third party that are allowed by a seller and taken by
19 a purchaser on a sale;

20 (B) interest, financing and carrying charges from credit extended
21 on the sale of personal property or services, if the amount is separately
22 stated on the invoice, bill of sale or similar document given to the
23 purchaser;

24 (C) any taxes legally imposed directly on the consumer that are
25 separately stated on the invoice, bill of sale or similar document given
26 to the purchaser;

27 (D) the amount equal to the allowance given for the trade-in of
28 property, if separately stated on the invoice, billing or similar
29 document given to the purchaser; and

30 (E) commencing on July 1, 2018, and ending on June 30, 2021,
31 cash rebates granted by a manufacturer to a purchaser or lessee of a
32 new motor vehicle if paid directly to the retailer as a result of the
33 original sale.

34 (mm) "Seller" means a person making sales, leases or rentals of
35 personal property or services.

36 (nn) "Service" means those services described in and taxed under
37 the provisions of K.S.A. 79-3603, and amendments thereto.

38 (oo) "Sourcing rules" means the rules set forth in K.S.A. 2018
39 Supp. 79-3670 through 79-3673, K.S.A. 12-191 and 12-191a, and
40 amendments thereto, which shall apply to identify and determine the
41 state and local taxing jurisdiction sales or use taxes to pay, or collect
42 and remit on a particular retail sale.

43 (pp) "Tangible personal property" means personal property that

1 can be seen, weighed, measured, felt or touched, or that is in any other
2 manner perceptible to the senses. Tangible personal property includes
3 electricity, water, gas, steam and prewritten computer software.

4 (qq) "Taxpayer" means any person obligated to account to the
5 director for taxes collected under the terms of this act.

6 (rr) "Tobacco" means cigarettes, cigars, chewing or pipe tobacco
7 or any other item that contains tobacco.

8 (ss) "Entity-based exemption" means an exemption based on who
9 purchases the product or who sells the product. An exemption that is
10 available to all individuals shall not be considered an entity-based
11 exemption.

12 (tt) "Over-the-counter drug" means a drug that contains a label
13 that identifies the product as a drug as required by 21 C.F.R. § 201.66.
14 The over-the-counter drug label includes: (1) A drug facts panel; or (2)
15 a statement of the active ingredients with a list of those ingredients
16 contained in the compound, substance or preparation. Over-the-
17 counter drugs do not include grooming and hygiene products such as
18 soaps, cleaning solutions, shampoo, toothpaste, antiperspirants and

20 (uu) "Ancillary services" means services that are associated with

30 ancillary service of separately stating information pertaining to

32 (xx) "Directory assistance" means an ancillary service of
33 providing telephone number information or address information, or

35 (yy) "Vertical service" means an ancillary service that is offered
36 in connection with one or more telecommunications services, which
37 offers advanced calling features that allow customers to identify
38 callers and to manage multiple calls and call connections, including
39 conference bridging services.

40 (zz) "Voice mail service" means an ancillary service that enables
41 the customer to store, send or receive recorded messages. Voice mail
42 service does not include any vertical services that the customer may be
43 required to have in order to utilize the voice mail service.

1 **(aaa) "Telecommunications service" means the electronic**
2 **transmission, conveyance or routing of voice, data, audio, video or any**
3 **other information or signals to a point, or between or among points.**
4 **The term telecommunications service includes such transmission,**
5 **conveyance or routing in which computer processing applications are**
6 **used to act on the form, code or protocol of the content for purposes of**

39 **(ccc) "900 service" means an inbound toll telecommunications**
40 **service purchased by a subscriber that allows the subscriber's**

43 **services provided by the seller of the telecommunications services to**

1 the subscriber, or service or product sold by the subscriber to the

5 (ddd) "Value-added non-voice data service" means a service that
6 otherwise meets the definition of telecommunications services in which

10 (eee) "International" means a telecommunications service that
11 originates or terminates in the United States and terminates or
12 originates outside the United States, respectively. United States
13 includes the District of Columbia or a U.S. territory or possession.

14 (fff) "Interstate" means a telecommunications service that
15 originates in one United States state, or a United States territory or
16 possession, and terminates in a different United States state or a
17 United States territory or possession.

18 (ggg) "Intrastate" means a telecommunications service that
19 originates in one United States state or a United States territory or
20 possession, and terminates in the same United States state or a United
21 States territory or possession.
