

**SENATE BILL No. 239**

1 AN ACT concerning public assistance; relating to food assistance;  
2 limitations; authorizing the secretary for children and families to  
3 request a waiver from work requirements in the food assistance  
4 program if there are insufficient jobs; amending K.S.A. 2020 Supp. 39-  
5 709 and repealing the existing section.  
6

7 *Be it enacted by the Legislature of the State of Kansas:*

8 Section 1. K.S.A. 2020 Supp. 39-709 is hereby amended to read as  
9 follows: 39-709. (a) *General eligibility requirements for assistance for*  
10 *which federal moneys are expended.* Subject to the additional requirements  
11 below, assistance in accordance with plans under which federal moneys  
12 are expended may be granted to any needy person who:

13 (1) Has insufficient income or resources to provide a reasonable  
14 subsistence compatible with decency and health. Where a husband and  
15 wife or cohabiting partners are living together, the combined income or  
16 resources of both shall be considered in determining the eligibility of  
17 either or both for such assistance unless otherwise prohibited by law. The  
18 secretary, in determining need of any applicant for or recipient of  
19 assistance shall not take into account the financial responsibility of any  
20 individual for any applicant or recipient of assistance unless such applicant  
21 or recipient is such individual's spouse, cohabiting partner or such  
22 individual's minor child or minor stepchild if the stepchild is living with  
23 such individual. The secretary in determining need of an individual may  
24 provide such income and resource exemptions as may be permitted by  
25 federal law. For purposes of eligibility for temporary assistance for needy  
26 families, for food assistance and for any other assistance provided through  
27 the Kansas department for children and families under which federal  
28 moneys are expended, the secretary for children and families shall  
29 consider one motor vehicle owned by the applicant for assistance,  
30 regardless of the value of such vehicle, as exempt personal property and  
31 shall consider any equity in any boat, personal water craft, recreational  
32 vehicle, recreational off-highway vehicle or all-terrain vehicle, as defined  
33 by K.S.A. 8-126, and amendments thereto, or any additional motor vehicle  
34 owned by the applicant for assistance to be a nonexempt resource of the  
35 applicant for assistance except that any additional motor vehicle used by  
36 the applicant, the applicant's spouse or the applicant's cohabiting partner

1 for the primary purpose of earning income may be considered as exempt  
2 personal property in the secretary's discretion.

3 (2) Is a citizen of the United States or is an alien lawfully admitted to  
4 the United States and who is residing in the state of Kansas.

5 (b) *Temporary assistance for needy families.* Assistance may be  
6 granted under this act to any dependent child, or relative, subject to the  
7 general eligibility requirements as set out in subsection (a), who resides in  
8 the state of Kansas or whose parent or other relative with whom the child  
9 is living resides in the state of Kansas. Such assistance shall be known as  
10 temporary assistance for needy families. Where the husband and wife or  
11 cohabiting partners are living together, both shall register for work under  
12 the program requirements for temporary assistance for needy families in  
13 accordance with criteria and guidelines prescribed by rules and regulations  
14 of the secretary.

15 (1) As used in this subsection, "family group" or "household" means  
16 the applicant or recipient for TANF, child care subsidy or employment  
17 services and all individuals living together in which there is a relationship  
18 of legal responsibility or a qualifying caretaker relationship. This will  
19 include a cohabiting boyfriend or girlfriend living with the person legally  
20 responsible for the child. The family group shall not be eligible for TANF  
21 if the family group contains at least one adult member who has received  
22 TANF, including the federal TANF assistance received in any other state,  
23 for 24 calendar months beginning on and after October 1, 1996, unless the  
24 secretary determines a hardship exists and grants an extension allowing  
25 receipt of TANF until the 36-month limit is reached. No extension beyond  
26 36 months shall be granted. Hardship provisions for a recipient include:

27 (A) Is a caretaker of a disabled family member living in the  
28 household;

29 (B) has a disability which precludes employment on a long-term basis  
30 or requires substantial rehabilitation;

31 (C) needs a time limit extension to overcome the effects of domestic  
32 violence/sexual assault;

33 (D) is involved with prevention and protection services-(PPS) and has  
34 an open social service plan; or

35 (E) is determined by the 24<sup>th</sup> month to have an extreme hardship other  
36 than what is designated in criteria listed in subparagraphs (A) through (D).  
37 This determination ~~will~~ shall be made by the executive review team.

38 (2) All adults applying for TANF shall be required to complete a  
39 work program assessment as specified by the Kansas department for  
40 children and families, including those who have been disqualified for or  
41 denied TANF due to non-cooperation, drug testing requirements or fraud.  
42 Adults who are not otherwise eligible for TANF, such as ineligible aliens,  
43 relative/non-relative caretakers and adults receiving supplemental security

1 income are not required to complete the assessment process. During the  
2 application processing period, applicants ~~must~~ shall complete at least one  
3 module or its equivalent of the work program assessment to be considered  
4 eligible for TANF benefits, unless good cause is found to be exempt from  
5 the requirements. Good cause exemptions shall only include:

6 (A) The applicant can document an existing certification verifying  
7 completion of the work program assessment;

8 (B) the applicant has a valid offer of employment or is employed a  
9 minimum of 20 hours a week;

10 (C) the applicant is a parenting teen without a GED or high school  
11 diploma;

12 (D) the applicant is enrolled in job corps;

13 (E) the applicant is working with a refugee social services agency; or

14 (F) the applicant has completed the work program assessment within  
15 the last 12 months.

16 (3) The department for children and families shall maintain a  
17 sufficient level of dedicated work program staff to enable the agency to  
18 conduct work program case management services to TANF recipients in a  
19 timely manner and in full accordance with state law and agency policy.

20 (4) TANF mandatory work program applicants and recipients shall  
21 participate in work components that lead to competitive, integrated  
22 employment. Components are defined by the federal government as being  
23 either primary or secondary. In order to meet federal work participation  
24 requirements, households ~~need to~~ shall meet at least 30 hours of  
25 participation per week, at least 20 hours of which need to be primary and  
26 at least 10 hours may be secondary components in one parent households  
27 where the youngest child is six years of age or older. Participation hours  
28 shall be 55 hours in two parent households ~~(, or 35 hours per week if child~~  
29 ~~care is not used)~~. The maximum assignment is 40 hours per week per  
30 individual. For two parent families to meet the federal work participation  
31 rate both parents ~~must~~ shall participate in a combined total of 55 hours per  
32 week, 50 hours of which ~~must~~ shall be in primary components, or one or  
33 both parents could be assigned a combined total of 35 hours per week ~~(, 30~~  
34 ~~hours of which~~ ~~must~~ shall be primary components), if department for  
35 children and families paid child care is not received by the family. Single  
36 parent families with a child under age six meet the federal participation  
37 requirement if the parent is engaged in work or work activities for at least  
38 20 hours per week in a primary work component. The following  
39 components meet federal definitions of primary hours of participation: Full  
40 or part-time employment, apprenticeship, work study, self-employment,  
41 job corps, subsidized employment, work experience sites, on-the-job  
42 training, supervised community service, vocational education, job search  
43 and job readiness. Secondary components include: Job skills training,

1 education directly related to employment such as adult basic education and  
2 English as a second language, and completion of a high school diploma or  
3 GED.

4 (5) A parent or other adult caretaker personally providing care for a  
5 child under the age of three months in their TANF household is exempt  
6 from work participation activities until the month the child turns three  
7 months of age. Such three-month limitation shall not apply to a parent or  
8 other adult caretaker who is personally providing care for a child born  
9 significantly premature, with serious medical conditions or with a  
10 disability as defined by the secretary, in consultation with the secretary of  
11 health and environment, and adopted in the rules and regulations. The  
12 three-month period is defined as two consecutive months starting with the  
13 month after childbirth. The exemption for caring for a child under three  
14 months cannot be claimed:

15 (A) By either parent when two parents are in the home and the  
16 household meets the two-parent definition for federal reporting purposes;

17 (B) by one parent or caretaker when the other parent or caretaker is in  
18 the home, and available, capable and suitable to provide care and the  
19 household does not meet the two-parent definition for federal reporting  
20 purposes;

21 (C) by a person age 19 or younger when such person is pregnant or a  
22 parent of a child in the home and the person does not possess a high school  
23 diploma or its equivalent. Such person shall become exempt the month  
24 such person turns age 20; or

25 (D) by any person assigned to a work participation activity for  
26 substance use disorders.

27 (6) TANF work experience placements shall be reviewed after 90  
28 days and are limited to six months per 24-month lifetime limit. A client's  
29 progress shall be reviewed prior to each new placement regardless of the  
30 length of time they are at the work experience site.

31 (7) TANF participants with disabilities shall engage in required  
32 employment activities to the maximum extent consistent with their  
33 abilities. TANF participants shall provide current documentation by a  
34 qualified medical practitioner that details the abilities to engage in  
35 employment and any limitations in work activities along with the expected  
36 duration of such limitations. Disability is defined as a physical or mental  
37 impairment constituting or resulting in a substantial impediment to  
38 employment for such individual.

39 (8) Non-cooperation is the failure of the applicant or recipient to  
40 comply with all requirements provided in state and federal law, federal and  
41 state rules and regulations and agency policy. The period of ineligibility  
42 for TANF benefits based on non-cooperation with work programs shall be  
43 as follows:

1 (A) For a first penalty, three months and full cooperation with work  
2 program activities;

3 (B) for a second penalty, six months and full cooperation with work  
4 program activities;

5 (C) for a third penalty, one year and full cooperation with work  
6 program activities; and

7 (D) for a fourth or subsequent penalty, 10 years.

8 (9) Individuals that have not cooperated with TANF work programs  
9 shall be ineligible to participate in the food assistance program. The  
10 comparable penalty shall be applied to only the individual in the food  
11 assistance program who failed to comply with the TANF work  
12 requirement. The agency shall impose the same penalty to the member of  
13 the household who failed to comply with TANF requirements. The penalty  
14 periods are three months, six months, one year, or 10 years.

15 (10) Non-cooperation is the failure of the applicant or recipient to  
16 comply with all requirements provided in state and federal law, federal and  
17 state rules and regulations and agency policy. The period of ineligibility  
18 for child care subsidy or TANF benefits based on parents' non-cooperation  
19 with child support services shall be as follows:

20 (A) For the first penalty, three months and cooperation with child  
21 support services prior to regaining eligibility;

22 (B) for a second penalty, six months and cooperation with child  
23 support services prior to regaining eligibility;

24 (C) for a third penalty, one year and cooperation with child support  
25 services prior to regaining eligibility; and

26 (D) for a fourth penalty, 10 years.

27 (11) Individuals that have not cooperated without good cause with  
28 child support services shall be ineligible to participate in the food  
29 assistance program. The period of disqualification ends once it has been  
30 determined that such individual is cooperating with child support services.

31 (12) (A) Any individual who is found to have committed fraud or is  
32 found guilty of the crime of theft pursuant to K.S.A. 39-720 and K.S.A.  
33 2020 Supp. 21-5801, and amendments thereto, in either the TANF or child  
34 care program shall render all adults in the family unit ineligible for TANF  
35 assistance. Adults in the household who were determined to have  
36 committed fraud or were convicted of the crime of theft pursuant to K.S.A.  
37 39-720 and K.S.A. 2020 Supp. 21-5801, and amendments thereto, shall  
38 render themselves and all adult household members ineligible for their  
39 lifetime for TANF, even if fraud was committed in only one program.  
40 Households who have been determined to have committed fraud or were  
41 convicted of the crime of theft pursuant to K.S.A. 39-720 and K.S.A. 2020  
42 Supp. 21-5801, and amendments thereto, shall be required to name a  
43 protective payee as approved by the secretary or the secretary's designee to

1 administer TANF benefits or food assistance on behalf of the children. No  
2 adult in a household may have access to the TANF cash assistance benefit.

3 (B) Any individual that has failed to cooperate with a fraud  
4 investigation shall be ineligible to participate in the TANF cash assistance  
5 program and the child care subsidy program until the department for  
6 children and families determines that such individual is cooperating with  
7 the fraud investigation. The department for children and families shall  
8 maintain a sufficient level of fraud investigative staff to enable the  
9 department to conduct fraud investigations in a timely manner and in full  
10 accordance with state law and department rules and regulations or policies.

11 (13) (A) Food assistance shall not be provided to any person  
12 convicted of a felony offense occurring on or after July 1, 2015, which  
13 includes as an element of such offense the manufacture, cultivation,  
14 distribution, possession or use of a controlled substance or controlled  
15 substance analog. For food assistance, the individual shall be permanently  
16 disqualified if they have been convicted of a state or federal felony offense  
17 occurring on or after July 1, 2015, involving possession or use of a  
18 controlled substance or controlled substance analog.

19 (B) Notwithstanding the provisions of subparagraph (A), an  
20 individual shall be eligible for food assistance if the individual enrolls in  
21 and participates in a drug treatment program approved by the secretary,  
22 submits to and passes a drug test and agrees to submit to drug testing if  
23 requested by the department pursuant to a drug testing plan.

24 An individual's failure to submit to testing or failure to successfully  
25 pass a drug test shall result in ineligibility for food assistance until a drug  
26 test is successfully passed. Failure to successfully complete a drug  
27 treatment program shall result in ineligibility for food assistance until a  
28 drug treatment plan approved by the secretary is successfully completed,  
29 the individual passes a drug test and agrees to submit to drug testing if  
30 requested by the department pursuant to a drug testing plan.

31 (C) The provisions of subparagraph (B) shall not apply to any  
32 individual who has been convicted for a second or subsequent felony  
33 offense as provided in subparagraph (A).

34 (14) No TANF cash assistance shall be used to purchase alcohol,  
35 cigarettes, tobacco products, lottery tickets, concert tickets, professional or  
36 collegiate sporting event tickets or tickets for other entertainment events  
37 intended for the general public or sexually oriented adult materials. No  
38 TANF cash assistance shall be used in any retail liquor store, casino,  
39 gaming establishment, jewelry store, tattoo parlor, massage parlor, body  
40 piercing parlor, spa, nail salon, lingerie shop, tobacco paraphernalia store,  
41 vapor cigarette store, psychic or fortune telling business, bail bond  
42 company, video arcade, movie theater, swimming pool, cruise ship, theme  
43 park, dog or horse racing facility, parimutuel facility, or sexually oriented

1 business or any retail establishment which provides adult-oriented  
2 entertainment in which performers disrobe or perform in an unclothed  
3 state for entertainment, or in any business or retail establishment where  
4 minors under age 18 are not permitted. No TANF cash assistance shall be  
5 used for purchases at points of sale outside the state of Kansas.

6 (15) (A) The secretary for children and families shall place a  
7 photograph of the recipient, if agreed to by such recipient of public  
8 assistance, on any Kansas benefits card issued by the Kansas department  
9 for children and families that the recipient uses in obtaining food, cash or  
10 any other services. When a recipient of public assistance is a minor or  
11 otherwise incapacitated individual, a parent or legal guardian of such  
12 recipient may have a photograph of such parent or legal guardian placed  
13 on the card.

14 (B) Any Kansas benefits card with a photograph of a recipient shall  
15 be valid for voting purposes as a public assistance identification card in  
16 accordance with the provisions of K.S.A. 25-2908, and amendments  
17 thereto.

18 (C) As used in this paragraph ~~and its subparagraphs~~, "Kansas benefits  
19 card" means any card issued to provide food assistance, cash assistance or  
20 child care assistance, including, but not limited to, the vision card, EBT  
21 card and Kansas benefits card.

22 (D) The Kansas department for children and families shall monitor all  
23 recipient requests for a Kansas benefits card replacement and, upon the  
24 fourth such request in a 12-month period, send a notice alerting the  
25 recipient that the recipient's account is being monitored for potential  
26 suspicious activity. If a recipient makes an additional request for  
27 replacement subsequent to such notice, the department shall refer the  
28 investigation to the department's fraud investigation unit.

29 (16) The secretary for children and families shall adopt rules and  
30 regulations:

31 (A) In determining eligibility for the child care subsidy program,  
32 including an income of a cohabiting partner in a child care household; and

33 (B) in determining and maintaining eligibility for non-TANF child  
34 care, requiring that all included adults shall be employed a minimum of 20  
35 hours per week or more as defined by the secretary or meet the following  
36 specific qualifying exemptions:

37 (i) Adults who are not capable of meeting the requirement due to a  
38 documented physical or mental condition;

39 (ii) adults who are former TANF recipients who need child care for  
40 employment after their TANF case has closed and earned income is a  
41 factor in the closure in the two months immediately following TANF  
42 closure;

43 (iii) adult parents included in a case in which the only child receiving

1 benefits is the child of a minor parent who is working on completion of  
 2 high school or obtaining a GED;

3 (iv) adults who are participants in a food assistance employment and  
 4 training program; or

5 (v) adults who are participants in an early head start child care  
 6 partnership program and are working or in school or training.

7 The department for children and families shall provide child care for  
 8 the pursuit of any degree or certification if the occupation has at least an  
 9 average job outlook listed in the occupational outlook of the ~~U.S.~~ *United*  
 10 *States* department of labor, bureau of labor statistics. For occupations with  
 11 less than an average job outlook, educational plans shall require approval  
 12 of the secretary or secretary's designee. Child care may also be approved if  
 13 the student provides verification of a specific job offer that will be  
 14 available to such student upon completion of the program. Child care for  
 15 post-secondary education shall be allowed for a lifetime maximum of 24  
 16 months per adult. The 24 months may not have to be consecutive. Students  
 17 shall be engaged in paid employment for a minimum of 15 hours per  
 18 week. In a two-parent adult household, child care would not be allowed if  
 19 both parents are adults and attending a formal education or training  
 20 program at the same time. The household may choose which one of the  
 21 parents is participating as a post-secondary student. The other parent shall  
 22 meet another approvable criteria for child care subsidy.

23 (17) (A) The secretary for children and families ~~is prohibited from~~  
 24 ~~requesting or implementing~~ *may request or implement* a waiver or program  
 25 from the ~~U.S.~~ *United States* department of agriculture for the ~~time-limited~~  
 26 *time-limited* assistance provisions for able-bodied adults aged 18 through  
 27 49 without dependents in a household under the food assistance program,  
 28 *if the secretary can establish that there are insufficient jobs for the*  
 29 *employment of such individuals.* The time on food assistance for able-  
 30 bodied adults aged 18 through 49 without dependents in the household  
 31 shall be limited to three months in a 36-month period if such adults are not  
 32 meeting the requirements imposed by the ~~U.S.~~ *United States* department of  
 33 agriculture that they must work for at least 20 hours per week or  
 34 participate in a federally approved work program or its equivalent.

35 (B) Each food assistance household member who is not otherwise  
 36 exempt from the following work requirements shall:

37 (i) Register for work;

38 (ii) participate in an employment and training program, if assigned to  
 39 such a program by the department;

40 (iii) accept a suitable employment offer; and

41 (iv) not voluntarily quit a job of at least 30 hours per week.

42 (C) Any recipient who has not complied with the work requirements  
 43 under subparagraph (B) shall be ineligible to participate in the food



1 assistance program for the following time period and until the recipient  
2 complies with such work requirements:

3 (i) For a first penalty, three months;

4 (ii) for a second penalty, six months; and

5 (iii) for a third penalty and any subsequent penalty, one year.

6 (18) Eligibility for the food assistance program shall be limited to  
7 those individuals who are citizens or who meet qualified non-citizen status  
8 as determined by ~~U.S.~~ *United States* department of agriculture. Non-  
9 citizen individuals who are unable or unwilling to provide qualifying  
10 immigrant documentation, as defined by the ~~U.S.~~ *United States* department  
11 of agriculture, residing within a household shall not be included when  
12 determining the household's size for the purposes of assigning a benefit  
13 level to the household for food assistance or comparing the household's  
14 monthly income with the income eligibility standards. The gross non-  
15 exempt earned and unearned income and resources of disqualified  
16 individuals shall be counted in its entirety as available to the remaining  
17 household members.

18 (19) The secretary for children and families shall not enact the state  
19 option from the ~~U.S.~~ *United States* department of agriculture for broad-  
20 based categorical eligibility for households applying for food assistance  
21 according to the provisions of 7 C.F.R. § 273.2(j)(2)(ii).

22 (20) No federal or state funds shall be used for television, radio or  
23 billboard advertisements that are designed to promote food assistance  
24 benefits and enrollment. No federal or state funding shall be used for any  
25 agreements with foreign governments designed to promote food  
26 assistance.

27 (21) (A) The secretary for children and families shall not apply gross  
28 income standards for food assistance *that are* higher than the standards  
29 specified in 7 U.S.C. § 2015(c) unless expressly required by federal law.  
30 Categorical eligibility exempting households from such gross income  
31 standards requirements shall not be granted for any non-cash, in-kind or  
32 other benefit unless expressly required by federal law.

33 (B) The secretary for children and families shall not apply resource  
34 limits standards for food assistance that are higher than the standards  
35 specified in 7 U.S.C. § 2015(g)(1) unless expressly required by federal  
36 law. Categorical eligibility exempting households from such resource  
37 limits shall not be granted for any non-cash, in-kind or other benefit unless  
38 expressly required by federal law.

39 (c) (1) ~~On and after January 1, 2017,~~ The department for children and  
40 families shall conduct an electronic check for any false information  
41 provided on an application for TANF and other benefits programs  
42 administered by the department. For TANF cash assistance, food  
43 assistance and the child care subsidy program, the department shall verify

1 the identity of all adults in the assistance household.

2 (2) The department of administration shall provide monthly to the  
3 Kansas department for children and families the social security numbers or  
4 alternate taxpayer identification numbers of all persons who claim a  
5 Kansas lottery prize in excess of \$5,000 during the reported month. The  
6 Kansas department for children and families shall verify if individuals  
7 with such winnings are receiving TANF cash assistance, food assistance or  
8 assistance under the child care subsidy program and take appropriate  
9 action. The Kansas department for children and families shall use data  
10 received under this subsection solely, and for no other purpose, to  
11 determine if any recipient's eligibility for benefits has been affected by  
12 lottery prize winnings. The Kansas department for children and families  
13 shall not publicly disclose the identity of any lottery prize winner,  
14 including recipients who are determined to have illegally received  
15 benefits.

16 (d) *Temporary assistance for needy families; assignment of support*  
17 *rights and limited power of attorney.* By applying for or receiving  
18 temporary assistance for needy families such applicant or recipient shall be  
19 deemed to have assigned to the secretary on behalf of the state any  
20 accrued, present or future rights to support from any other person such  
21 applicant may have in such person's own behalf or in behalf of any other  
22 family member for whom the applicant is applying for or receiving aid. In  
23 any case in which an order for child support has been established and the  
24 legal custodian and obligee under the order surrenders physical custody of  
25 the child to a caretaker relative without obtaining a modification of legal  
26 custody and support rights on behalf of the child are assigned pursuant to  
27 this section, the surrender of physical custody and the assignment shall  
28 transfer, by operation of law, the child's support rights under the order to  
29 the secretary on behalf of the state. Such assignment shall be of all  
30 accrued, present or future rights to support of the child surrendered to the  
31 caretaker relative. The assignment of support rights shall automatically  
32 become effective upon the date of approval for or receipt of such aid  
33 without the requirement that any document be signed by the applicant,  
34 recipient or obligee. By applying for or receiving temporary assistance for  
35 needy families, or by surrendering physical custody of a child to a  
36 caretaker relative who is an applicant or recipient of such assistance on the  
37 child's behalf, the applicant, recipient or obligee is also deemed to have  
38 appointed the secretary, or the secretary's designee, as an attorney-in-fact  
39 to perform the specific act of negotiating and endorsing all drafts, checks,  
40 money orders or other negotiable instruments representing support  
41 payments received by the secretary in behalf of any person applying for,  
42 receiving or having received such assistance. This limited power of  
43 attorney shall be effective from the date the secretary approves the

1 application for aid and shall remain in effect until the assignment of  
2 support rights has been terminated in full.

3 (e) *Requirements for medical assistance for which federal moneys or*  
4 *state moneys or both are expended.* (1) When the secretary has adopted a  
5 medical care plan under which federal moneys or state moneys or both are  
6 expended, medical assistance in accordance with such plan shall be  
7 granted to any person who is a citizen of the United States or who is an  
8 alien lawfully admitted to the United States and who is residing in the state  
9 of Kansas, whose resources and income do not exceed the levels  
10 prescribed by the secretary. In determining the need of an individual, the  
11 secretary may provide for income and resource exemptions and protected  
12 income and resource levels. Resources from inheritance shall be counted.  
13 A disclaimer of an inheritance pursuant to K.S.A. 59-2291, and  
14 amendments thereto, shall constitute a transfer of resources. The secretary  
15 shall exempt principal and interest held in irrevocable trust pursuant to  
16 K.S.A. 16-303(c), and amendments thereto, from the eligibility  
17 requirements of applicants for and recipients of medical assistance. Such  
18 assistance shall be known as medical assistance.

19 (2) For the purposes of medical assistance eligibility determinations  
20 on or after July 1, 2004, if an applicant or recipient owns property in joint  
21 tenancy with some other party and the applicant or recipient of medical  
22 assistance has restricted or conditioned their interest in such property to a  
23 specific and discrete property interest less than 100%, then such  
24 designation will cause the full value of the property to be considered an  
25 available resource to the applicant or recipient. Medical assistance  
26 eligibility for receipt of benefits under the title XIX of the social security  
27 act, commonly known as medicaid, shall not be expanded, as provided for  
28 in the patient protection and affordable care act, public law 111-148, 124  
29 stat. 119, and the health care and education reconciliation act of 2010,  
30 public law 111-152, 124 stat. 1029, unless the legislature expressly  
31 consents to, and approves of, the expansion of medicaid services by an act  
32 of the legislature.

33 (3) (A) Resources from trusts shall be considered when determining  
34 eligibility of a trust beneficiary for medical assistance. Medical assistance  
35 is to be secondary to all resources, including trusts, that may be available  
36 to an applicant or recipient of medical assistance.

37 (B) If a trust has discretionary language, the trust shall be considered  
38 to be an available resource to the extent, using the full extent of discretion,  
39 the trustee may make any of the income or principal available to the  
40 applicant or recipient of medical assistance. Any such discretionary trust  
41 shall be considered an available resource unless: (i) At the time of creation  
42 or amendment of the trust, the trust states a clear intent that the trust is  
43 supplemental to public assistance; and (ii) the trust: (a) Is funded from

1 resources of a person who, at the time of such funding, owed no duty of  
2 support to the applicant or recipient of medical assistance; or (b) is funded  
3 not more than nominally from resources of a person while that person  
4 owed a duty of support to the applicant or recipient of medical assistance.

5 (C) For the purposes of this paragraph, "public assistance" includes,  
6 but is not limited to, medicaid, medical assistance or title XIX of the social  
7 security act.

8 (4) (A) When an applicant or recipient of medical assistance is a party  
9 to a contract, agreement or accord for personal services being provided by  
10 a nonlicensed individual or provider and such contract, agreement or  
11 accord involves health and welfare monitoring, pharmacy assistance, case  
12 management, communication with medical, health or other professionals,  
13 or other activities related to home health care, long term care, medical  
14 assistance benefits, or other related issues, any moneys paid under such  
15 contract, agreement or accord shall be considered to be an available  
16 resource unless the following restrictions are met:

17 (i) The contract, agreement or accord must be in writing and executed  
18 prior to any services being provided;

19 (ii) the moneys paid are in direct relationship with the fair market  
20 value of such services being provided by similarly situated and trained  
21 nonlicensed individuals;

22 (iii) if no similarly situated nonlicensed individuals or situations can  
23 be found, the value of services will be based on federal hourly minimum  
24 wage standards;

25 (iv) such individual providing the services will report all receipts of  
26 moneys as income to the appropriate state and federal governmental  
27 revenue agencies;

28 (v) any amounts due under such contract, agreement or accord shall  
29 be paid after the services are rendered;

30 (vi) the applicant or recipient shall have the power to revoke the  
31 contract, agreement or accord; and

32 (vii) upon the death of the applicant or recipient, the contract,  
33 agreement or accord ceases.

34 (B) When an applicant or recipient of medical assistance is a party to  
35 a written contract for personal services being provided by a licensed health  
36 professional or facility and such contract involves health and welfare  
37 monitoring, pharmacy assistance, case management, communication with  
38 medical, health or other professionals, or other activities related to home  
39 health care, long term care, medical assistance benefits or other related  
40 issues, any moneys paid in advance of receipt of services for such  
41 contracts shall be considered to be an available resource.

42 (5) Any trust may be amended if such amendment is permitted by the  
43 Kansas uniform trust code.

1 (f) *Eligibility for medical assistance of resident receiving medical*  
2 *care outside state.* A person who is receiving medical care including long-  
3 term care outside of Kansas whose health would be endangered by the  
4 postponement of medical care until return to the state or by travel to return  
5 to Kansas, may be determined eligible for medical assistance if such  
6 individual is a resident of Kansas and all other eligibility factors are met.  
7 Persons who are receiving medical care on an ongoing basis in a long-term  
8 medical care facility in a state other than Kansas and who do not return to  
9 a care facility in Kansas when they are able to do so, shall no longer be  
10 eligible to receive assistance in Kansas unless such medical care is not  
11 available in a comparable facility or program providing such medical care  
12 in Kansas. For persons who are minors or who are under guardianship, the  
13 actions of the parent or guardian shall be deemed to be the actions of the  
14 child or ward in determining whether or not the person is remaining  
15 outside the state voluntarily.

16 (g) *Medical assistance; assignment of rights to medical support and*  
17 *limited power of attorney; recovery from estates of deceased recipients.* (1)  
18 (A) Except as otherwise provided in K.S.A. 39-786 and 39-787, and  
19 amendments thereto, or as otherwise authorized on and after September  
20 30, 1989, under section 303 of the federal medicare catastrophic coverage  
21 act of 1988, whichever is applicable, by applying for or receiving medical  
22 assistance under a medical care plan in which federal funds are expended,  
23 any accrued, present or future rights to support and any rights to payment  
24 for medical care from a third party of an applicant or recipient and any  
25 other family member for whom the applicant is applying shall be deemed  
26 to have been assigned to the secretary on behalf of the state. The  
27 assignment shall automatically become effective upon the date of approval  
28 for such assistance without the requirement that any document be signed  
29 by the applicant or recipient. By applying for or receiving medical  
30 assistance the applicant or recipient is also deemed to have appointed the  
31 secretary, or the secretary's designee, as an attorney in fact to perform the  
32 specific act of negotiating and endorsing all drafts, checks, money orders  
33 or other negotiable instruments, representing payments received by the  
34 secretary in on behalf of any person applying for, receiving or having  
35 received such assistance. This limited power of attorney shall be effective  
36 from the date the secretary approves the application for assistance and  
37 shall remain in effect until the assignment has been terminated in full. The  
38 assignment of any rights to payment for medical care from a third party  
39 under this subsection shall not prohibit a health care provider from directly  
40 billing an insurance carrier for services rendered if the provider has not  
41 submitted a claim covering such services to the secretary for payment.  
42 Support amounts collected on behalf of persons whose rights to support  
43 are assigned to the secretary only under this subsection and no other shall

1 be distributed pursuant to K.S.A. 39-756(d), and amendments thereto,  
2 except that any amounts designated as medical support shall be retained by  
3 the secretary for repayment of the unreimbursed portion of assistance.  
4 Amounts collected pursuant to the assignment of rights to payment for  
5 medical care from a third party shall also be retained by the secretary for  
6 repayment of the unreimbursed portion of assistance.

7 (B) Notwithstanding the provisions of subparagraph (A), the  
8 secretary of health and environment, or the secretary's designee, is hereby  
9 authorized to and shall exercise any of the powers specified in  
10 subparagraph (A) in relation to performance of such secretary's duties  
11 pertaining to medical subrogation, estate recovery or any other duties  
12 assigned to such secretary in article 74 of chapter 75 of the Kansas Statutes  
13 Annotated, and amendments thereto.

14 (2) The amount of any medical assistance paid after June 30, 1992,  
15 under the provisions of subsection (e) is:

16 (A) A claim against the property or any interest therein belonging to  
17 and a part of the estate of any deceased recipient or, if there is no estate,  
18 the estate of the surviving spouse, if any, shall be charged for such medical  
19 assistance paid to either or both; and

20 (B) a claim against any funds of such recipient or spouse in any  
21 account under K.S.A. 9-1215, 17-2263 or 17-2264, and amendments  
22 thereto. There shall be no recovery of medical assistance correctly paid to  
23 or on behalf of an individual under subsection (e) except after the death of  
24 the surviving spouse of the individual, if any, and only at a time when the  
25 individual has no surviving child who is under 21 years of age or is blind  
26 or permanently and totally disabled. Transfers of real or personal property  
27 by recipients of medical assistance without adequate consideration are  
28 voidable and may be set aside. Except where there is a surviving spouse,  
29 or a surviving child who is under 21 years of age or is blind or  
30 permanently and totally disabled, the amount of any medical assistance  
31 paid under subsection (e) is a claim against the estate in any guardianship  
32 or conservatorship proceeding. The monetary value of any benefits  
33 received by the recipient of such medical assistance under long-term care  
34 insurance, as defined by K.S.A. 40-2227, and amendments thereto, shall  
35 be a credit against the amount of the claim provided for such medical  
36 assistance under this subsection. The secretary of health and environment  
37 is authorized to enforce each claim provided for under this subsection. The  
38 secretary of health and environment shall not be required to pursue every  
39 claim, but is granted discretion to determine which claims to pursue. All  
40 moneys received by the secretary of health and environment from claims  
41 under this subsection shall be deposited in the social welfare fund. The  
42 secretary of health and environment may adopt rules and regulations for  
43 the implementation and administration of the medical assistance recovery

1 program under this subsection.

2 (3) By applying for or receiving medical assistance under the  
3 provisions of article 7 of chapter 39 of the Kansas Statutes Annotated, and  
4 amendments thereto, such individual or such individual's agent, fiduciary,  
5 guardian, conservator, representative payee or other person acting on  
6 behalf of the individual consents to the following definitions of estate and  
7 the results therefrom:

8 (A) If an individual receives any medical assistance before July 1,  
9 2004, pursuant to article 7 of chapter 39 of the Kansas Statutes Annotated,  
10 and amendments thereto, which forms the basis for a claim under  
11 paragraph (2), such claim is limited to the individual's probatable estate as  
12 defined by applicable law; and

13 (B) if an individual receives any medical assistance on or after July 1,  
14 2004, pursuant to article 7 of chapter 39 of the Kansas Statutes Annotated,  
15 and amendments thereto, which forms the basis for a claim under  
16 paragraph (2), such claim shall apply to the individual's medical assistance  
17 estate. The medical assistance estate is defined as including all real and  
18 personal property and other assets in which the deceased individual had  
19 any legal title or interest immediately before or at the time of death to the  
20 extent of that interest or title. The medical assistance estate includes,  
21 without limitation assets conveyed to a survivor, heir or assign of the  
22 deceased recipient through joint tenancy, tenancy in common,  
23 survivorship, transfer-on-death deed, payable-on-death contract, life estate,  
24 trust, annuities or similar arrangement.

25 (4) The secretary of health and environment or the secretary's  
26 designee is authorized to file and enforce a lien against the real property of  
27 a recipient of medical assistance in certain situations, subject to all prior  
28 liens of record and transfers for value to a bona fide purchaser of record.  
29 The lien must be filed in the office of the register of deeds of the county  
30 where the real property is located within one year from the date of death of  
31 the recipient and must contain the legal description of all real property in  
32 the county subject to the lien.

33 (A) After the death of a recipient of medical assistance, the secretary  
34 of health and environment or the secretary's designee may place a lien on  
35 any interest in real property owned by such recipient.

36 (B) The secretary of health and environment or the secretary's  
37 designee may place a lien on any interest in real property owned by a  
38 recipient of medical assistance during the lifetime of such recipient. Such  
39 lien may be filed only after notice and an opportunity for a hearing has  
40 been given. Such lien may be enforced only upon competent medical  
41 testimony that the recipient cannot reasonably be expected to be  
42 discharged and returned home. A six-month period of compensated  
43 inpatient care at a nursing home or other medical institution shall

1 constitute a determination by the department of health and environment  
2 that the recipient cannot reasonably be expected to be discharged and  
3 returned home. To return home means the recipient leaves the nursing or  
4 medical facility and resides in the home on which the lien has been placed  
5 for a continuous period of at least 90 days without being readmitted as an  
6 inpatient to a nursing or medical facility. The amount of the lien shall be  
7 for the amount of assistance paid by the department of health and  
8 environment until the time of the filing of the lien and for any amount paid  
9 thereafter for such medical assistance to the recipient. After the lien is filed  
10 against any real property owned by the recipient, such lien will be  
11 dissolved if the recipient is discharged, returns home and resides upon the  
12 real property to which the lien is attached for a continuous period of at  
13 least 90 days without being readmitted as an inpatient to a nursing or  
14 medical facility. If the recipient is readmitted as an inpatient to a nursing or  
15 medical facility for a continuous period of less than 90 days, another  
16 continuous period of at least 90 days shall be completed prior to  
17 dissolution of the lien.

18 (5) The lien filed by the secretary of health and environment or the  
19 secretary's designee for medical assistance correctly received may be  
20 enforced before or after the death of the recipient by the filing of an action  
21 to foreclose such lien in the Kansas district court or through an estate  
22 probate court action in the county where the real property of the recipient  
23 is located. However, it may be enforced only:

- 24 (A) After the death of the surviving spouse of the recipient;  
25 (B) when there is no child of the recipient, natural or adopted, who is  
26 20 years of age or less residing in the home;  
27 (C) when there is no adult child of the recipient, natural or adopted,  
28 who is blind or disabled residing in the home; or  
29 (D) when no brother or sister of the recipient is lawfully residing in  
30 the home, who has resided there for at least one year immediately before  
31 the date of the recipient's admission to the nursing or medical facility, and  
32 has resided there on a continuous basis since that time.

33 (6) The lien remains on the property even after a transfer of the title  
34 by conveyance, sale, succession, inheritance or will unless one of the  
35 following events occur:

- 36 (A) The lien is satisfied. The recipient, the heirs, personal  
37 representative or assigns of the recipient may discharge such lien at any  
38 time by paying the amount of the lien to the secretary of health and  
39 environment or the secretary's designee;  
40 (B) the lien is terminated by foreclosure of prior lien of record or  
41 settlement action taken in lieu of foreclosure; or  
42 (C) the value of the real property is consumed by the lien, at which  
43 time the secretary of health and environment or the secretary's designee



1 may force the sale for the real property to satisfy the lien.

2 (7) If the secretary for aging and disability services or the secretary of  
3 health and environment, or both, or such secretary's designee has not filed  
4 an action to foreclose the lien in the Kansas district court in the county  
5 where the real property is located within 10 years from the date of the  
6 filing of the lien, then the lien shall become dormant, and shall cease to  
7 operate as a lien on the real estate of the recipient. Such dormant lien may  
8 be revived in the same manner as a dormant judgment lien is revived under  
9 K.S.A. 60-2403 et seq., and amendments thereto.

10 (8) Within seven days of receipt of notice by the secretary for  
11 children and families or the secretary's designee of the death of a recipient  
12 of medical assistance under this subsection, the secretary for children and  
13 families or the secretary's designee shall give notice of such recipient's  
14 death to the secretary of health and environment or the secretary's  
15 designee.

16 (9) All rules and regulations adopted on and after July 1, 2013, and  
17 prior to July 1, 2014, to implement this subsection shall continue to be  
18 effective and shall be deemed to be duly adopted rules and regulations of  
19 the secretary of health and environment until revised, amended, revoked or  
20 nullified pursuant to law.

21 (h) *Placement under the revised Kansas code for care of children or*  
22 *revised Kansas juvenile justice code; assignment of support rights and*  
23 *limited power of attorney.* In any case in which the secretary for children  
24 and families pays for the expenses of care and custody of a child pursuant  
25 to K.S.A. 2020 Supp. 38-2201 et seq. or 38-2301 et seq., and amendments  
26 thereto, including the expenses of any foster care placement, an  
27 assignment of all past, present and future support rights of the child in  
28 custody possessed by either parent or other person entitled to receive  
29 support payments for the child is, by operation of law, conveyed to the  
30 secretary. Such assignment shall become effective upon placement of a  
31 child in the custody of the secretary or upon payment of the expenses of  
32 care and custody of a child by the secretary without the requirement that  
33 any document be signed by the parent or other person entitled to receive  
34 support payments for the child. When the secretary pays for the expenses  
35 of care and custody of a child or a child is placed in the custody of the  
36 secretary, the parent or other person entitled to receive support payments  
37 for the child is also deemed to have appointed the secretary, or the  
38 secretary's designee, as attorney in fact to perform the specific act of  
39 negotiating and endorsing all drafts, checks, money orders or other  
40 negotiable instruments representing support payments received by the  
41 secretary on behalf of the child. This limited power of attorney shall be  
42 effective from the date the assignment to support rights becomes effective  
43 and shall remain in effect until the assignment of support rights has been

1 terminated in full.

2 (i) No person who voluntarily quits employment or who is fired from  
3 employment due to gross misconduct as defined by rules and regulations  
4 of the secretary or who is a fugitive from justice by reason of a felony  
5 conviction or charge or violation of a condition of probation or parole  
6 imposed under federal or state law shall be eligible to receive public  
7 assistance benefits in this state. Any recipient of public assistance who  
8 fails to timely comply with monthly reporting requirements under criteria  
9 and guidelines prescribed by rules and regulations of the secretary shall be  
10 subject to a penalty established by the secretary by rules and regulations.

11 (j) If the applicant or recipient of temporary assistance for needy  
12 families is a mother of the dependent child, as a condition of the mother's  
13 eligibility for temporary assistance for needy families the mother shall  
14 identify by name and, if known, by current address the father of the  
15 dependent child except that the secretary may adopt by rules and  
16 regulations exceptions to this requirement in cases of undue hardship. Any  
17 recipient of temporary assistance for needy families who fails to cooperate  
18 with requirements relating to child support services under criteria and  
19 guidelines prescribed by rules and regulations of the secretary shall be  
20 subject to a penalty established by the secretary.

21 (k) By applying for or receiving child care benefits or food  
22 assistance, the applicant or recipient shall be deemed to have assigned,  
23 pursuant to K.S.A. 39-756, and amendments thereto, to the secretary on  
24 behalf of the state only accrued, present or future rights to support from  
25 any other person such applicant may have in such person's own behalf or  
26 in behalf of any other family member for whom the applicant is applying  
27 for or receiving aid. The assignment of support rights shall automatically  
28 become effective upon the date of approval for or receipt of such aid  
29 without the requirement that any document be signed by the applicant or  
30 recipient. By applying for or receiving child care benefits or food  
31 assistance, the applicant or recipient is also deemed to have appointed the  
32 secretary, or the secretary's designee, as an attorney in fact to perform the  
33 specific act of negotiating and endorsing all drafts, checks, money orders  
34 or other negotiable instruments representing support payments received by  
35 the secretary in behalf of any person applying for, receiving or having  
36 received such assistance. This limited power of attorney shall be effective  
37 from the date the secretary approves the application for aid and shall  
38 remain in effect until the assignment of support rights has been terminated  
39 in full. An applicant or recipient who has assigned support rights to the  
40 secretary pursuant to this subsection shall cooperate in establishing and  
41 enforcing support obligations to the same extent required of applicants for  
42 or recipients of temporary assistance for needy families.

43 (l) (1) A program of drug screening for applicants for cash assistance

1 as a condition of eligibility for cash assistance and persons receiving cash  
2 assistance as a condition of continued receipt of cash assistance shall be  
3 established, subject to applicable federal law, by the secretary for children  
4 and families on and before January 1, 2014. Under such program of drug  
5 screening, the secretary for children and families shall order a drug  
6 screening of an applicant for or a recipient of cash assistance at any time  
7 when reasonable suspicion exists that such applicant for or recipient of  
8 cash assistance is unlawfully using a controlled substance or controlled  
9 substance analog. The secretary for children and families may use any  
10 information obtained by the secretary for children and families to  
11 determine whether such reasonable suspicion exists, including, but not  
12 limited to, an applicant's or recipient's demeanor, missed appointments and  
13 arrest or other police records, previous employment or application for  
14 employment in an occupation or industry that regularly conducts drug  
15 screening, termination from previous employment due to unlawful use of a  
16 controlled substance or controlled substance analog or prior drug screening  
17 records of the applicant or recipient indicating unlawful use of a controlled  
18 substance or controlled substance analog.

19 (2) Any applicant for or recipient of cash assistance whose drug  
20 screening results in a positive test may request that the drug screening  
21 specimen be sent to a different drug testing facility for an additional drug  
22 screening. Any applicant for or recipient of cash assistance who requests  
23 an additional drug screening at a different drug testing facility shall be  
24 required to pay the cost of drug screening. Such applicant or recipient who  
25 took the additional drug screening and who tested negative for unlawful  
26 use of a controlled substance and controlled substance analog shall be  
27 reimbursed for the cost of such additional drug screening.

28 (3) Any applicant for or recipient of cash assistance who tests  
29 positive for unlawful use of a controlled substance or controlled substance  
30 analog shall be required to complete a substance abuse treatment program  
31 approved by the secretary for children and families, secretary of labor or  
32 secretary of commerce, and a job skills program approved by the secretary  
33 for children and families, secretary of labor or secretary of commerce.  
34 Subject to applicable federal laws, any applicant for or recipient of cash  
35 assistance who fails to complete or refuses to participate in the substance  
36 abuse treatment program or job skills program as required under this  
37 subsection shall be ineligible to receive cash assistance until completion of  
38 such substance abuse treatment and job skills programs. Upon completion  
39 of both substance abuse treatment and job skills programs, such applicant  
40 for or recipient of cash assistance may be subject to periodic drug  
41 screening, as determined by the secretary for children and families. Upon a  
42 second positive test for unlawful use of a controlled substance or  
43 controlled substance analog, a recipient of cash assistance shall be ordered

1 to complete again a substance abuse treatment program and job skills  
2 program, and shall be terminated from cash assistance for a period of 12  
3 months, or until such recipient of cash assistance completes both substance  
4 abuse treatment and job skills programs, whichever is later. Upon a third  
5 positive test for unlawful use of a controlled substance or controlled  
6 substance analog, a recipient of cash assistance shall be terminated from  
7 cash assistance, subject to applicable federal law.

8 (4) If an applicant for or recipient of cash assistance is ineligible for  
9 or terminated from cash assistance as a result of a positive test for  
10 unlawful use of a controlled substance or controlled substance analog, and  
11 such applicant for or recipient of cash assistance is the parent or legal  
12 guardian of a minor child, an appropriate protective payee shall be  
13 designated to receive cash assistance on behalf of such child. Such parent  
14 or legal guardian of the minor child may choose to designate an individual  
15 to receive cash assistance for such parent's or legal guardian's minor child,  
16 as approved by the secretary for children and families. Prior to the  
17 designated individual receiving any cash assistance, the secretary for  
18 children and families shall review whether reasonable suspicion exists that  
19 such designated individual is unlawfully using a controlled substance or  
20 controlled substance analog.

21 (A) In addition, any individual designated to receive cash assistance  
22 on behalf of an eligible minor child shall be subject to drug screening at  
23 any time when reasonable suspicion exists that such designated individual  
24 is unlawfully using a controlled substance or controlled substance analog.  
25 The secretary for children and families may use any information obtained  
26 by the secretary for children and families to determine whether such  
27 reasonable suspicion exists, including, but not limited to, the designated  
28 individual's demeanor, missed appointments and arrest or other police  
29 records, previous employment or application for employment in an  
30 occupation or industry that regularly conducts drug screening, termination  
31 from previous employment due to unlawful use of a controlled substance  
32 or controlled substance analog or prior drug screening records of the  
33 designated individual indicating unlawful use of a controlled substance or  
34 controlled substance analog.

35 (B) Any designated individual whose drug screening results in a  
36 positive test may request that the drug screening specimen be sent to a  
37 different drug testing facility for an additional drug screening. Any  
38 designated individual who requests an additional drug screening at a  
39 different drug testing facility shall be required to pay the cost of drug  
40 screening. Such designated individual who took the additional drug  
41 screening and who tested negative for unlawful use of a controlled  
42 substance and controlled substance analog shall be reimbursed for the cost  
43 of such additional drug screening.

1 (C) Upon any positive test for unlawful use of a controlled substance  
2 or controlled substance analog, the designated individual shall not receive  
3 cash assistance on behalf of the parent's or legal guardian's minor child,  
4 and another designated individual shall be selected by the secretary for  
5 children and families to receive cash assistance on behalf of such parent's  
6 or legal guardian's minor child.

7 (5) If a person has been convicted under federal or state law of any  
8 offense which is classified as a felony by the law of the jurisdiction and  
9 which has as an element of such offense the manufacture, cultivation,  
10 distribution, possession or use of a controlled substance or controlled  
11 substance analog, and the date of conviction is on or after July 1, 2013,  
12 such person shall thereby become forever ineligible to receive any cash  
13 assistance under this subsection unless such conviction is the person's first  
14 conviction. First-time offenders convicted under federal or state law of any  
15 offense which is classified as a felony by the law of the jurisdiction and  
16 which has as an element of such offense the manufacture, cultivation,  
17 distribution, possession or use of a controlled substance or controlled  
18 substance analog, and the date of conviction is on or after July 1, 2013,  
19 such person shall become ineligible to receive cash assistance for five  
20 years from the date of conviction.

21 (6) Except for hearings before the Kansas department for children and  
22 families, the results of any drug screening administered as part of the  
23 drug screening program authorized by this subsection shall be confidential  
24 and shall not be disclosed publicly.

25 (7) The secretary for children and families may adopt such rules and  
26 regulations as are necessary to carry out the provisions of this subsection.

27 (8) Any authority granted to the secretary for children and families  
28 under this subsection shall be in addition to any other penalties prescribed  
29 by law.

30 (9) As used in this subsection:

31 (A) "Cash assistance" means cash assistance provided to individuals  
32 under the provisions of article 7 of chapter 39 of the Kansas Statutes  
33 Annotated, and amendments thereto, and any rules and regulations adopted  
34 pursuant to such statutes.

35 (B) "Controlled substance" means the same as in K.S.A. 2020 Supp.  
36 21-5701, and amendments thereto, and 21 U.S.C. § 802.

37 (C) "Controlled substance analog" means the same as in K.S.A. 2020  
38 Supp. 21-5701, and amendments thereto.
