1 AN ACT concerning cigarettes and tobacco products; relating to the  
2 cigarette and tobacco products act; definitions, licenses and permits,  
3 suspension or revocation licenses, stamps, records required of dealers,  
4 unlawful acts, penalties, sale of cigarettes, application of certain laws to  
5 taxes, remittance of taxes and escrow deposits; amending K.S.A. 79-  
6 3304, 79-3309, 79-3323, 79-3324a, 79-3326 and 79-3378 and K.S.A.  
7 2016 Supp. 50-6a07, 79-3301, 79-3302, 79-3303, 79-3311, 79-3312,  
8 79-3316, 79-3321, 79-3322, 79-3333, 79-3335, 79-3387, 79-3391, 79-  
9 3392 and 79-3393 and repealing the existing sections.

10  
11 *Be it enacted by the Legislature of the State of Kansas:*

12 New Section 1. (a) Notwithstanding any other provision in this act,  
13 any person who purchases, possesses, uses or consumes more than 400  
14 cigarettes in this state without the required tax indicia being affixed as  
15 herein provided shall be liable for the tax imposed by this act.

16 (b) The provisions of this section shall be part of and supplemental to  
17 the Kansas cigarette and tobacco products act.

18 New Sec. 2. For the purpose of determining whether a conviction is a  
19 first, second, third or subsequent conviction in sentencing under this act:

20 (a) "Conviction" or "convicted" includes being convicted of a  
21 violation of this act or entering into a diversion or deferred judgment  
22 agreement in lieu of further criminal proceedings on a complaint alleging a  
23 violation of this act;

24 (b) "conviction" or "convicted" includes being convicted of a  
25 violation of a law of another state or the United States, which prohibits the  
26 acts that this act prohibits or entering into a diversion or deferred judgment  
27 agreement in lieu of further criminal proceedings in a case alleging a  
28 violation of such law;

29 (c) only convictions occurring in the immediately preceding five  
30 years beginning on July 1, 2017, shall be taken into account, but the court  
31 may consider other prior convictions in determining the sentence to be  
32 imposed within the limits provided for a first, second, third or subsequent  
33 offense, whichever is applicable; and

34 (d) it is irrelevant whether an offense occurred before or after  
35 conviction for a previous offense.

36 (e) The provisions of this section shall be part of and supplemental to

1 the Kansas cigarette and tobacco products act.

14 flavored, adulterated or mixed with any other ingredient if the wrapper is  
15 in greater part made of any material except tobacco.*

16 ~~(d)~~(e) *"Conspicuous location or place" means a location or place  
17 available to the general public.*

18 (f) *"Consumer" means the person purchasing or receiving cigarettes  
19 or tobacco products for final use.*

20 ~~(e)~~(g) *"Contracting entity" means any public or private person, firm  
21 or entity that has entered into a contract with the secretary of revenue to  
22 provide services.*

23 (h) *"Dealer" means any person who engages in the sale or  
24 manufacture of cigarettes, tobacco products or electronic cigarettes in the  
25 state of Kansas, and who is required to be licensed under the provisions of  
26 this act.*

27 ~~(f)~~(i) *"Dealer establishment" means any location or premises, other  
28 than vending machine locations, at or from which cigarettes, tobacco  
29 products or electronic cigarettes are sold, and where records are kept.*

30 ~~(g)~~(j) *"Director" means the director of taxation.*

31 ~~(h)~~(k) *"Distributor" means: (1) Any person engaged in the business of  
32 selling tobacco products in this state who brings, or causes to be brought,  
33 into this state from outside the state any tobacco products for sale;*

34 *(2) any person who makes, manufactures, fabricates or stores tobacco  
35 products in this state for sale in this state; or*

36 *(3) any person engaged in the business of selling tobacco products  
37 outside this state who ships or transports tobacco products to any person in  
38 the business of selling tobacco products in this state.*

39 ~~(i)~~(l) *"Division" means the division of taxation.*

40 ~~(j)~~(m) *"Electronic cigarette" means a battery-powered device,  
41 whether or not such device is shaped like a cigarette, that can provide  
42 inhaled doses of nicotine by delivering a vaporized solution by means of  
43 cartridges or other chemical delivery systems.*

1       (n) *"Importer" means the same as provided in 26 U.S.C. §-5702(~~t~~)*  
2 **5702(k).**

3       (o) "License" means the privilege of a licensee to sell cigarettes or  
4 tobacco products in the state of Kansas, and the written evidence of such  
5 authority or privilege as issued by the director.

6       (~~k~~)(p) "Licensee" means any person holding a current license issued  
7 pursuant to this act.

8       (~~t~~)(q) *"Manufacturer" means the same as provided in 26 U.S.C. §*  
9 **5702(d).**

10       (r) "Manufacturer's salesperson" means a person employed by a  
11 cigarette manufacturer who sells cigarettes, manufactured by such  
12 employer and procured from wholesale dealers.

13       (~~m~~) ~~"Meter imprints" means tax indicia applied by means of ink~~  
14 ~~printing machines.~~

15       (~~t~~)(s) (1) "Package" means a container in which no more than 25  
16 individual cigarettes are wrapped and sealed by the manufacturer of  
17 cigarettes prior to shipment to a wholesale dealer;

18       (2) for the purposes of ~~subsections (u), (v) and (w) of K.S.A. 79-~~  
19 ~~3321(~~t~~), (v) and (w), and amendments thereto, "package" means the same~~  
20 ~~as provided in 15 U.S.C. § 1332(4).~~

21       (~~t~~)(t) "Person" means any individual, partnership, society,  
22 association, joint-stock company, corporation, estate, receiver, trustee,  
23 assignee, referee or any other person acting in a fiduciary or representative  
24 capacity whether appointed by a court or otherwise and any combination  
25 of individuals.

26       (~~t~~)(u) "Received" means the coming to rest of cigarettes for sale by  
27 any dealer in the state of Kansas.

28       (~~t~~)(v) "Retail dealer" or *"retailers"* means a person, other than a  
29 vending machine operator, in possession of cigarettes or electronic  
30 cigarettes for the purpose of sale to a consumer.

31       (~~t~~)(w) "Sale" means any transfer of title or possession or both,  
32 exchange, barter, distribution or gift of cigarettes ~~or tobacco products,~~  
33 ***tobacco products or electronic cigarettes,*** with or without consideration.

34       (~~s~~)(x) "Sample" means cigarettes or tobacco products distributed to  
35 members of the general public at no cost for purposes of promoting the  
36 product.

37       (~~t~~)(y) "Self-service display" means a display that contains cigarettes  
38 or tobacco products and is located in an area openly accessible to a retail  
39 dealer's consumers, and from which such consumers can readily access  
40 cigarettes or tobacco products without the assistance of a salesperson, ***and***  
41 ***which is knowingly utilized by the retail dealer to market and sell***  
42 ***cigarettes and tobacco products to consumers.*** A display case that holds  
43 cigarettes or tobacco products behind locked doors does not constitute a

1 self-service display.

2 ~~(t)(z)~~ "Stamps" means tax indicia applied ~~either by means of water~~  
3 ~~applied gummed paper or~~ heat process, *pressure or any other process*  
4 *approved by the director.*

5 ~~(v)(aa)~~ "Tax indicia" means visible evidence of tax payment in the  
6 form of stamps ~~or meter imprints.~~

7 ~~(w)(bb)~~ "Tobacco products" means cigars, cheroots, stogies, periques;  
8 granulated, plug cut, crimp cut, ready rubbed and other smoking tobacco;  
9 snuff, snuff flour; cavendish; plug and twist tobacco; fine cut and other  
10 chewing tobaccos; shorts; refuse scraps, clippings, cuttings and sweepings  
11 of tobacco, and other kinds and forms of tobacco, prepared in such manner  
12 as to be suitable for chewing or smoking in a pipe or otherwise, or both for  
13 chewing and smoking. Tobacco products do not include cigarettes.

14 ~~(x)(cc)~~ "Tobacco—~~speciality~~ *specialty* store" means a dealer  
15 establishment that derives at least ~~75~~ 65% of such dealer establishment's  
16 revenue from cigarettes or tobacco products.

17 ~~(y)(dd)~~ "Vending machine" means any coin operated machine,  
18 contrivance or device, by means of which merchandise may be sold.

19 ~~(z)(ee)~~ "Vending machine distributor" means any person who sells  
20 cigarette vending machines to a vending machine operator operating  
21 vending machines in the state of Kansas.

22 ~~(aa)(ff)~~ "Vending machine operator" means any person who places a  
23 vending machine, owned, leased or operated by such person, at locations  
24 where cigarettes are sold from such vending machine. The owner or lessee  
25 of the premises upon which a vending machine is placed shall not be  
26 considered the operator of the machine, nor shall the owner or lessee, or  
27 any employee or agent of the owner or lessee be considered an authorized  
28 agent of the vending machine operator, if the owner or lessee does not own  
29 or lease the machine and the owner's or lessee's sole remuneration from the  
30 machine is a flat rental fee or commission based upon the number or value  
31 of cigarettes sold from the machine, or a combination of both.

32 ~~(bb)(gg)~~ "Wholesale dealer" means any person who sells cigarettes to  
33 other wholesale dealers, retail dealers, vending machine operators and  
34 manufacturer's salespersons for the purpose of resale in the state of  
35 Kansas.

36 ~~(ee)(hh)~~ "Wholesale sales price" means the original net invoice price  
37 for which a manufacturer sells a tobacco product to a distributor, as shown  
38 by the manufacturer's original invoice.

39 ~~(dd)~~ "Importer" means the same as provided in 26 U.S.C. § 5702(i).

40 ~~(ee)~~ "Manufacturer" means the same as provided in 26 U.S.C. §  
41 5702(d).

42 ~~(ff)~~ "Electronic cigarette" means a battery-powered device, whether  
43 or not such device is shaped like a cigarette, that can provide inhaled doses

1 of nicotine by delivering a vaporized solution by means of cartridges or  
2 other chemical delivery systems.

12 (b) It is the purpose and intent of this act to regulate the sale of  
13 cigarettes and tobacco products in this state and to impose a tax thereon.

14 Sec. 5. K.S.A. 2016 Supp. 79-3303 is hereby amended to read as  
15 follows: 79-3303. (a) Each person engaged in the business of selling  
16 cigarettes or electronic cigarettes in the state of Kansas and each vending  
17 machine distributor shall obtain a license as provided by this act. A  
18 separate application, license and fee is required for each dealer  
19 establishment owned or operated by a dealer. A vending machine operator  
20 is required to obtain a vending machine operator's master license and, in  
21 addition, a separate permit for each vending machine operated by the  
22 operator. A vending machine operator may submit one application for the  
23 vending machine operator's master license and all permits for vending  
24 machines operated by the operator. The license shall be displayed in the  
25 dealer establishment and the vending machine permit shall remain securely  
26 and visibly attached to the vending machine and contain such information  
27 as the director may require. Any vending machine found without such  
28 permit attached to the machine shall be sealed by an agent of the director  
29 and such seal shall be removed only by an agent of the director after  
30 payment of the permit fee and the penalties provided by this act.

31 (b) The application for a vending machine operator's master license  
32 and vending machine permits shall list the brand name and serial number  
33 of each machine and such other information as required by the director.  
34 Except in accordance with proper judicial order or as otherwise provided  
35 by law, it shall be unlawful for any officer or employee of the division to  
36 divulge or make known in any way the location of any vending machine to  
37 any person not an officer or employee of the division *or contracting entity*  
38 *of the division, where the division has determined disclosure of such*  
39 *information is essential for completion of the contract and has taken*  
40 *appropriate steps to preserve confidentiality*, except that such information  
41 may be divulged to any law enforcement officer for use in the officer's  
42 official duties. Any officer-~~or~~, employee *or contracting entity* revealing  
43 any such location in violation of this provision, in addition to the penalties

1 otherwise provided in this act, shall be dismissed from office.

2 (c) A vending machine operator, in the course of business as a  
3 vending machine operator, may dispose of or sell vending machines  
4 without securing a license to sell vending machines. The vending machine  
5 operator may move vending machines from one location to another and, if  
6 a vending machine becomes inoperative or is disposed of, the permit for  
7 such machine may be transferred to another machine. A vending machine  
8 operator, within 10 days, shall notify the director of the brand name and  
9 serial number of vending machines that become inoperative or that the  
10 operator disposes of, sells, acquires or brings into service in this state as  
11 additional machines.

12 (d) The key to the lower or storage compartment of a vending  
13 machine shall remain only in the possession of the vending machine  
14 operator or the operator's authorized agent. All services connected with the  
15 operation of a vending machine shall be performed by the vending  
16 machine operator or the operator's authorized agent. All vending machines  
17 shall be subject to inspection by the director or the director's authorized  
18 agents. No permit shall be issued for a vending machine unless it is  
19 constructed so that at least one package of each vertical column of  
20 cigarettes located therein is visible showing tax indicia.

21 (e) All vending machines operated on military installations shall have  
22 a permit affixed to the machines and the cigarettes shall show tax indicia  
23 of the Kansas tax.

24 (f) On or before the 10<sup>th</sup> day of each month, each vending machine  
25 distributor shall report to the director, on forms provided by the director,  
26 all sales of cigarette vending machines by the distributor to persons in the  
27 state of Kansas during the preceding month; the name and address of the  
28 purchaser; and the brand name, serial number and sale price of the  
29 machines.

30 (g) Concurrently with a change in ownership of a dealer  
31 establishment the license applicable to the establishment is void and shall  
32 be surrendered to the director and shall not be transferred. On removal of a  
33 dealer establishment from one location to another, the owner of the  
34 establishment shall notify the director and surrender the owner's license.  
35 The director shall issue a new license for the unexpired term of the  
36 surrendered license on payment of a fee of \$2. If a dealer's license is lost,  
37 stolen or destroyed, the director may issue a new license on proof of loss,  
38 theft or destruction, at a cost of \$2. The director shall remit all moneys  
39 received under this subsection to the state treasurer in accordance with the  
40 provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of  
41 each such remittance, the state treasurer shall deposit the entire amount in  
42 the state treasury to the credit of the state general fund.

43 Sec. 6. K.S.A. 79-3304 is hereby amended to read as follows: 79-

1 3304. (a) The license fee for each biennium or portion thereof shall be as  
2 follows:

3 (1) For retail dealer's license, \$25 for each dealer establishment.

4 (2) For retailer's license on railroad or sleeping cars, \$50. Only one  
5 retail license need be obtained by each railroad or sleeping car company to  
6 permit the sale of cigarettes on any or all of its cars within the state.

7 (3) For show, carnival or catering license, \$50 for each concession.

8 (4) For resident retail dealer's temporary license for a place of  
9 business of a temporary nature, \$2 for each seven days or portion thereof.

10 (5) For wholesale dealer's license, \$50 for each dealer establishment.  
11 No wholesale dealer's license shall be issued until the person applying  
12 therefor has filed with the director a bond payable to the state of Kansas in  
13 such an amount as shall be fixed by the director, but in no event less than  
14 \$1,000, with a corporate surety authorized to do business in the state of  
15 Kansas, and approved by the director. If a wholesale dealer is unable to  
16 secure a corporate surety bond, the director may issue a license to such  
17 wholesale dealer, upon the wholesale dealer furnishing a personal bond  
18 meeting the approval of the director. Such bond shall be conditioned on the  
19 wholesale dealer's compliance with all the provisions of this act during the  
20 license period.

21 (6) For vending machine distributor's license, \$50.

22 (7) For manufacturer's salesperson license, \$20 for each salesperson.  
23 The manufacturer's salesperson shall, with respect to each sale made to a  
24 retail dealer, make and deliver to the retail dealer a true invoice wherein  
25 such salesperson shall insert the name of the wholesale dealer from whom  
26 such salesperson secured such cigarettes, together with such salesperson's  
27 own name and the name of the retail dealer purchasing the cigarettes.

28 (8) For vending machine operator's license, no fee.

29 (9) For vending machine permit, \$25 for each permit.

30 (b) An application for any license required under the provisions of  
31 this act may be refused to: (1) A person who is not of good character and  
32 reputation in the community in which such person resides; or (2) a person  
33 who has been convicted of a felony or of any crime involving moral  
34 turpitude or of the violation of any law of any state or the United States  
35 pertaining to cigarettes or tobacco products and who has not completed the  
36 sentence, parole, probation or assignment to a community correctional  
37 services program imposed for any such conviction within two years  
38 immediately preceding the date of making application for any of such  
39 licenses.

40 (c) *The director may refuse to issue or renew a license to any person*  
41 *who:*

42 (1) *Has been convicted on or after January 1, 2013, of a felony under*  
43 *the laws of this state or any other state or the United States;*

 2       (3) *has had a cigarette license revoked in this state or any other*  
 3 *state;*  
 4       (4) *is not at least 18 years of age;*

 7 *this act, would not be eligible for the license upon first application;*

 11       (9) *is a corporation in which any officer, manager or director thereof,*

 28 3309. (a) Whenever the director has reason to believe that any person  
 29 licensed under this act has violated any of the provisions of this act, ***in any***  
 30 ***of the following ways***, the director shall notify ~~the person~~ ***the person***, by  
 31 certified mail ~~of~~, ***of*** the director's intention to suspend or revoke the  
 32 ~~person's~~ ***person's*** license or licenses ~~of any person licensed under this act~~  
 33 ~~whenever the director has reason to believe such person has violated any~~  
 34 ~~provision of this act in any of the following ways, if the person:~~

20       (b) ~~Within 30~~ *Within 30* days after the mailing of the notice, the person may  
 21 request a hearing in writing before the director. The hearing shall be  
 22 conducted in accordance with the provisions of the Kansas administrative  
 23 procedure act. If, after such hearing, it appears to the satisfaction of the  
 24 director that the person has violated any of the provisions of this act, the  
 25 director is hereby authorized and empowered to suspend or revoke the  
 26 person's license or licenses and may in addition deny the application of the  
 27 person for a license or licenses for a portion of the succeeding calendar  
 28 year for such period as the director determines is necessary, but in no case  
 29 for a period ending more than one year following the date upon which the  
 30 license or licenses were suspended or revoked. The suspension or  
 31 revocation of a vending machine operator's master license shall suspend or

 35 under this act after having notice or knowledge of the suspension or  
 36 revocation of the person's license or licenses or after becoming more than  
 37 10 days delinquent in *filing a bond payable to the state of Kansas as*  
 38 *required by the director*; payment of any *fine*, tax, penalty or interest  
 39 imposed pursuant to this act, the state shall be entitled, in any proceedings  
 40 brought for such purposes, to have an order and judgment restraining and  
 41 enjoining such unlawful sale and no bond shall be required for the  
 42 issuance of any such restraining order or injunction.

1 follows: 79-3311. The director shall design and designate indicia of tax  
2 payment to be affixed to each package of cigarettes as provided by this act.  
3 ~~The director shall sell water applied stamps only to licensed wholesale~~  
4 ~~dealers in the amounts of 1,000 or multiples thereof. Stamps applied by the~~  
5 heat process shall be sold only in amounts of 30,000 or multiples thereof,  
6 except that such stamps which are suitable for packages containing 25  
7 cigarettes each shall be sold in amounts prescribed by the director. ~~Meter~~  
8 ~~imprints shall be sold only in amounts of 10,000 or multiples thereof.~~  
9 ~~Water applied stamps in amounts of 10,000 or multiples thereof and~~  
10 Stamps applied by the heat process and meter imprints shall be supplied to  
11 wholesale dealers *in good standing with the director at the time of*  
12 *purchase* at a discount of 0.55% on and after July 1, 2015, and thereafter,  
13 from the face value thereof, and shall be deducted at the time of purchase  
14 or from the remittance therefor as hereinafter provided. Any wholesale
