

SENATE RESOLUTION No. 1803

1 A RESOLUTION relating to rules of the Senate for 2009-2012,
2 amending rule 7, relating to standing committees.

3 *Be it resolved by the Senate of the State of Kansas:* That rule 7 be
4 amended to read as follows:

5 **Rule 7. Standing Committees.** There shall be a standing committee
6 named the Committee on Organization, Calendar and Rules which shall
7 consist of nine members, the chairperson of which shall be the
8 president of the senate, and the vice chairperson of which shall be the
9 majority leader of the Senate. The Vice President of the Senate shall be
10 a member of the committee. Each of the other six members shall be
11 selected separately by the majority political party of the Senate.

12 No bill or resolution other than resolutions adopting, amending or
13 revoking rules of the Senate or Joint Rules of the Senate and House of
14 Representatives, shall be introduced by or be referred to the Committee
15 on Organization, Calendar and Rules.

3 The Committee on Organization, Calendar and Rules shall appoint
4 the members of each committee, shall appoint the chairperson and vice
5 chairperson or vice chairpersons thereof and shall designate the ranking
6 minority member of each committee. The minority leader shall submit
7 recommendations for the appointment of minority members to the
8 standing committees of the Senate to the Committee on Organization,
9 Calendar and Rules. The Committee on Organization, Calendar and
10 Rules shall have a standing subcommittee on calendar which shall be
11 the president of the senate, the vice president of the senate and the
12 majority leader of the Senate. The Majority Leader shall be the
13 chairperson of the subcommittee. The Committee on Organization,
14 Calendar and Rules may establish such other subcommittees of the
15 Committee on Organization, Calendar and Rules as the Committee
16 deems appropriate.

17 For the purpose of considering committee member appointments,
18 and appointments of chairpersons, vice-chairpersons and ranking
19 minority members, and for such other purposes as may be authorized
20 by law, by the joint rules of the senate and the house of representatives
21 or by rules of the senate for closed meetings, the Committee on
22 Organization, Calendar and Rules may close its meetings.

23 The two major political parties shall have proportional
24 representation on each standing committee other than the Committee on
25 Organization, Calendar and Rules. In the event application of the
26 preceding sentence results in a fraction, the party having a fraction
27 exceeding .5 shall receive representation as though such fraction were a
28 whole number.
