

1 AN ACT relating to crimes and punishments.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 532 IS CREATED TO  
4 READ AS FOLLOWS:

5 *(1) As used in this section, "violent felony" means a felony that would classify a*  
6 *person as a violent offender under Section 32 of this Act.*

7 *(2) Notwithstanding any other provision of this chapter, a person convicted of a*  
8 *violent felony who has previously been convicted of two (2) separate violent*  
9 *felonies shall be sentenced to:*

10 *(a) A term of imprisonment for life without benefit of probation or parole, if the*  
11 *felony is not a capital offense; or*

12 *(b) Death, or a term of imprisonment for life without benefit of probation or*  
13 *parole, if the felony is a capital offense.*

14 *(3) For the purpose of determining whether a person has two (2) or more separate*  
15 *violent felony convictions, two (2) or more convictions for which the person*  
16 *served concurrent or uninterrupted consecutive terms of imprisonment shall be*  
17 *deemed to be only one (1) conviction, unless one (1) of the convictions was for an*  
18 *offense committed while that person was imprisoned.*

19 ➔SECTION 2. A NEW SECTION OF KRS CHAPTER 532 IS CREATED TO  
20 READ AS FOLLOWS:

21 *Notwithstanding any other provision of this chapter, or Section 32 of this Act, a person*  
22 *shall not be eligible for probation, parole, conditional discharge, conditional release, or*  
23 *any other form of release prior to the completion of his or her sentence if, in the*  
24 *commission of the offense, he or she utilized a firearm in furtherance of the crime,*  
25 *and:*

26 *(1) Was previously convicted of a felony;*

27 *(2) Knew or should have known that the firearm was stolen; or*

1 (3) Was on probation, parole, conditional discharge, conditional release, or any  
2 other form of release after conviction of a violent felony offense as defined in  
3 KRS 532.200.

4 ➔Section 3. KRS 610.070 is amended to read as follows:

5 (1) All cases involving children brought before the court whose cases are under the  
6 jurisdiction of the court shall be granted a speedy hearing and shall be dealt with by  
7 the court without a jury.

8 (2) The hearings shall be conducted in a formal manner, unless specified to the contrary  
9 by other provisions of KRS Chapters 600 to 645.

10 (3) The general public shall be excluded and only the immediate families or guardians  
11 of the parties before the court, witnesses necessary for the prosecution and defense  
12 of the case, the probation worker with direct interest in the case, a representative  
13 from the Department of Juvenile Justice, the victim, his or her parent or legal  
14 guardian, or if emancipated, his or her spouse, or a legal representative of either,  
15 such persons admitted as the judge shall find have a direct interest in the case or in  
16 the work of the court, and such other persons as agreed to by the child and his or  
17 her attorney may be admitted to the hearing. A parent, legal guardian, or spouse if a  
18 witness shall be admitted to the hearing only during and after his or her testimony  
19 at the hearing, and witnesses shall be admitted to the hearing only for the duration  
20 of their testimony. The court may order the exclusion of a parent, legal guardian, or  
21 spouse, if it is shown to the satisfaction of the court that the parent, legal guardian,  
22 or spouse may physically disrupt the proceedings or may do violence to any  
23 participant therein. The mere presence of a parent, legal guardian, or spouse shall  
24 not be deemed to be a disruption of the proceedings merely because their presence  
25 may make the defendant uncomfortable; the court shall find a potential for actual  
26 physical disruption of the proceedings before an exclusion may be granted for this  
27 reason.

1 (4) The court ~~shall~~<sup>may</sup> order at least one (1) parent, guardian, or person~~the~~  
 2 ~~parents, guardians, or persons~~ exercising custodial control over the child to be  
 3 present at any hearing or other proceeding involving the child. The court shall  
 4 make accommodations necessary to allow the person to attend, including but not  
 5 limited to allowing remote attendance or holding hearings outside the court's  
 6 normal operating hours.

7 ➔SECTION 4. A NEW SECTION OF KRS CHAPTER 610 IS CREATED TO  
 8 READ AS FOLLOWS:

9 (1) At any hearing or other proceeding under KRS Chapters 630 to 645, at least one  
 10 (1) person ordered by the court, pursuant to subsection (4) of Section 3 of this  
 11 Act, to attend hearings or proceedings involving the child shall be present. The  
 12 court shall make reasonable accommodations to allow the person to attend.

13 (2) A person who has been excluded from a hearing pursuant to subsection (3) of  
 14 Section 3 of this Act and has not subsequently been ordered by the court to be  
 15 present at future proceedings shall not be charged under this section.

16 (3) If a violation of subsection (1) of this section occurs, any parent, guardian, or  
 17 other person who was ordered, pursuant to subsection (4) of Section 3 of this Act,  
 18 to attend hearings or proceedings involving the child shall be fined not more than  
 19 five hundred dollars (\$500) or ordered to participate in up to forty (40) hours of  
 20 community service.

21 ➔Section 5. KRS 507.030 is amended to read as follows:

22 (1) A person is guilty of manslaughter in the first degree when:  
 23 (a) With intent to cause serious physical injury to another person, he or she  
 24 causes the death of such person or of a third person;  
 25 (b) With intent to cause the death of another person, he or she causes the death of  
 26 such person or of a third person under circumstances which do not constitute  
 27 murder because he or she acts under the influence of extreme emotional

1 disturbance, as defined in subsection (1)(a) of KRS 507.020; ~~or~~

2 (c) Through circumstances not otherwise constituting the offense of murder, he or  
3 she intentionally abuses another person or knowingly permits another person  
4 of whom he or she has actual custody to be abused and thereby causes death  
5 to a person twelve (12) years of age or less, or who is physically helpless or  
6 mentally helpless; or

7 (d) He or she knowingly sells fentanyl or a fentanyl derivative to another  
8 person, and the injection, ingestion, inhalation, or other introduction of the  
9 fentanyl or fentanyl derivative causes the death of the person.

10 (2) Manslaughter in the first degree is a Class B felony.

11 ➔Section 6. KRS 507.040 is amended to read as follows:

12 (1) A person is guilty of manslaughter in the second degree when he or she wantonly  
13 causes the death of another person, including but not limited to situations where the  
14 death results from the person's:

15 (a) Operation of a motor vehicle;

16 (b) Leaving a child under the age of eight (8) years in a motor vehicle under  
17 circumstances which manifest an extreme indifference to human life and  
18 which create a grave risk of death to the child, thereby causing the death of  
19 the child; ~~or~~

20 (c) Unlawful distribution for remuneration of a Schedule I or II controlled  
21 substance when the controlled substance is the proximate cause of death; or

22 (d) Knowing distribution of fentanyl or a fentanyl derivative to another person  
23 without remuneration, and the injection, ingestion, inhalation, or other  
24 introduction of the fentanyl or fentanyl derivative causes the death of the  
25 person.

26 (2) Manslaughter in the second degree is a Class C felony.

27 ➔Section 7. KRS 218A.133 is amended to read as follows:

- 1 (1) As used in this section:
- 2 (a) "Drug overdose" means an acute condition of physical illness, coma, mania,  
3 hysteria, seizure, cardiac arrest, cessation of breathing, or death which  
4 reasonably appears to be the result of consumption or use of a controlled  
5 substance, or another substance with which a controlled substance was  
6 combined, and that a layperson would reasonably believe requires medical  
7 assistance; and
- 8 (b) "Good faith" does not include seeking medical assistance during the course of  
9 the execution of an arrest warrant, or search warrant, or a lawful search.
- 10 (2) A person shall not be charged with or prosecuted for a criminal offense prohibiting  
11 the possession of a controlled substance or the possession of drug paraphernalia, for  
12 a violation of subsection (1)(d) of Section 5 of this Act or subsection (1)(d) of  
13 Section 6 of this Act, or for an offense punishable under subsection (3)(c) of  
14 Section 8 of this Act if:
- 15 (a) In good faith, medical assistance with a drug overdose is sought from a public  
16 safety answering point, emergency medical services, a law enforcement  
17 officer, or a health practitioner because the person:
- 18 1. Requests emergency medical assistance for himself or herself or another  
19 person;
- 20 2. Acts in concert with another person who requests emergency medical  
21 assistance; or
- 22 3. Appears to be in need of emergency medical assistance and is the  
23 individual for whom the request was made;
- 24 (b) The person remains with, or is, the individual who appears to be experiencing  
25 a drug overdose until the requested assistance is provided; and
- 26 (c) The evidence for the charge or prosecution is obtained as a result of the drug  
27 overdose and the need for medical assistance.

1 (3) The provisions of subsection (2) of this section shall not extend to the investigation  
2 and prosecution of any other crimes committed by a person who otherwise qualifies  
3 under this section.

4 (4) When contact information is available for the person who requested emergency  
5 medical assistance, it shall be reported to the local health department. Health  
6 department personnel shall make contact with the person who requested emergency  
7 medical assistance in order to offer referrals regarding substance abuse treatment, if  
8 appropriate.

9 (5) A law enforcement officer who makes an arrest in contravention of this section  
10 shall not be criminally or civilly liable for false arrest or false imprisonment if the  
11 arrest was based on probable cause.

12 ➔Section 8. KRS 218A.1412 is amended to read as follows:

13 (1) A person is guilty of trafficking in a controlled substance in the first degree when  
14 he or she knowingly and unlawfully traffics in:

15 (a) Four (4) grams or more of cocaine;

16 (b) Two (2) grams or more of methamphetamine;

17 (c) Ten (10) or more dosage units of a controlled substance that is classified in  
18 Schedules I or II and is a narcotic drug, or a controlled substance analogue;

19 (d) Any quantity of heroin, fentanyl, carfentanil, or fentanyl derivatives; lysergic  
20 acid diethylamide; phencyclidine; gamma hydroxybutyric acid (GHB),  
21 including its salts, isomers, salts of isomers, and analogues; or flunitrazepam,  
22 including its salts, isomers, and salts of isomers; or

23 (e) Any quantity of a controlled substance specified in paragraph (a), (b), or (c) of  
24 this subsection in an amount less than the amounts specified in those  
25 paragraphs.

26 (2) The amounts specified in subsection (1) of this section may occur in a single  
27 transaction or may occur in a series of transactions over a period of time not to

1 exceed ninety (90) days that cumulatively result in the quantities specified in this  
2 section.

3 (3) (a) Any person who violates the provisions of subsection (1)(a), (b), (c), or (d) of  
4 this section shall be guilty of a Class C felony for the first offense and a Class  
5 B felony for a second or subsequent offense.

6 (b) Any person who violates the provisions of subsection (1)(e) of this section  
7 shall be guilty of a Class D felony for the first offense and a Class C felony  
8 for a second or subsequent offense.

9 (c) *If the substance is fentanyl or a fentanyl derivative, and the injection,*  
10 *ingestion, inhalation, or other introduction of the fentanyl or fentanyl*  
11 *derivative causes the death of a person, the penalty for the offense shall be*  
12 *one (1) level higher than the level otherwise specified in this section.*

13 (d) Any person convicted of a Class C felony offense or higher under this section  
14 shall not be released on probation, shock probation, parole, conditional  
15 discharge, or other form of early release until he or she has served at least fifty  
16 percent (50%) of the sentence imposed in cases where the trafficked substance  
17 was heroin, fentanyl, carfentanil, or fentanyl derivatives.

18 ➔SECTION 9. A NEW SECTION OF KRS CHAPTER 515 IS CREATED TO  
19 READ AS FOLLOWS:

20 *(1) A person is guilty of carjacking when he or she takes a motor vehicle in the*  
21 *possession of another without lawful authority or ownership, from the possessor's*  
22 *person or immediate presence, or from the person or immediate presence of a*  
23 *passenger of the motor vehicle, against the possessor's or passenger's will and*  
24 *with the intent to either permanently or temporarily deprive the possessor of the*  
25 *motor vehicle of his or her possession, accomplished by means of force or*  
26 *intimidation.*

27 *(2) Carjacking is a Class B felony.*

1 **(3) A person shall not be convicted of a violation of this section and a violation of**  
 2 **KRS 515.020 or KRS Chapter 514 arising from the same act.**

3 ➔Section 10. KRS 512.020 is amended to read as follows:

4 (1) A person is guilty of criminal mischief in the first degree when, having no right to  
 5 do so or any reasonable ground to believe that he or she has such right, he or she  
 6 intentionally or wantonly:

7 (a) Defaces, destroys, or damages any property causing pecuniary loss of **five**  
 8 **hundred dollars (\$500)**~~one thousand dollars (\$1,000)~~ or more;

9 (b) Tampers with the operations of a key infrastructure asset, as defined in KRS  
 10 511.100, in a manner that renders the operations harmful or dangerous; or

11 (c) As a tenant, intentionally or wantonly defaces, destroys, or damages  
 12 residential rental property causing pecuniary loss of **five hundred dollars**  
 13 **(\$500)**~~one thousand dollars (\$1,000)~~ or more.

14 (2) Criminal mischief in the first degree is a Class D felony, unless:

15 **(a)** The offense occurs during a declared emergency as defined by KRS 39A.020  
 16 arising from a natural or man-made disaster, within the area covered by the  
 17 emergency declaration, and within the area impacted by the disaster, in which  
 18 case it is a Class C felony;

19 **(b) For the first offense, if the defendant at any time prior to trial effects repair**  
 20 **or replacement of the defaced, destroyed, or damaged property, makes**  
 21 **complete restitution in the amount of the damage, or performs community**  
 22 **service as required by the court, in which case it is a Class B misdemeanor.**  
 23 **The court shall determine the number of hours of community service**  
 24 **commensurate with the total amount of monetary damage caused by or**  
 25 **incidental to the commission of the crime, of not less than sixty (60) hours;**  
 26 **or**

27 **(c) For the second or subsequent offense, if the defendant at any time prior to**



1 trial effects repair or replacement of the defaced, destroyed, or damaged  
 2 property, makes complete restitution in the amount of the damage, or  
 3 performs community service as required by the court, in which case it is a  
 4 Class A misdemeanor. The court shall determine the number of hours of  
 5 community service commensurate with the total amount of monetary  
 6 damage caused by or incidental to the commission of the crime, of not less  
 7 than sixty (60) hours.

8 ➔Section 11. KRS 512.030 is amended to read as follows:

9 (1) A person is guilty of criminal mischief in the second degree when, having no right  
 10 to do so or any reasonable ground to believe that he or she has such right, he or she:

11 (a) Intentionally or wantonly defaces, destroys, or damages any property causing  
 12 pecuniary loss of ~~five hundred dollars (\$500) or more but~~ less than five  
 13 hundred dollars (\$500)~~one thousand dollars (\$1,000)]; or~~

14 (b) As a tenant, intentionally or wantonly defaces, destroys, or damages  
 15 residential rental property causing pecuniary loss of ~~five hundred dollars~~  
 16 ~~(\$500) or more but~~ less than five hundred dollars (\$500)~~one thousand~~  
 17 ~~dollars (\$1,000)].~~

18 (2) Criminal mischief in the second degree is a Class A misdemeanor, unless:

19 (a) The offense occurs during a declared emergency as defined by KRS 39A.020  
 20 arising from a natural or man-made disaster, within the area covered by the  
 21 emergency declaration, and within the area impacted by the disaster, in which  
 22 case it is a Class D felony; or

23 (b) The defendant at any time prior to trial effects repair or replacement of the  
 24 defaced, destroyed, or damaged property, makes complete restitution in the  
 25 amount of the damage, or performs community service as required by the  
 26 court, in which case it is a Class B misdemeanor. The court shall determine  
 27 the number of hours of community service commensurate with the total

3           ➔Section 12. KRS 149.410 is amended to read as follows:

4   The Commonwealth's attorney or county attorney shall initiate and prosecute appropriate  
 5   abatement proceedings by injunction or otherwise, for the prevention or correction of any  
 6   condition constituting or threatening to constitute a violation of KRS 149.360 to 149.430.  
 7   The institution or pendency of a proceeding pursuant to this section shall not bar the  
 8   imposition of any penalties or the securing of any other relief provided by KRS 149.360  
 9   to 149.430, 149.991, 277.990, 512.020, *or Section 11 of this Act* ~~to 512.040~~, or  
 10  administrative regulations promulgated thereunder.

11          ➔Section 13. KRS 506.160 is amended to read as follows:

12  (1) If a defendant is alleged by the prosecuting attorney to have been a member of a  
 13   criminal gang as defined in KRS 506.135, at the time of the commission of the  
 14   offense, upon conviction of the offense there shall be a separate proceeding from  
 15   that proceeding which resulted in the defendant's conviction if the defendant was  
 16   convicted of:

- 17   (a) Assault in the fourth degree under KRS 508.030;
- 18   (b) Menacing under KRS 508.050;
- 19   (c) Wanton endangerment in the second degree under KRS 508.070;
- 20   (d) Terroristic threatening in the third degree under KRS 508.080;

9        (2) The proceeding described in subsection (1) of this section shall be conducted before

10        the court sitting with the jury that found the defendant guilty of the offense unless

11        the court for good cause discharges that jury and impanels a new jury for that

12        purpose. If the jury determines beyond a reasonable doubt that the defendant is or

13        was a member of a criminal gang, acting for the purpose of benefitting, promoting,

14        or furthering the interest of a criminal gang at the time he or she committed the

15        offense, he or she shall not be released for a minimum of seventy-six (76) to ninety

16        (90) days of the sentence imposed if the offense he or she is convicted of is

17        classified as a Class B misdemeanor, or for a minimum of three hundred eleven

18        (311) to three hundred sixty-five (365) days if the offense he or she is convicted of

19        is classified as a Class A misdemeanor.

20        (3) This section shall not apply to a juvenile unless he or she has been transferred to

21        Circuit Court as a youthful offender pursuant to KRS 640.010 and has on at least

22        one (1) prior separate occasion been adjudicated a public offender for a felony

23        offense.

24        ➔Section 14. KRS 525.220 is amended to read as follows:

25        No person shall be convicted of assault on a service animal when **he or she has**:

- 26        (1) ~~He has~~ Also been convicted of a violation of KRS 525.125, 525.130, 512.020, **or**
- 27        512.030~~, or 512.040~~ arising out of the same incident;~~or~~

- 1 (2) ~~{He has }~~Destroyed or treated a service animal that is injured, diseased, or suffering  
 2 or that constitutes a hazard to public safety if not destroyed;~~{or }~~
- 3 (3) ~~{He has }~~Used physical force against the service animal in protection of himself,  
 4 **herself**, or a third person; or
- 5 (4) ~~{He has }~~Used physical force without knowledge that the animal was a service  
 6 animal.

7 ➔Section 15. KRS 520.050 is amended to read as follows:

- 8 (1) A person is guilty of promoting contraband in the first degree when:
- 9 (a) He **or she** knowingly introduces dangerous contraband into a detention  
 10 facility or a penitentiary; or
- 11 (b) Being a person confined in a detention facility or a penitentiary, he **or she**  
 12 knowingly makes, obtains, or possesses dangerous contraband.
- 13 (2) Promoting contraband in the first degree is a Class D felony, **unless the dangerous**  
 14 **contraband is fentanyl, carfentanil, or a fentanyl derivative, in which case it is a**  
 15 **Class C felony.**

16 ➔Section 16. KRS 16.220 is amended to read as follows:

- 17 (1) Subject to the duty to return confiscated firearms to innocent owners pursuant to  
 18 KRS 500.090, all firearms confiscated by the Department of Kentucky State Police  
 19 and not retained for official use pursuant to KRS 500.090 shall be sold at public  
 20 auction to:
- 21 **(a)** Federally licensed firearms dealers holding a license appropriate for the type  
 22 of firearm sold; **or**
- 23 **(b)** **For a firearm which was used in a homicide, any person who certifies on a**  
 24 **form provided by the Department of Kentucky State Police prior to placing a**  
 25 **bid that he or she will, upon completion of the auction, leave the firearm**  
 26 **with the Department of Kentucky State Police for destruction. A state or**  
 27 **local government or agency thereof shall not purchase a firearm under this**

1                    paragraph.

2     **(2)** Any provision of KRS Chapter 45 or 45A relating to disposition of property to the  
3       contrary notwithstanding, the Department of Kentucky State Police shall:

4       (a) Conduct any auction specified by this section;

5       (b) Retain for departmental use twenty percent (20%) of the gross proceeds from  
6       any auction specified by this section; ~~and~~

7       (c) Transfer remaining proceeds of the sale to the account of the Kentucky Office  
8       of Homeland Security for use as provided in subsection ~~(5)~~~~(4)~~ of this  
9       section; and

10      **(d) For any sale pursuant to subsection (1)(b) of this section, destroy the**  
11      **firearm.**

12     ~~(3)~~~~(2)~~ Prior to the sale of any firearm, the Department of Kentucky State Police shall  
13       make an attempt to determine if the firearm to be sold has been stolen or otherwise  
14       unlawfully obtained from an innocent owner and return the firearm to its lawful  
15       innocent owner, unless that person is ineligible to purchase a firearm under federal  
16       law.

17     ~~(4)~~~~(3)~~ The Department of Kentucky State Police shall receive firearms and  
18       ammunition confiscated by or abandoned to every law enforcement agency in  
19       Kentucky. The department shall dispose of the firearms received in the manner  
20       specified in subsections~~subsection~~ (1) and (2) of this section. However, firearms  
21       which are not retained for official use, returned to an innocent lawful owner, or  
22       transferred to another government agency or public museum shall be sold as  
23       provided in subsection~~subsections~~ (1) ~~and (3)~~ of this section.

24     ~~(5)~~~~(4)~~ The proceeds of firearms sales shall be utilized by the Kentucky Office of  
25       Homeland Security to provide grants to city, county, charter county, unified local  
26       government, urban-county government, and consolidated local government police  
27       departments; university safety and security departments organized pursuant to KRS

1 164.950; school districts that employ special law enforcement officers as defined in  
2 KRS 61.900; and sheriff's departments for the purchase of:

- 3 (a) Body armor for sworn peace officers of those departments and service  
4 animals, as defined in KRS 525.010, of those departments;
- 5 (b) Firearms or ammunition;
- 6 (c) Electronic control devices, electronic control weapons, or electro-muscular  
7 disruption technology; and
- 8 (d) Body-worn cameras.

9 In awarding grants under this section, the Kentucky Office of Homeland Security  
10 shall give first priority to providing and replacing body armor and second priority to  
11 providing firearms and ammunition, with residual funds available for the purchase  
12 of body-worn cameras, electronic control devices, electronic control weapons, or  
13 electro-muscular disruption technology. Body armor purchased by the department  
14 receiving grant funds shall meet or exceed the standards issued by the National  
15 Institute of Justice for body armor. No police or sheriff's department shall apply for  
16 a grant to replace existing body armor unless that body armor has been in actual use  
17 for a period of five (5) years or longer. Any department applying for grant funds for  
18 body-worn cameras shall develop a policy for their use and shall submit that policy  
19 with its application for the grant funds to the Office of Homeland Security as part of  
20 the application process.

21 ~~(6)(5)~~ The Department of Kentucky State Police may transfer a machine gun, short-  
22 barreled shotgun, short-barreled rifle, silencer, pistol with a shoulder stock, any  
23 other weapon, or destructive device as defined by the National Firearms Act which  
24 is subject to registration under the National Firearms Act and is not properly  
25 registered in the national firearms transfer records for those types of weapons, to the  
26 Bureau of Alcohol, Tobacco, and Firearms of the United States Department of  
27 Justice, after a reasonable attempt has been made to transfer the firearm to an

1 eligible state or local law enforcement agency or to an eligible museum and no  
 2 eligible recipient will take the firearm or weapon. National Firearms Act firearms

5 KRS 218A.1432, in which case it is a Class B felony for the first offense and  
6 a Class A felony for each subsequent offense;
- 7 (c) The property is one (1) or more controlled substances valued collectively at  
8 less than ten thousand dollars (\$10,000), in which case it is a Class D felony;
- 9 (d) The value of the property is five hundred dollars (\$500) or more but less than  
10 one thousand dollars (\$1,000), in which case it is a Class A misdemeanor;
- 11 (e) The value of the property is one thousand dollars (\$1,000) or more but less  
12 than ten thousand dollars (\$10,000), in which case it is a Class D felony;
- 13 (f) The person has three (3) or more convictions under paragraph (d) of this  
14 subsection within the last five (5) years, in which case it is a Class D felony.  
15 The five (5) year period shall be measured from the dates on which the  
16 offenses occurred for which the judgments of conviction were entered;
- 17 (g) The value of the property is ten thousand dollars (\$10,000) or more but less  
18 than one million dollars (\$1,000,000), in which case it is a Class C felony;
- 19 (h) The value of the property is one million dollars (\$1,000,000) or more but less  
20 than ten million dollars (\$10,000,000), in which case it is a Class B felony;
- 21 (i) The value of the property is ten million dollars (\$10,000,000) or more, in  
22 which case it is a Class B felony; or
- 23 (j) The offense occurs during a declared emergency as defined by KRS 39A.020  
24 arising from a natural or man-made disaster, within the area covered by the  
25 emergency declaration, and within the area impacted by the disaster, in which  
26 case the person shall be charged one (1) level higher than the level otherwise  
27 specified in this subsection.

- 1 (3) Any person convicted under subsection (2)(i) of this section shall not be released on  
 2 probation or parole until he or she has served at least fifty percent (50%) of the  
 3 sentence imposed, any statute to the contrary notwithstanding.
- 4 (4) If any person commits two (2) or more separate offenses of theft by unlawful taking  
 5 or disposition within one (1) year~~ninety (90) days~~, the offenses may be combined  
 6 and treated as a single offense, and the value of the property in each offense may be  
 7 aggregated for the purpose of determining the appropriate charge. Offenses  
 8 committed in different jurisdictions within the Commonwealth may be combined  
 9 pursuant to this subsection and tried in any jurisdiction in which venue would be  
 10 proper for at least one (1) of the offenses. A defendant shall not be tried in more  
 11 than one (1) jurisdiction for the same offense or offenses.

- 13 (1) A person is guilty of attempting to escape from the penitentiary when he or she:
- 14 (a) Conceals himself or herself within the walls of the penitentiary;~~or~~
- 15 (b) Attempts to scale the enclosure surrounding the penitentiary;~~or~~
- 16 (c) Flees from whatever bounds he or she may be assigned, whether under guard  
 17 or as a trusty;~~or~~
- 18 (d) Escapes from a locked cell, dormitory, hospital or other lockup in the  
 19 penitentiary;~~or~~
- 20 (e) Escapes from one part of the penitentiary to another;~~or~~
- 21 (f) Does any other act in furtherance of an escape from the penitentiary; ~~or~~
- 22 (g) Obstructs, disables, tampers with, removes, damages, or destroys any video  
 23 recording or monitoring device within the penitentiary; or  
 24 (h) Does any act or omission constituting criminal attempt under KRS 506.010.

- 26 (3) No penalty provision of KRS 506.010 shall apply to an offense committed under

1           ➔SECTION 53. A NEW SECTION OF KRS CHAPTER 15A IS CREATED TO  
2 READ AS FOLLOWS:

3       *(1) The Department of Juvenile Justice shall establish in each county, or assign to*  
4       *an existing body the responsibilities of, a local juvenile restorative justice advisory*  
5       *committee. For counties within the same judicial district, the requirements of this*  
6       *subsection may be satisfied through a joint committee.*

7       *(2) The membership of each committee shall include the following:*

8           *(a) The Chief District Judge;*

9           *(b) The county attorney;*

10          *(c) An assistant public advocate;*

11          *(d) A representative from the Department for Community Based Services;*

12          *(e) A representative from the Department of Juvenile Justice;*

13          *(f) A representative from a local law enforcement agency;*

14          *(g) A representative from each local school district;*

15          *(h) Community members reflecting the racial, socioeconomic, and other*  
16          *diversity of the county or, in the case of a joint committee, the counties; and*

17          *(i) A representative from a victims advocacy group.*

18       *(3) Each committee shall:*

19           *(a) Establish sustainable programs that employ restorative practices to identify*  
20           *the underlying causes of negative behavior and empower children, families,*  
21           *and communities to address and prevent issues surrounding incidents of*  
22           *negative behavior; and*

23           *(b) Develop and implement local restorative justice programs with an*  
24           *established organization to serve children, youth, and families through*

1 **(4) Restorative justice programs established pursuant to this section shall not allow**

5 **of Juvenile Justice, Office of Community and Mental Health Services.**
