1	A CONCURRENT RESOLUTION urging the Kentucky Cabinet for Health and
2	Family Services, Department for Medicaid Services, to continue to improve the provision
3	of colorectal cancer screening services to Kentucky Medicaid recipients.
4	WHEREAS, according to the United States Centers for Disease Control and
5	Prevention (CDC) Web site, of cancers that affect both men and women, colorectal
6	cancer is the second leading cause of cancer-related deaths in the United States, and it is
7	the leading cause of cancer deaths among nonsmokers; and
8	WHEREAS, the American Cancer Society estimates that there will be 140,250 new
9	cases of colorectal cancer and 50,630 deaths from colorectal cancer in the United States
10	in 2018; and
11	WHEREAS, according to the most recent data from the CDC Web site, Kentucky
12	has the highest rate of colorectal cancer incidence in the United States and the fifth
13	highest rate of colorectal cancer deaths in the United States; and
14	WHEREAS, the United States Preventive Services Task Force (USPSTF) is a well-
15	respected and nationally recognized independent, volunteer panel of experts appointed by
16	the United States Agency for Healthcare Research and Quality to make evidence-based
17	recommendations about clinical preventive services, such as screenings, counseling
18	services, and preventive medications; and
19	WHEREAS, the USPSTF recommends periodic colorectal cancer screening for
20	adults to reduce mortality from colorectal cancer, beginning at age 50 and continuing to
21	age 75; and
22	WHEREAS, the USPSTF states that using any of the following three screening
23	regimens will be effective at reducing mortality from colorectal cancer: (1) annual high-
24	sensitivity fecal occult blood testing; (2) sigmoidoscopy every five years combined with
25	high-sensitivity fecal occult blood testing every three years; and (3) screening
26	colonoscopy every ten years; and

WHEREAS, colorectal cancer screening has contributed to a decrease in colorectal

1 cancer death rates by 34 percent among individuals in the United States age 50 and over 2 during 2000 through 2014; and 3 WHEREAS, according to 2016 Behavioral Risk Factor Surveillance System Survey 4 data from the CDC, 70.1 percent of Kentucky's citizens over the age of 50 were screened 5 for colorectal cancer within the recommended timeframes; and 6 WHEREAS, an initiative led by the American Cancer Society, the CDC, and the 7 National Colorectal Cancer Roundtable strives to achieve an 80 percent screening rate for 8 adults over the age of 50 by 2018; and 9 WHEREAS, for the years spanning from 2005 to 2013, the United States Medicaid 10 and CHIP Payment and Access Commission found data showing that adults with 11 Medicaid coverage reported lower rates of colorectal cancer screening than adults covered 12 by private insurance, regardless of income level; and 13 WHEREAS, according to the Kentucky Colon Cancer Screening Program Advisory 14 Committee's 2013-14 Annual Report, people covered by Kentucky Medicaid with a 15 primary diagnosis of colorectal cancer and with any diagnosis and colorectal cancer 16 accounted for 516 total hospital admissions in 2013, with total charges of \$30,879,111. 17 There were 2,905 colonoscopies reported as covered by Kentucky Medicaid in 2013, with 18 total charges of \$16,077,003; and 19 WHEREAS, according to the 2017 External Quality Review Technical Report 20 published by the Kentucky Cabinet for Health and Family Services, Department for 21 Medicaid Services, the provision of colorectal cancer screening services to Medicaid 22 recipients is one of six health care areas targeted for improvement by the Department; 23 NOW, THEREFORE,

- 24 Be it resolved by the Senate of the General Assembly of the Commonwealth of 25 Kentucky, the House of Representatives concurring therein:
- 26 → Section 1. The General Assembly thanks the Kentucky Cabinet for Health and 27 Family Services, Department for Medicaid Services (DMS), for its work in seeking to

1 improve the provision of colorectal cancer screening services to Medicaid recipients.

- 2 → Section 2. The General Assembly respectfully urges DMS to continue to work
- 3 towards improving the provision of colorectal cancer screening services to Medicaid
- 4 recipients, which should include achieving an 80 percent colorectal cancer screening rate
- 5 for Kentucky Medicaid recipients over the age of 50 and holding Medicaid managed care
- 6 organizations accountable for achieving this goal.
- 7 → Section 3. The General Assembly respectfully urges DMS to ensure that all
- 8 colorectal cancer screening services criteria for Medicaid managed care programs align, at
- 9 a minimum, with USPSTF guidelines for reducing mortality from colorectal cancer.
- → Section 4. The Clerk of the Senate shall transmit a copy of this Resolution to
