

1 AN ACT relating to the Honor and Remember flag.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 2 IS CREATED TO
4 READ AS FOLLOWS:

5 *(1) As used in this section, the "Honor and Remember flag" means either:*

6 *(a) The Honor and Remember flag as created by Honor and Remember, Inc.;*

7 *or*

8 *(b) The flag designated by the United States Congress as the official symbol to*
9 *honor and remember members of the United States Armed Forces who have*
10 *given their lives in the line of duty.*

11 *(2) The Honor and Remember flag is designated as the state's emblem of the service*
12 *and sacrifice of the brave men and women of the United States Armed Forces*
13 *who have given their lives in the line of duty.*

14 *(3) The flag may be displayed:*

15 *(a) At the following locations:*

- 16 *1. Any state-owned building at which the United States flag is displayed;*
- 17 *2. Any state-owned military memorial;*
- 18 *3. Any other state-owned location; and*
- 19 *4. Any local government building or location at which the United States*
20 *flag is displayed or that the local government deems appropriate;*

21 *(b) On the following days:*

- 22 *1. Armed Forces Day;*
- 23 *2. Memorial Day;*
- 24 *3. Flag Day;*
- 25 *4. Independence Day;*
- 26 *5. National POW-MIA Recognition Day, the third Friday in September;*
- 27 *6. Veterans Day;*

- 1 7. Gold Star Mother's Day, the last Sunday in September; and
- 2 8. A day, or the anniversary of a day, on which a member of the United
- 3 States Armed Forces who is a resident of the state loses his or her life
- 4 in the line of duty;
- 5 (c) In a manner designed to ensure visibility to the public; and
- 6 (d) With no more than two (2) additional flags when displayed together on a
- 7 flagpole.
- 8 (4) The Honor and Remember flag shall be manufactured in the United States.
- 9 (5) A department or agency responsible for a location specified in subsection (2)(a)1.
- 10 to 3. of this section, or a local government pursuant to subsection (2)(a)4. of this
- 11 section, may promulgate administrative regulations or ordinances, respectively,
- 12 as necessary to effectuate this section but shall not require an employee to report
- 13 to work solely to display the flag.
- 14 (6) If the United States Congress designates a flag as the official symbol to honor
- 15 and remember members of the United States Armed Forces who died in the line
- 16 of duty, the flag designated by Congress instead of the flag created by Honor and
- 17 Remember, Inc., shall be flown in accordance with subsections (1) to (5) of this
- 18 Section.
