6	<u>(c)</u>	Annually review the behavioral health portion of the Kentucky Emergency
7		Operations Plan and make recommendations for updates to the plan;
8	<u>(d)</u>	Participate in state-level planning workgroups to address the provision of
9		crisis response services;
10	<u>(e)</u>	Establish and maintain memoranda of understanding and master
11		agreements with local partners to provide crisis response services following
