## 2 Be it enacted by the General Assembly of the Commonwealth of Kentucky:

- 3 → Section 1. KRS 344.030 is amended to read as follows:
- 4 For the purposes of KRS 344.030 to 344.110:
- 5 (1) "Qualified individual with a disability" means an individual with a disability as 6 defined in KRS 344.010 who, with or without reasonable accommodation, can 7 perform the essential functions of the employment position that the individual holds 8 or desires unless an employer demonstrates that he is unable to reasonably 9 accommodate an employee's or prospective employee's disability without undue 10 hardship on the conduct of the employers' business. Consideration shall be given to 11 the employer's judgment as to what functions of a job are essential, and if an 12 employer has prepared a written description before advertising or interviewing 13 applicants for the job, this description shall be considered evidence of the essential 14 functions of the job; [...]
  - (2) "Employer" means a person who has eight (8) or more employees within the state in each of twenty (20) or more calendar weeks in the current or preceding calendar year and an agent of such a person, except for purposes of determining discrimination based on disability, employer means a person engaged in an industry affecting commerce who has fifteen (15) or more employees for each working day in each of twenty (20) or more calendar weeks in the current or preceding calendar year, and any agent of that person, except that, for two (2) years following July 14, 1992, an employer means a person engaged in an industry affecting commerce who has twenty-five (25) or more employees for each working day in each of twenty (20) or more calendar weeks in the current or preceding year, and any agent of that person. For the purposes of determining discrimination based on disability, employer shall not include:
    - (a) The United States, a corporation wholly owned by the government of the

(b) For employees affected by pregnancy, childbirth, or related medical

21			color, religion, national origin, sex, age forty (40) and over, because the
22			person is a qualified individual with a disability, or because the individual is a
23			smoker or nonsmoker, as long as the person complies with any workplace
24			policy concerning smoking;
25		(b)	To limit, segregate, or classify employees in any way which would deprive or
26			tend to deprive an individual of employment opportunities or otherwise
27			adversely affect status as an employee, because of the individual's race, color,

1			religion, national origin, sex, or age forty (40) and over, because the person is
2			a qualified individual with a disability, or because the individual is a smoker
3			or nonsmoker, as long as the person complies with any workplace policy
4			concerning smoking; [or]
5		(c)	To fail to make reasonable accommodations for any employee with
6			limitations related to pregnancy, childbirth, or a related medical condition
7			who requests an accommodation, including but not limited to the need to
8			express breast milk, unless the employer can demonstrate the
9			accommodation would impose an undue hardship on the employer's
10			program, enterprise, or business. The following shall be required as to

12			1. An employee shall not be required to accept an accommodation or to
