AN ACT relating to fraud against the Kentucky Public Pensions Authority.

2 Be it enacted by the General Assembly of the Commonwealth of Kentucky:

→ Section 1. KRS 61.685 is amended to read as follows:

4 (1)Notwithstanding the provisions of KRS Chapter 413, upon discovery of any error or 5 omission in system records, the system shall correct all records including, but not 6 limited to, membership in the system, service credit, member and employer 7 contributions, and benefits paid or payable. The system may conduct audits to detect 8 possible fraud, misrepresentation, and change in circumstance, which may result in 9 errors or omissions in the system's records. The system, by its executive director or 10 by representatives appointed in writing by the executive director, may take 11 testimony or depositions, and may examine records, documents, or files of any 12 person whose records, documents, or files may furnish knowledge concerning any 13 system records, when the executive director or representative deems this reasonably 14 necessary for purposes incident to the performance of the system's functions. The 15 system may enforce these powers by application to the Franklin Circuit Court, 16 which court may compel compliance with the orders of the executive director or 17 representatives appointed by the executive director.

18 (2) Neither the board nor any of its individual members shall be liable to any person for
any claim arising from the failure of any participating employer, or any employer
who should have been participating in any retirement system operated by the board,
to make retirement contributions on behalf of the person.

6	payment or receipt of any benefit provided under KRS 16.505 to
7	16.652, 61.510 to 61.705, and 78.510 to 78.852;
8	2. Makes, uses, or causes to be made or used a false record or statement
9	material to a false or fraudulent claim to obtain benefits provided
10	under KRS 16.505 to 16.652, 61.510 to 61.705, and 78.510 to 78.852;
11	<u>or</u>
12	3. Possesses or otherwise has custody or control of money, records, or
13	property used or to be used by the Kentucky Public Pensions Authority
14	or the systems it administers and fails to deliver or delivers less than
15	all of the money, records, or property to which the authority or the
16	retirement systems it administers are entitled, including but not limited
17	to member agencies failing to report and remit employer and employee
18	contributions and employment records to the authority.
19	(c) A person found to have committed one (1) or more of the actions under
20	paragraph (b) of this subsection by a preponderance of the evidence in an
21	administrative process before the authority or in an action before the
22	Franklin Circuit Court in conformity with all due process protections shall
23	<u>be liable for:</u>
24	1. Restitution of any payments received for which the person was not
25	entitled to receive by reason of violation of KRS 16.505 to 16.652,
26	61.510 to 61.705, or 78.510 to 78.852 and interest at the maximum
27	legal rate pursuant to KRS 360.010 in effect on the date any payment

1	was made for the period from the date payment was made to the date
2	of repayment to the authority;
3	2. A civil payment in an amount up to three (3) times the amount of the
4	<u>excess payments;</u>
5	3. A civil payment of five hundred dollars (\$500) for each false of
6	fraudulent claim submitted for the payment of benefits under KRS
7	16.505 to 16.652, 61.510 to 61.705, and 78.510 to 78.852; and
8	4. Legal fees and costs of investigation and enforcement of civi
9	remedies, including all attorneys' fees and costs of litigation.
10	(d) Upon the written request of the authority, the Attorney General shal
11	investigate and file the necessary actions to enforce civil penalties fo
12	violations of this subsection and, if funds are recovered by or on behalf o
13	the authority in any legal action, may recover reasonable costs of litigation
14	as determined by the court as provided by KRS 48.005.
