- 6 1 in any year], a penalty of twenty-five percent (25%) shall be assessed and added to
- 7 the original fee and shall be paid by the applicant before the renewal is issued.
- 8 (2) Any person holding a current valid license may renew the license for the next year
- 9 without taking another examination unless the department determines that new
- 10 knowledge related to classifications for which the applicant has applied makes a
- 11 new examination necessary. [However, if the license is not renewed by June 1 of
- each year, then the licensee shall be required to take another examination.
- 13 (3) No license will be issued or renewed unless certification is valid for the calendar
- 14 year or the applicant has met training requirements that will allow for a renewal of
- certification within the calendar year for the license.
